AACM hosts aviation security exercise workshop

Working in collaboration with the International Civil Aviation Organization (ICAO), Macau's Civil Aviation Authority (AACM) is hosting a four-day aviation security exercise workshop the MSAR. The event commenced yesterday with the aim of educating participants with the knowledge of developing and planning an aviation security exercise and evaluating the effectiveness of the exercise, through theory courses and simulation. A total of 20 participants from eight different countries and administrations in the Asia Pacific region join the workshop. The participants in this small-scale workshop are all aviation security personnel. They work for aeronautical authorities and industry operators in Bangladesh, Bhutan, Cambodia, Singapore, Sri Lanka, Thailand, Hong Kong and Macau. According to a statement issued yesterday AACM has been working hand-in-hand with ICAO to organize aviation security training courses in Macau on a regular basis.

'EU constitution' seminar to be held at UM

The European Union Academic Programme in Macau (EUAP-M) will hold a seminar tomorrow at the University of Macau (UM), titled "Constitutional Perspectives: From the 'European Constitution' to a Global Constitutionalism." The seminar will be delivered by Professor Paulo Ferreira da Cunha of the University of Porto. It will cover a controversial international issue, namely the establishment of European constitutional integration, which has been previously blocked by French and Dutch vetoes. According to organizers, Cunha will attempt to answer the question: "To what extent can the Treaty of Lisbon be considered as a true European constitution?" The professor, who is based at the University of Porto, is currently working in Brazil as part of a team creating an International Constitutional Court. Since he was very young, Cunha has described himself as a European enthusiast. The seminar will be held in English at 3 p.m. at the UM's Faculty of Law (E32) and all are welcome to attend.

Ecuador to waive visa requirements

After negotiations with the Embassy of the Republic of Ecuador in the People's Republic of China, Macau's Identification Services Bureau (BIR) has been informed that holders of the Macau SAR passport are now exempted from visa requirements when entering Ecuador for a maximum stay of 90 days. According to a statement from the BIR, a total of 128 countries or territories have agreed to grant visa-free access or visa-on-arrival permission to MSAR passport holders. A 2017 passport strength index published by residence advisory firm Henley & Partners earlier this month showed that MSAR passports were ranked a tied 36th strongest in the world in terms of the number of countries that offer visa-free access and visa-on-arrival services.

Lai Chi Vun shipyards demolition suspended

THE demolition of the controversial Lai Chi Vun shipyards area has been postponed for a year; a period of time which will allow the Cultural Affairs Bureau (IC) to complete an evaluation process to determine whether Lai Chi Vun is a historical site.

The IC conducted a press conference yesterday to announce that the bureau has a year to conduct an evaluation through consulting with relevant experts and the public.

IC president Leung Hio Ming told the press that the evaluation process would formally start after yesterday's press conference.

"For the final result of whether we are going to enlist the historic site, it has to wait until we finish all the procedures - according to the law," Leung reiterated.

The first stage of the process will include a further investigation of the details, data and historic facts about the shipyards area. After, the bureau will hand the investigative documents to a cultural preservation committee.

According to Leung, the committee is scheduled to conduct their first meeting at the beginning of April.

Aside from consulting relevant professionals, the president stressed that the IC would produce a detailed report on what they have at the moment and organize a public consultation period for at least 30 days.

The IC has pledged to organized seminars, workshops and to invite members of the public to hear their opinion.

"After we gather all the information from the public, with sufficient professional data and information, then we are going to make the difficult decision; and everything has to finish within one year," Leung explained.

citizens handed a petition – which collated 670 signatures from Macau residents - to the bureau.

The group called for the IC to suspend the demolition immediately and conduct a cultural heritage assessment of the shipyards.

In the midst of several concerned groups criticizing the decision on demolishing the area, Leung listed the bureau's fundamental opinion of the controversial issue.

"Our realization of this place is threefold: we must preserve the art of ship building, we have to preserve the old village living style in that area, and we have to preserve the [opportunity for] people to get in touch with nature," the president vowed.

The first dismantlement of two lots in the area occurred on March 8 due to their precarious state.

Unknown fate for dilapidated shipyards

THE government reclaimed three properties in the Lai Chi Vun area in May 2016. Around that time, the former IC president, Ung Vai Meng, said that these properties – which include shipyards and two small wooden houses – would "serve to launch a display of traditions" showcasing the heyday of Macau's shipbuilding industry.

Last month, Maria Helena de Senna Fernandes, director of the Macau Government Tourism Office (MGTO), proposed that masthe main structure of their premises, creating a high security risk."

As recently as the 1950s, the coastal villages were thriving in Macau. Historical accounts indicate that at the time there were around 10,000 fishermen and over 30 shipyards in Macau, many of them in Lai Chi Vun.

Suffering from regional competition and the surge of the gaming industry in Macau, the industry collapsed in the 1990s.



When questioned about what actions the bureau would conduct if the results pointed to a complete demolition of the area, Leung replied, "we cannot ignore the voice of society."

Yet he noted that the public should trust professional opinions and decisions.

Malaysia says Kim Jong Nam's body still in the country

ALAYSIA'S health minister said yesterday the body of Kim Jong Nam is still in Malaysia, six weeks after the exiled half brother of North Korea's leader was poisoned in Kuala Lumpur.

Health Minister Subramaniam Sathasivam made the announcement as rumors swirled that Kim's body was about to flown out of the country as part of diplomatic negotiations. Custody of the body has been a flashpoint in the case as relations between Malaysia and North Korea deteriorated sharply.

Kim was poisoned on Feb. 13 at a crowded airport terminal in Kuala Lumpur. According to Malaysian investigators, two young women went up to Kim as he waited for a flight and smeared VX nerve agent — a banned chemical weapon across his face. He was dead within 20 minutes.

Although Malaysia has never directly accused North Korea of being behind the attack, many speculate that it must have orchestrated it.

Experts say the VX nerve agent used to kill Kim was almost certainly produced in a sophisticated state weapons laboratory, and North Korea is widely believed to possess large quantities of chemical weapons.

North Korea has denied any role in the killing and denounced the investigation as flawed and politically motivated. North Korea does not even acknowledge the victim is Kim Jong Nam, referring to him instead as Kim Chol, the name on the passport he was carrying when he died.

North Korea has demanded custody of the body because the victim was one of its citizens. But Malaysia refused, in part because it needed to formally identify the body, which it now says it has done, using DNA from his son.

Conflicting reports in the local media on Monday said Kim's body was to be cremated and flown to North Korea, or that the body was about to be sent to Macau, where his family is believed to be.

But Health Minister Subramaniam Sathasivam said the body is still at the morgue. "As far as we are concerned, there has been no change," he said.

"Once they finish the discussion and come to a definite decision, we will make an announcement," he said, in reference to negotiations between the two

countries.

Relations between Malaysia and North Korea have frayed since Kim's death, with each expelling the other's ambassador. North Korea then blocked Malaysians from leaving the country until a "fair settlement" of the case is reached. Malaysia responded in kind, barring North Koreans from exiting its soil.

The two women accused of wiping Kim's face with the poison have been charged with murder. The two – an Indonesian and a Vietnamese – say they were duped into thinking they were taking part in a hiddencamera prank TV show. Authorities also say they are looking for seven North Koreans. Four of them left Malaysia on the day of the killing and are likely back in North Korea. Police said the other three men are believed to be hiding in the North Korean Embassy in Kuala Lumpur. AP

FDCT increases budget for science project-funding

FOUR applied science-related projects, funded by the Science and Technology Development Fund (FDCT), were presented yesterday, showcasing the works conducted by Macau universities and institutions.

During yesterday's presentation, FDCT recalled that it received over 158 applications, with an overall requested sum of more than MOP335 million.

Although the institution continually sees an annual increase in its received applications, FDCT president of the Administration Committee of FDCT, Frederico Ma, said they have decreased the number of successful applicants.

"We try to decrease because for each application, we would like to increase the funding to have a higher rate of finishing the project," he told the Times.

However Ma noted that there are plans to increase the budget for 2017 applications.

"This year we have a total budget of MOP220 million, about a 10 percent increase [compared to the past]," Ma indicated.

FDCT is currently focusing on funding researches in Information Technology, engineering and Traditional Chinese Medicine.

Yesterday, the University of Macau (UM), Civil Engineering Laboratory of Macau (LECM) Macau University of Science and Technology (MUST) and Hou Kong Middle School presented their concluded projects.

UM rector Wei Zhao was the first to present, with the university's project titled, "Theoretical foundations, design methodologies, and supporting technologies for cyber physical networking systems."

The project, which UM called "WInternet," is a technology and science base for internet of things (IoT).

IoT is a critical networking infrastructure for cyber-physical systems, as cited in the university's Faculty of Science and Technology's webpage.

"With IoT, physical objects should be seamlessly integrated into an internet-like networking system so that the physical objects and cyberagents can interact to each other in order to achieve mission-critical objectives," the presentation indicated.

The four-year project, which was budgeted at around MOP4 million, claimed to be the first university to be able to develop a system that interconnects different IoTs to different places in the world, making them a global network.

"This technology has a lot of potential to be commercialized. Macau needs to diversify its industry, [so] we need to identify several fields in which we can develop technology to help Macau develop its own industry," the rector explained to the Times.

Wei also revealed that the university is currently developing a national laboratory to develop mature technology, which he hoped would contribute to Macau and other regions.

When asked how the technology is currently being integrated in society, Wei noted that companies are approaching them to utilize their products in their firms.

"We are working for different companies," he claimed. "We've been recognized [favorably as] the very first academic journal of IoT published our article," he concluded.

LECM, MUST and Hou Kong Middle School presented projects which amounted to MOP739,300, MOP2 million and MOP360,500 respectively. **LV**

Firm linked to Imperial Pacific arranged Saipan lawmakers' trips

 HE company that paid

for controversial factfinding visits to Hong Kong and Macau by lawmakers from the U.S. territory of Saipan has connections to the operator of the island's casino, according to evidence accepted by a Hong Kong court this month.

In a High Court judgment issued March 16 in a suit over casino debts, Judge Bebe Pui Ying Chu found "credible" the overall testimony of a Chinese gambler who said that Ji Xiaobo and Cai Lingli were representatives of a firm called Esteem Capital Success Ltd. in the fall of 2013. Ji's mother owns a controlling stake in casino operator Imperial Pacific International Holdings Ltd., while Cai is its executive director. Ji was the Saipan casino's project manager as of November, the company said then.

This is the first time a link has been drawn between Esteem Capital and Imperial Pacific, which in a November interview said it never had any connections to the firm. The trips taken by Saipan legislators, including then-senator Ralph Torres, to Hong Kong and Macau were arranged by Esteem, according to Torres, who is now the territory's governor. Esteem was not among bidders for Saipan's first-ever casino license. Soon after the trips that were taken from late 2013, Imperial Pacific won the bidding, gaining exclusive rights to operate a casino in the Pacific territory.

The trips raised questions at the time, with critics of the license process alleging that the gaming bill passed by the legislature benefited the investor group that had brought the legislators to Hong Kong and Macau, the Sai-



pan Tribune reported in 2014.

Imperial Pacific declined to comment on the relationship between Imperial Pacific and Esteem Capital or the language in the court's judgment. Esteem Capital is not listed in company registries in Hong Kong or China.

The visits to **HK and Macau** occurred a few months before Saipan legislators reversed years of opposition to a casino on the island

Torres was "offered no reason to establish a connection between Esteem Capital and Imperial Pacific" when he traveled to Hong Kong and Macau to observe the operation of integrated casino resorts, he said in an email

through a representative. Torres was told that Esteem was in the business of promoting such resorts in Asia, he said. The governor was unaware of the Hong Kong judgment and said he couldn't comment on it.

The court decision included testimony that described Ji's office, listed on a business card bearing his name and that of Esteem Capital, as the same 70th-floor suite in Hong Kong's International Finance Center skyscraper that since last year has housed Imperial Pacific's corporate headquarters.

In a Hong Kong exchange filing in 2011, the same suite was listed as the address for a subsidiary of Simsen International that was identified in the court decision. Ji held a 9 percent stake in Simsen in 2014. The suite was occupied by the Simsen unit up until Imperial Pacific took it over, according to the building's reception.

In the Hong Kong case, a Simsen subsidiary sued Chinese gambler Jiang Quanlong for allegedly not paying back more than HKD212 million (USD27 million) in loans. Ji's mother, mainland Chinese entrepreneur Cui Lijie, owns about 64 percent of Hong Konglisted Imperial Pacific, according to a Hong Kong exchange filing in October. Cai, Imperial Pacific's executive director, was described in the court testimony as Ji's secretary at Esteem.

Imperial Pacific's casino on remote Saipan, dubbed Best Sunshine Live, has attracted attention throughout the gambling industry for posting per-table VIP revenues far greater than those of the largest facilities in Macau, Asia's gambling capital. The company has said that success is due in part to wealthy Chinese bettors choosing to take the roughly five-hour flight to the Pacific island rather than going to Macau, sometimes betting millions of dollars at a time.

A competing bidder for Saipan's sole gambling license alleged in an unsuccessful 2014 lawsuit that local lawmakers had illegally received "significant benefits" from casino investors, and that regulators had refused to investigate whether Imperial Pacific was linked to them. A spokeswoman for Torres said in November there is no evidence to support allegations of improper benefits to legislators.

The visits to Hong Kong and Macau occurred a few months before Saipan legislators in March 2014 reversed years of opposition to a casino on the island, passing a law to open bidding for the license.

Imperial Pacific's then-Chief Executive Officer Mark Brown said in an interview in November that Imperial Pacific has never been connected to Esteem or had anything to do the legislators' visits to Hong Kong.

"We met them, but we had nothing to do with the trip or taking them around," Brown, now the company's chairman, said in November, referring to meetings between the legislators and Imperial Pacific. Brown said he didn't know who arranged the meetings that took place before he joined Imperial Pacific in November 2014.

"Whoever they were, they dropped out," he said, referring to Esteem not joining the list of bidders for the Saipan casino license.

Brown, a former executive in President Donald Trump's Atlantic City casino empire, has led Imperial Pacific's plan to replace what it describes as a temporary facility with a much larger luxury hotel and casino complex slated to open next month. After downgrades from Fitch Ratings and Moody's Investors Service in January, the company sold \$150 million in bonds this year to Inventive Star Ltd., which is controlled by Cui.

Imperial Pacific has faced multiple court challenges since the Saipan facility opened, including a December suit from a former executive who alleged violations of money-laundering rules at the facility. The company says it complies with all relevant regulations. Imperial Pacific told the court March 1 that it will file an amended answer to the plaintiff's claim shortly. Bloomberg

Leong: 'Prudent' management of MSAR's investment portfolio

THE Secretary for Eco-**I** nomy and Finance, Lionel Leong, said that the government would continue to adopt safe, effective and prudent strategies in managing its investments. The Monetary Authority of Macau (AMM) revealed last week that Macau's fiscal reserve in 2016 recorded a total investment income of MOP3.31 billion, representing an annual

return of 0.8 percent. Allocated assets contributing to the generation of last year's investment income included global bonds; while the reserve's investments in foreign exchange and equity markets recorded deficits due to market volatilities experienced worldwide. Speaking this week on

the sidelines of a banquet to mark the 9th anniversary of the People's Alliance of Macau, Lionel Leong said he had directed the Monetary Authority of Macau to monitor closely developments in the global economy in 2017, and to diversify the investment profile, based on a full and balanced assessment of risk factors.

The secretary added that the government's investment in the equity market

- an investment overseen externally by asset managers - had an allocation of 11 percent of its fiscal reserve. The government is studying the possibility of increasing the proportion of investment in the equity market in order to allow the participation of more investment professionals.

Regarding an interest rate increase in the United States, Leong said that the MSAR authorities are closely monitoring how to ensure maintenance of the region's economic growth. Leong is looking in particular at how the city might be affected by possible changes in the purchasing power available to some of its visitors, due to the move by the U.S.

Ho Chio Meng trial resumes today

It was confirmed by order of a judge that the trial of former prosecutor general, Ho Chio Meng, would resume today. The trial had been suspended after the legal team that was representing Ho, led by Leong Weng Pun, stepped down earlier this month. After the new defense lawyer Oriana Pun took up the case, a break period of two weeks was provided to give her enough time to familiarize herself. Initially, Pun had requested at least one month to study the case. The court gathered last week in order to hear non-Macau resident witnesses that had already been notified.

Few employers respond to 'flawed' gov't survey

The Labour Affairs Bureau has said that it need to continue conducting public consultation sessions with employers and employees before agreeing to a new adjustment to the minimum wage for cleaning and security staff, just one year after a related law was introduced by the government. Representatives of employers met with government officials yesterday afternoon to discuss the issue, where they complained that authorities had not sought enough opinions from the private sector. A representative of the Standing Committee for the Coordination of Social Affairs said that very few of the companies surveyed had actually responded, citing a "flawed questionnaire design," according to public broadcaster TDM. "The number of respondents failed to reflect the law's impact on the industry," the representative said. Meanwhile, worker resentatives, also present at th meeting, said that they hope a universal minimum wage will be introduced in Macau by 2019.

Macau to implement new rules on tax information exchange

DEBATE over legal amendment which establishes new rules for the financial transparency of Macau based persons and companies which have tax residences abroad has reached a conclusion.

The amendment will be sent to the Legislative Assembly (AL) in the next couple of days to be voted on and approved, the spokesperson of the Executive Council (ExCo), Leong Heng Teng, informed yesterday in a press conference. The proposal was made because of the need to adapt the current Law on Exchange of Information on Tax Matters so that it will comply with the Common Reporting Standard and Due **Diligence on Financial Account** Information (CRS) from the United Nations (UN) Organization for Economic Cooperation and Development (OECD). The CRS from the OECD demanded that all countries need to start sharing this information in an automated system and that these automated systems should be operational by 2018. The OECD also encouraged countries and persons to participate in these systems in a more voluntary and spontaneous way. The ultimate goal of such sys-

tems is to help to fight fraud and tax evasion and avoidance. Besides the already established mechanism of formal request of information, the revision establishes two new mechanisms that will include the automated exchange.

As Leong explained, while the exchange of information by request is due to "people, associations, foundations or other

legal entities that are supported by other government services, institutions or people in MSAR [regarding their actions] related to operations done in the finance system, 'offshore', and insurance," such information sharing is depending on approval by the Chief Executive. If approved, they will be done with entities with "which Macau has agreed a principle of reciprocity and as long as Central or local government secrets are not violated as well as other commercial or professional secrets are not questioned."

Answering questions posed by journalists, Leong said that such information might include "names, addresses and account balances." He said that such a system does not include Macau residents "that are not included in other countries' taxation systems," aiming mostly to "disallow multinational companies that are based in different countries to transfer part or the totality of their profits into a different country in order to benefit from more a convenient taxation" he noted.

As for the automated exchange of information, the first of these mechanisms are related with the finance institutions and establishes that information of banking operations should be recorded and shared with the Financial Services Bureau (DSF) in pre-established periods in a systematic way. Records of such information should be kept for a period of five years.

As for the spontaneous exchange, it is related to information regarding tax exemption or reduction that might justify the payment of extra taxes on another country and as the ExCo spokesperson explained is mostly related to a system that will allow crosschecking of information preventing contributors from providing "false declarations in other countries about their assets and benefits."

The system does not cover residents which are not included in overseas taxation systems

The draft will also establish administrative penalties regarding the responsibilities of the entities, personal data protection and regarding the principle of confidentiality as well as empowering the DSF with the ability to undertake and manage the exchanges and supervise the financial institutions that would perform automated exchanges.

The director of the DSF, Iong Kong Leong, replying to questions from the media also noted that in the cases where there is a request for information, the authorities must inform the account holder.

Iong also noted that to fulfill the international agreements to provide information from 2018 the financial institutions will need to start to collect data from July 1 this year.



Manhattan landlords are turning to giveaways for retailers

MANHATTAN landlords, who have seen retail occupancy plummet after boosting rents to record levels, are trying to avoid big price cuts. Instead, they're writing checks for things like interior redesigns and moving expenses to keep storefronts from going empty.

Tenant-improvement allowances haven't been typical in the Manhattan retail market. But now the concessions, which can pay for anything from lighting and displays to a complete overhaul, are becoming a key component in some new leases, particularly for large, flagship stores in high-profile areas, such as Madison Avenue and Fifth Avenue, according to Steve Soutendijk, an executive director at brokerage Cushman & Wakefield Inc.

"We're seeing tenant-improvement and concession packages that retail landlords never, ever contemplated before," he said.

The sweeteners signal that the balance of power is tilting toward merchants in Manhattan after a relentless surge in rents during the past five years. Landlords facing rising vacancies are more willing to negotiate with retailers, who have gotten battered by the rapid rise of e-commerce and have shied away from committing to costly, longterm leases.

The incentives are "a creative solution that landlords are using now to get deals done," said Jeffrey Roseman, an executive vice president at Newmark Grubb Knight Frank Retail. "It's a way to get over the hump."

The details of leases in Manhat-

tan are often closely guarded secrets, making it difficult to quantify the incentives retailers are receiving. Landlords have a lot of ways to cut a deal without lowering asking rents, such as paying the construction contractor, offering an extended period of free rent or simply writing a check for the tenant to use at their discretion.

Property owners are kicking in as it becomes more expensive to build out stores. Companies are creating elaborate installations, such as the basketball court where customers can try out their sneakers in Nike Inc.'s 5,100-square-meter Soho store, in an effort to create an experience that shoppers can't get online. Sportswear maker Under Armour Inc. plans to open what Chief Executive Officer Kevin Plank has called "the single greatest retail store in the world" at its new Fifth Avenue home, formerly occupied by FAO Schwarz.

In the city's largest retail lease of 2016, Nike in December signed a 15-year agreement to rent 69,214 square feet across seven floors at 650 Fifth Ave. in Midtown. Landlords SL Green Realty Corp. and Jeff Sutton had been working to fill the space since acquiring the property in 2013. They bought out the leases of Devon & Blakely and Godiva and committed to adding three additional floors and rerouting the storefront's entrance, according to a presentation in December for SL Green's investors.

"That deal did not come easy by any stretch," Andrew Mathias, president of SL Green, said while discussing the Nike lease at the investor conference.

As part of Nike's deal at 650 Fifth Ave., the landlords offered to take over the company's lease obligation at an existing store about five blocks away and adjacent to Trump Tower, according to a person with knowledge of the transaction who asked not to be named because the terms are private.

The landlords haven't disclosed the breakdown of rental rates and costs associated with the USD700 million Nike deal. In its presentation, SL Green forecast a 7.75 percent return on the investment.

Representatives of SL Green, Sutton and Nike declined to comment.

At 680 Madison Ave., fashion designer Tom Ford signed a lease in August for 12,300 square feet, taking over the space after a Qatari luxury retailer backed out of a deal. As an enticement, landlord Thor Equities gave Ford about \$12 million in an improvement allowance, a person with knowledge of the transaction said.

Merchants in Manhattan are gaining more leverage in negotiations after landlords pushed leasing costs to record highs. As the U.S. emerged from the recession and overseas tourism in New York boomed, rents on Fifth Avenue from 49th to 60th streets -- the world's most expensive stretch of retail real estate -- jumped about 50 percent in the past five years, according to Cushman. The growth drew property investors.

"Street retail was the golden goose," said Alexander Goldfarb, an analyst covering real estate investment trusts at Sandler O'Neill & Partners. "Suddenly, everybody wanted a golden goose."

Tepid demand for luxury goods and a stronger U.S. dollar that's crimped spending by tourists have particularly hurt Fifth Avenue, where the space-availability rate was at a record 15.9 percent in fourth quarter, up from 10.1 percent a year earlier, Cushman data show. The average rent on the stretch from 49th to 60th streets reached a record \$3,213 a square foot in the third quarter before dropping in the last three months of the year to \$2,985.

Some landlords will grant generous tenant-improvement allowances rather than slash rents in order to maintain a property's value, said Susan Kurland, an executive vice president of retail services at brokerage Savills Studley Inc. That trend has accelerated over the past 12 months in prime locations in Manhattan, she said. **Bloomberg**

LANDLORDS OFFERING CONCESSIONS

THE RISE in costs for retail landlords mirrors trends in other corners of the commercialproperty market. Manhattan office landlords, facing falling rents and heightened competition, took on a record 12 percent of the expense of converting raw space last year, according to Savills Studley. Apartment landlords are offering concessions and paying broker's fees - a burden typically shouldered by the tenant in New York - to better compete as a glut of new towers gives renters more choices. "People bought assets predicated on achieving incredible rents and were unable to deliver," Goldfarb said. "One of the oldest tricks in real estate is to maintain high face rents by funding a lot of incentives up front."

Twitter adds video ads to periscope amid YouTube content uproar

TWITTER Inc. is adding advertising to posts from its Periscope live-broadcasting tool but only on the safest videos.

As some of the world's largest advertisers pull spending from Google's YouTube video-sharing site amid concerns about placement with potentially offensive material, Twitter is touting that its Periscope ads will be placed predictably and only with high-quality publishers that the marketers choose.

"They'll be able to scale and have complete control about where their message appears on live content on Twitter," Matt Derella, Twitter's vice president of global revenue, said in an interview. "Brands can control and choose the trusted content they want to align their message with."

It's a difficult promise to make about live content. Periscope users have pos-

ted live feeds of violent protests and crimes, for example. The social-media company has a program to work directly with certain publishers, such as media organizations and influencers. When advertising starts on Periscope in the coming weeks, initially on a trial basis, Twitter will share the revenue with those top-tier creators. The ads will play before the videos start rolling.

Twitter is struggling to win market share in a di-

gital-ad market dominated by Facebook Inc. and Alphabet Inc.'s Google. It may have an opportunity in video as YouTube works to repair relationships with advertisers that saw their commercials play alongside offensive, racist or extremist content. You-Tube had been matching ads to videos automatically, as opposed to letting marketers pick the pairings - a tactic that allowed the site's ad business to grow quickly but now has the company scrambling



for technical solutions. Periscope's progress will be slower, with an invitation-only trial to start, Derella said. Twitter wouldn't say how much of the video on its site comes from its Periscope tool only that many millions of hours of Periscope are watched every month. The company is betting on video advertising to help boost its sales, which have slowed in recent quarters and are expected to post their first annual decline this year. **Bloomberg** ADVERTORIAL



Cape Verde reinforces openness to foreign investment

CAPE Verde, the Portuguese-speaking African country with the highest level of development and greatest political and economic stability, is preparing a set of measures to further open up the archipelago to foreign investment, according to a recent publication.

Recent developments and prospects for this year in the Cape Verde archipelago are the focus of the first of the Africa Reports, a new publication launched this month, joining Africa Monitor Intelligence, Legis-PALOP, a legal knowledge and information sharing platform and Eupportunity, a consultancy specialized in European affairs.

Among the main trends identified in Cape Verde for the coming months are privatizations, pending the presentation by the government of a program that includes the management of ports and airports, energy and water, ship repair, air transport, production and sale of drugs and the financial restructuring of public enterprises, in particular airline TACV and real estate company Imobiliária Fundiária e Habitat (IFH), which is in a weak financial situation due to the risks of its largest housing project (House

infrastructure in recent years."

"The tax reform package is ambitious, as are the aims of creating conditions to promote financing of the economy. Similarly, measures are expected for greater flexibility of the labor market and education and training initiatives, to further reduce a mismatch of skills, which affects productivity," says the report.



Beijing concerned over Paris Asian community clash with police

VIOLENT clashes in Paris between baton-wielding police and protesters outraged at the police killing of a Chinese man in his home injured three police officers and led to the arrest of 35 protesters, authorities said yesterday.

The incidents prompted international attention, as China's Foreign Ministry expressed concern to French authorities over Sunday's killing of the man, who it says was shot by a plainclothes officer.

France's Foreign Ministry responded by calling the security of Chinese in France "a priority."

Monday night saw angry demonstrators from the Asian community gather outside a police station in Paris' multicultural northeast where the killing occurred, said Agnes Thibault-Lecuivre, of the Paris Prosecutor's Office.

The crowd's fury stemmed from rumors that the man was shot in his home in Paris 19th district in front of his children while cutting up fish with scissors and had not hurt anyone. Police say an officer fired in selfdefense during a raid after the victim wounded an officer with a "bladed weapon."

With chants of "murderers" and candles that spelled "opposition to violence" lining the road Monday night, scores of demonstrators broke down barricades, threw projectiles and set fire to cars during the brutal clashes with police that lasted several hours.

Authorities said 26 demonstrators were held for participating in a group planning violence.

Witnesses said that one man of Chinese origin was injured in the clashes, according to China's state-run Xinhua News Agency.

Chinese Foreign Ministry spokeswoman Hua Chunying said that China had summoned a representative of the French embassy in Beijing Tuesday and urged French officials to "get to the bottom of the inci-



dent as soon as possible."

Chinese authorities "hope that Chinese nationals in France can express their wishes and demands in a reasonable way," Hua said.

France's Foreign Ministry confirmed that an inquiry has started to shed light on the exact circumstances of the shooting. This did not calm some 100 people from Paris' Asian community who gathered at the police station on Tuesday afternoon to demand justice including families and friends of those in custody waiting for them to be released.

"Justice must be done, the killer must be punished!" the protesters shouted, ahead of a meeting of the Chinese community yesterday to decide on what further action to take.

France is home to Europe's largest population of ethnic Chinese, a community that routinely accuses police of not doing enough to protect them against racism.

Last September, 15,000 people rallied in the French capital to urge an end to violence against the Asian community after the beating to death of Chinese tailor Chaolin Zhangh called new attention to ethnic tensions in Paris suburbs. The victim's lawyer said the August 2016 attack was ethnically motivated.

"Chinese are victims of racist attitudes in France — especially from other ethnic groups like Arabs. They are targets for crime because they often carry cash and many don't have residence permits, so can be threatened easily. They're angry with police for not protecting them enough," said Pierre Picquart, Chinese expert at the University of Paris VIII.

"Chinese people do not like to protest or express themselves publicly, so when we see them like this it means they are very, very angry. They've had enough of discrimination," he added.

He estimated that there are 2 million people living in France of Chinese origin. **AP**

A Taiwanese pro-democracy activist believed to be in Chinese custody may have attracted the attention of China's security services after he used the social media site WeChat to discuss China-Taiwan relations, a colleague said yesterday.

Lee Ming-che, 42, disappeared after clearing immigration on March 19 in the semi-autonomous Chinese territory of Macau and never showed up for a planned meeting later that day with a friend across the border in the Chinese city of Zhuhai, according to Chiu Yi-ling, secretary general of the Taiwan Association for

The Taiwan government's Mainland Affairs Council, a China policymaking body, demanded Monday that Chinese government departments disclose their "handling" of Lee and ensure his safety.

"The government is paying a high degree of attention to Mr. Lee's safety or danger and will continue doing its utmost to help his family members," the council said in a statement. **AP**

Report says man-made islands nearly complete

report from a U.S. think tank says China has nearly completed construction work on three man-made islands in the South China Sea, giving it the ability to deploy combat aircraft and other military assets to the disputed

region.

Washington-based The Center for Strategic and International Studies analyzed recent satellite photos and concluded that runways, aircraft hangers, radar sites and hardened surface-to-air missile shelters have either been finished or are nearing completion.

The report, released yesterday [Macau time], appears to be the most conclusive indication yet that China is using its island-building project to give teeth to its claim over almost the entire South China Sea and its islands and reefs.

The islands in the study – Subi, Mischief and Fiery Cross reefs – are part of the Spratly chain, which is claimed in whole or in part by China, the Philippines, Vietnam, Malaysia, Taiwan and Brunei.

On each of the islands, China has constructed enough concrete hangers for 24 fighter jets and four or five larger planes such as bombers or early warning aircraft, CSIS reported.

China already uses an existing airfield on Woody Island in the similarly disputed Paracel chain, located to the north, where it has maintained mobile HQ-9 surface-toair missiles for more than a year and deployed anti-ship cruise missiles on at least one occasion, CSIS said.

The airfields and advanced surveillance and early warning radars will allow China's military to operate over virtually the entire South China Sea.

"Beijing can now deploy military assets, including combat aircraft and mobile missile launchers, to the Spratly Islands at any time," the report said.

China's creation of seven man-made islands in the South China Sea has drawn strong criticism from the U.S. and others, who accuse Beijing of further militarizing the region and altering geography to bolster its claims.

China says its island construction is mainly for civilian purposes, particularly to increase safety for ships that carry an estimated \$5 trillion worth of goods through the waterway each year. It has also provided reassurances that it will not interfere with freedom of navigation or overflight, although questions remain as to whether that includes military ships

and aircraft.

Commenting on the report, a senior Philippine defense official said the construction China has carried out on the islands "belies a clearly military purpose contrary to Chinese public pronouncements that it is civilian in nature."

That raises the likelihood of further militarization and restrictions on air and sea traffic, posing a "clear and present danger to the present regional security balance," said the official, who requested anonymity because he was not authorized to speak to reporters on the matter.

Labor was the conservative government's last hope of getting the treaty through the upper house a decade after it was signed. Bishop said she would renew negotiations with China and Labor to find a compromise that the Senate would accept.

"It is very much in Australia's national interests for us to have the highest level of cooperation with China and other countries with whom we have an extradition treaty," she said. In Beijing, Chinese Foreign Ministry spokeswoman Hua Chunying told reporters that the treaty would help in the fight against transnational crime and promote judicial and law enforcement cooperation.

"We hope Australia can bear in mind the general picture of bilateral relations and proceed with its possible," Hua said.

conservati-Former ve Prime Minister John Howard's government signed the treaty in September 2007, only weeks before the government was defeated in a general election. The prime ministers who have followed Howard in the past decade have proved less enthusiastic about the deal, which was never ratified.

Chinese Premier Li Kegiang urged Prime Minister Malcolm Turnbull to ratify the deal during a visit last week which focused on closer economic ties, Bishop said.

and seek safe haven in Australia," Bishop said.

Powerful cyclone slams into tropical northeast

Apowerful cyclone packing winds of up to 260 kilometers per hour roared across Australia's tropical northeast yesterday, uprooting trees, tearing down fences and knocking out power to thousands, officials said.

Cyclone Debbie, which slam-

med into the coast of Queens-

land state as a fierce Category 4 storm, quickly began to weaken after making landfall near the resort town of Airlie Beach, the Australian Bureau of Meteorology said. By yesterday night, it had been downgraded to a Category 2 storm, with wind gusting up to 155 kilometers per hour.

One man was injured after a wall collapsed in Proserpine, a town south of Airlie Beach, **Queensland Police Commissio**ner Ian Stewart said. The man was taken to a hospital, where he was in stable condition.

The extent of the damage from the storm was not known as night fell across the region, but

there were reports of roofs peeling from homes, fences crumbling and trees snapping in half. The idyllic Whitsunday Islands, a popular tourist destination, were hit particularly hard, with one recorded wind gust of 263 kilometers per hour, the meteorology bureau reported.

The slow-moving storm pounded the coastal region for hours, creating what Stewart called a "battering ram effect," with the same areas enduring the howling winds and drenching rains for a punishingly long time.

Communities along more than 300 kilometers of coastline were expected to be impacted, Stewart said.

Australia's military was sending vehicles, aircraft and supplies to the region, with soldiers focusing on clearing debris and reopening roads, State Recovery Coordinator Brigadier Chris Field said.

John Collins, a member of the Whitsundays government council, was sheltering from the storm with his wife and four daughters inside their house in Proserpine. He could see that four of his neighbors' sheds had been destroyed and every house within sight — including his own - had lost their fences. At least four trees had been smashed to pieces.

"It sounds like you got a jumbo jet sitting on the roof of your house," Collins said by telephone of the wind roaring outside. "It really is so loud. It's incredible."

Collins' wife and two of their daughters were so scared they were hiding under blankets. Meanwhile, one of his other daughters - whom he described as "a real weather nerd" was enthralled with the storm, and was diligently listening to the radio for updates on its path. The family's power had been out since yesterday morning, and they were resigned to several more hours of waiting until it was safe to emerge from their house.

"It's just going on and on and on," he said.

Thousands of people evacuated low-lying areas in the storm's path on Monday. Hundreds of schools were closed yesterday and more than 50,000 households were without power.

"Conditions have deteriorated rapidly," Australian Prime Minister Malcolm Turnbull said in an address to Parliament. "Take care and stay safe. Be prepared to shelter in place until today."

The storm also poses a serious threat to the farming region's crops. The area produces sugarcane and a wide range of fruits and vegetables, including tomatoes, mangoes and peppers. AP

HE Ferrari driver who allegedly slammed into a motorcycle cop, dragged him along the road and then sped away from the mangled body took just hours to find, as investigators followed a trail of brake fluid into the gated estate of one of Thailand's richest families.

But the prosecution of Red Bull heir Vorayuth "Boss" Yoovidhya has been delayed almost five years. When Vorayuth, 31, has been called in to face authorities, he hasn't shown up, claiming through his attorney that he's sick or out of the country on business. And while statutes of limitations run out on key charges this year, it's widely assumed he's hiding, possibly abroad, or quietly living locally, only going out in disguise.

He isn't.

Within weeks of the accident, The Associated Press has found, Vorayuth was back to enjoying his family's jet-set life, largely associated with the Red Bull brand, an energy drink company co-founded by his grandfather. He flies around the world on Red Bull jets, cheers their Formula One racing team from Red Bull's VIP seats and keeps a black Porsche Carrera in London with a custom plate: B055 RBR. Boss Red Bull Racing.

And he's not hard to find.

Last month, social media clues led AP reporters to Vorayuth in the sacred city of Luang Prabang, Laos, where he and his family enjoyed a USD1,000-anight resort, visited temples and lounged by the pool.

Critics say inaction in this case epitomizes longstanding privilege for the wealthy class in Thailand, a politically tumultuous country that has struggled with rule of law for decades.

The Yoovidhya family attorney did not respond to AP's request to interview Vorayuth. Police say Vorayuth is once again on notice to show up and hear the charges. He's due at the prosecutors' of-

fice tomorrow.

Vorayuth and his siblings grew up in a private, extended family whose fortune expanded from millions to billions. His brother is nicknamed Porsche, his sister Champagne. Vorayuth received a British education at a \$40,000-a-year boarding school. In rural Thailand, police Sgt. Maj. Wichean Glanprasert didn't have such opportunities, but he was ambitious. The youngest of five, he was the first to leave their coconut and palm farm for the city, the first to get a government job, to graduate from college. He paid for his parents' medical care and supported a sister through cancer. He had no children, but planned to put his brother's kids through college. Their lives collided pre-dawn on Sept. 3, 2012, when Vorayuth's Ferrari roared down Sukhumvit Road, one of Bangkok's main drags. The bloody accident scene made national

headlines for days.

The policeman's family grieved, but they figured at least there would be justice. Wichean was a police officer. Certainly the system would hold his killer responsible.

"At first I thought they'd follow a legal process," said his brother Pornanan.

Now he's not so sure.

"We will not let this police officer die without justice. Believe me," said Bangkok Police Commissioner Comronwit Toopgrajank in the days after the accident.

As the case unfolded, the Yoo-

charge expired after a year. The more serious charge of hit-andrun, which police say carries a penalty of up to six months in jail, expires in September.

Complicating matters, Yoovidhya's attorney has repeatedly filed petitions claiming unfair treatment in the investigation.

Police say it's up to prosecutors to charge him. Prosecutors say extra investigation is needed, but wouldn't specify.

Thammasat University law professor Pokpong Srisanit said the situation is "not normal" but does appear legal.

Meanwhile, the Thai media fi-

rant Gordon Ramsay in London. At the Wizarding World of Harry Potter in Osaka, he posed wearing robes from Hogwarts School's darkest dorm, Slytherin House. Friends and cousins posting about him have hundreds of thousands of online followers.

His lifestyle – soaking in an Abu Dhabi pool, dining in Nice, France, holding a \$10,000 bicycle in Bangkok – is supported by his family's billions.

Vorayuth's grandfather, Chaleo Yoovidhya, was known as a modest, private man who grew up in poverty, the son of a duck seller.

Before Vorayuth was born, Chaleo partnered his company T.C. Pharma with Austrian entrepreneur, Dietrich Mateschitz, investing \$500,000 each to carbonate and market a caffeine-powered syrupy energy drink popular in Thailand. In 1987, Red Bull Energy Drink went international.

Red Bull is now sold in 170 countries. It has its own media company, race cars and jets, and sponsors concerts and extreme athletes. Forbes estimates Vorayuth's father Chalerm Yoovidhya's net worth at \$9.7 billion. Vorayuth's legal situation is far

from unique. In 2010, a 16-year-old unlicen-

sed daughter of a former military officer crashed her sedan into a van, killing nine people. The teen, from an affluent family, was given a two-year suspended sentence and had misunderstandings that postponed her community service until last year.

Her case, and others involving what the local press calls "Bangkok's deadly rich kids," are handled markedly different than most deadly car crashes, in which Thais are typically arrested, prosecuted and sentenced to jail.

Today in his small apartment, Sgt. Maj. Wichean's brother keeps a few photo albums of him. Pornanan says Thailand runs on a "double standard."

Last month on Instagram, a friend posted a group shot, guys taking a snowboarding break at Japan's majestic Annapuri ski resort.

"ran into little bull @bossrbr lets catch up tonite dude" says a friend.

"Snow snow snow," chimes in another.

"Wof wof," says bossrbr. AP

vidhya family attorney said Voravuth left the scene not to flee, but to tell his father. Vorayuth's blood alcohol levels were high because he drank once he got home to settle his nerves, said the attorney.

Sgt. Maj. Wichean's family accepted a settlement, about \$100,000. In turn, they promised not to press criminal charges.

"Blood money," says Pornanan, whose share sits in the bank.

Meanwhile, Vorayuth failed to show up when ordered to face criminal charges of speeding, hitand-run, and deadly, reckless driving. Police say Vorayuth disputes the reckless-driving charge, claiming the officer swerved in front of him. The speeding gures he's laying low.

Last year the Bangkok Post said that after paying the settlement in 2012, Vorayuth "has been out of the country or otherwise unable to answer the criminal case against him in the years since." A few weeks after the article appeared, a photo of Vorayuth was posted online. He was on the beach at a seaside resort south of Bangkok.

While Vorayuth's case has been on hold since 2012, his carefree lifestyle has not.

More than 120 social media posts show Vorayuth visiting at least nine countries since Sgt. Maj. Wichean's death. He's cruised Monaco's harbor, snowboarded Japan's powder, and celebrated his birthday at Restau-

photograph focusing on the legs of Prime Minister Theresa May and Scottish First Minister Nicola Sturgeon. The photo of the two leaders published yesterday displays their legs prominently alongside a headline that read "Never mind Brexit, who won Legs-it!"

May and Sturgeon had met to discuss vital differences in their approach to Britain's exit from the European Union and a possible second Scottish independence referendum that could break up the United Kingdom.

It was their legs however that drew the popular tabloid's attention, drawing complaints of sexism from some politicians and readers. An inside headline said their "pins" were the finest weapons at their command.

The newspaper said in a statement that the piece about the legs was a "lighthearted" side-bar alongside a serious political story, and urged critics to "get a life."

The statement said the Daily Mail often comments on the appearance of male poli-

ticians, and asks if there is a rule that all political coverage must be dull.

A spokesman for Sturgeon said it is "slightly surprising" that when two leaders are discussing such important issues the newspaper's "main focus should be on their legs and what they are wearing."

PARIS AND London, traditional rivals when it comes to attracting tourists and industry, have signed a business agreement to cooperate in attracting visitors and companies. The two cities, which are linked by rail, have seen their rivalry intensify recently as Paris hopes to welcome finance jobs that are expected to leave London because of Brexit. Trump takes aim at Obama's efforts to curb global warming

OVING forward with a campaign pledge to unravel former President Barack Obama's sweeping plan to curb global warming, President Donald Trump will sign an executive order today [Macau time] that will suspend, rescind or flag for review more than a half-dozen measures in an effort to boost domestic energy production in the form of fossil fuels.

As part of the roll-back, Trump will initiate a review of the Clean Power Plan, which restricts greenhouse gas emissions at coal-fired power plants. The regulation, which was the former president's signature effort to curb carbon emissions, has been the subject of long-running legal challenges by Republican-led states and those who profit from burning oil, coal and gas.

Trump, who has called global warming a "hoax" invented by the Chinese, has repeatedly criticized the power-plant rule and others as an attack on American workers and the struggling U.S. coal industry. The contents of the order were outlined to reporters in a sometimes tense briefing with a senior White House official, whom aides insisted speak without attribution despite President Trump's criticism of the use of unnamed sources in the news media.

The official at one point appeared to break with mainstream climate science, denying familiarity with widely publicized concerns about the potential adverse economic impacts of climate change, such as rising sea levels and more extreme weather.

In addition to pulling back from the Clean Power Plan, the administration will also lift a 14-mon-

leases on federal lands.

The Obama administration had imposed a three-year moratorium on new federal coal leases in January 2016, arguing that the USD1 billion-a-year program must be modernized to ensure a fair financial return to taxpayers and address climate change.

Trump accused his predecessor of waging a "war on coal" and boasted in a speech to Congress that he has made "a historic effort to massively reduce job-crushing threaten "the future and livelihoods of our great coal miners." The order will also chip away at other regulations, including scrapping language on the "social cost" of greenhouse gases. It will initiate a review of efforts to reduce the emission of methane in oil and natural gas production as well as a Bureau of Land Management hydraulic fracturing rule, to determine whether those reflect the president's policy priorities.

It will also rescind Obama-era executive orders and memoranda, including one that addressed climate change and national security and one that sought to prepare the country for the impacts of climate change.

The administration is still in discussion about whether it intends to withdraw from the Paris Agreement on climate change. But the moves to be announced will undoubtedly make it more difficult for the U.S. to achieve its goals.

Trump's Environmental Protection Agency chief, Scott Pruitt, alarmed environmental groups and scientists earlier this month when he said he does not believe tributor to global warming. The statement is at odds with mainstream scientific consensus and Pruitt's own agency.

The overwhelming majority of peer-reviewed studies and climate scientists agree the planet is warming, mostly due to man-made sources, including carbon dioxide, methane, halocarbons and nitrogen oxide.

The official who briefed reporters said the president does believe in man-made climate change.

The power-plant rule Trump is set to address in his order has been on hold since last year as a federal appeals court considers a challenge by coal-friendly states and more than 100 companies who call the plan an unconstitutional power grab.

Opponents say the plan will kill coal-mining jobs and drive up electricity costs. The Obama administration, some Democratic-led states and environmental groups countered that it would spur thousands of clean-energy jobs and help the U.S. meet ambitious goals to reduce carbon pollution set by the international Trump's order on coal-fired power plants follows an executive order he signed last month mandating a review of an Obama-era rule aimed at protecting small streams and wetlands from development and pollution. The order instructs the EPA and Army Corps of Engineers to review a rule that redefined "waters of the United States" protected under the Clean Water Act to include smaller creeks and wetlands.

While Republicans have blamed Obama-era environmental regulations for the loss of coal jobs, federal data shows that U.S. mines have been shedding jobs for decades under presidents from both parties as a result of increasing automation and competition from cheaper natural gas. Another factor is the plummeting cost of solar panels and wind turbines, which now can produce emissions-free electricity cheaper than burning coal.

According to an Energy Department analysis released in January, coal mining now accounts for fewer than 70,000 U.S. jobs. By contrast, renewable energy including wind, solar and biofuels — now accounts for more than 650,000 U.S. jobs.

The Trump administration's plans drew praise from business groups and condemnation from environmental groups.

U.S. Chamber of Commerce President Thomas J. Donohue praised the president for taking "bold steps to make regulatory relief and energy security a top priority."

"These executive actions are a welcome departure from the previous administration's strategy of making energy more expensive through costly, job-killing regulations that choked our economy," he said.

Former EPA Administrator Gina McCarthy accused the Trump administration of wanting "us to travel back to when smokestacks damaged our health and polluted our air, instead of taking every opportunity to support clean jobs of the future."

"This is not just dangerous; it's embarrassing to us and our businesses on a global scale to be dismissing opportunities for new technologies, economic growth, and U.S. leadership," she said in

Cheney blasts Russia's alleged interference in US election

FORMER U.S. Vice President Dick Cheney has criticized Russia's alleged interference in the U.S. presidential election, calling it a hostile act.

Russian President Vladimir Putin made a serious attempt to interfere in the 2016 election and other democratic processes in America, Cheney said.

"In some quarters, that would be considered an

act of war," Cheney said in a speech this week at a conference in New Delhi. Cheney said the Cold War was long over but Putin is on a course to reestablish Russian power following the collapse of the former Soviet Union. "Putin has aspirations of trying to correct what he sees as a disaster. He has designs on the Baltics. He wanted Crimea and he took it. And he is trying to undermine NATO," Cheney said.

Russian cyber interference is "the kind of conduct and activity that we'll see going forward," he said.

But he also warned that Russia should not "underestimate the weight that we as Americans assign at Russia's attempts to interfere in our democratic

processes."

Cheney's accusation comes at a time when both the U.S. Senate and House of Representatives intelligence committees are investigating possible Russian interference in the election that brought President Donald Trump to power.

Among the other threats faced by the United States, Cheney listed an aggressi-

ve China, North Korea, Iran and the terror threat posed by the Islamic State group.

He described North Korea as the "most dangerous part of the world with an unpredictable head of government" who is developing nuclear warheads and missiles to add to his stockpile.

Cheney said these threats come at a time when the U.S. military is at a "significantly diminished level" following eight years of budget cuts under the Obama administration.

The U.S. budget debate in the coming weeks will focus on how to allocate more funds to rebuild the military and restore the relationships that the United States had with its allies and adversaries in the past, he said. **AP** WWW.MACAUDAILYTIMES.COM.MO

1999 HANRATTY FAMILY WINS RIGHT TO APPEAL

The case of James Hanratty has been sent back to the Court of Appeal - 37 years after he was hanged for the notorious A6 murder in Bedfordshire.

The Criminal Cases Review Commission, (CCRC), the body set up to investigate miscarriages of justice, has referred the case back to the courts after a two-year study of the evidence which convicted the 25-year-old.

New DNA evidence has emerged and a police inquiry into the conviction highlighted flaws in the original investigation.

Campaigners have produced new witnesses who insist Hanratty was 200 miles from the scene of the murder and have produced new evidence which calls into question eyewitness reports used to convict him. Hanratty was hanged in Bedford Prison in April 1962, after being convicted of the murder of government scientist Michael Gregsten, 36, and assaulting Valerie Storie, 22, his laboratory assistant and mistress.

They were kidnapped from a cornfield in Berkshire in August 1961 and forced to drive 60 miles at gunpoint to Deadman's Hill in Bedfordshire, where Mr Gregsten was shot dead and Miss Storie was raped, shot and left for dead.

Miss Storie survived and picked out Hanratty at an identification parade from her hospital bed, where she lay paralysed from the waist down.

But Hanratty supporters said she had seen the attacker for only a few seconds during the six-hour ordeal, and failed to pick him out at the first police identity parade.

She later admitted her memory of the attacker was failing.

Hanratty insisted he was 250 miles from the scene in a bed-and-breakfast in Rhyl, North Wales, at the time of the attack and the landlady backed up his claim.

In the years after his execution a number of witnesses came forward to support the story.

Hanratty lost an appeal in 1962 and became one of the last men in Britain to be sent to the gallows. He denied his guilt to the end and before he died he wrote to his brother Michael: "I'm dying tomorrow but I'm innocent. Clear my name."

WHAT THE SMURF?! SMURFETTE IS SHUNNED IN ISRAELI ULTRA-ORTHODOX CITY

IN CONTEXT

Hanratty's case became a cause celebre, with politicians, pop stars, legal experts and writers, joining the campaign to prove he was the victim of a miscarriage of justice.

His family fought to clear his name and the CCRC decision in 1999 brought this opportunity.

During the case new forensic techniques not available at the time were used.

Hanratty's body was exhumed for DNA testing against traces found on Miss Storie's underwear and the handkerchief wrapped around the gun. After the test scientists said the DNA was 2.5 million times more likely to belong to Hanratty than anyone else.

Hanratty's family and lawyers argued these tests proved nothing because there was a real possibility evidence gathered in 1961 had been contaminated.

In 2002 his conviction was upheld at the Court of Appeal and a bid to have it heard at the House of Lords was rejected.







ELCOME to Cristiano Ronaldo Airport. That will likely be the message awaiting passengers in the Madeira Islands when the local airport is renamed after the local star.

Ronaldo is expected to attend a ceremony at the airport outside his hometown of Funchal today, a day after his Portugal side plays Sweden in the city in a friendly.

It will be the first time Ronaldo plays with the national team in the city where he grew up. Funchal also features a Ronaldo statue, a museum about him, and a hotel complex named after him.

"This game is a great tribute to the people of Madeira, they deserve it," Ronaldo said on the Portuguese Football Federation website.

Portugal's squad landed on Monday at the airport, displaying the trophy it won at the 2016 European Championship in France.

A sign with the player's image was already being added to the facade of the airport, which until yesterday was called the Madeira International Airport.

The name change at the airport, known as one of the windiest in the world, attracted a lot of attention locally, with some politicians opposing it and saying that the footballer's name should be added to a stadium or another sporting venue. Some

said the Madeira regional government didn't have the legal right to make the name change without consulting the main government.

Ronaldo is regarded as a promoter of Madeira, which is considered one of the world's top travel destinations. A couple of years ago, he used his social media accounts to ask fans to vote for Madeira in a contest organized by the travel industry. The islands southwest of Portugal are known for their incredible landscapes, and their wine is known worldwide.

The islands are about 500 kilometers (310 miles) from the African coast, and some 1,000 kilometers (620 miles) from the European continent.

Ronaldo grew up in Funchal sharing a room with his older brother and two older sisters before moving to the mainland to join the youth squads of Sporting Lisbon. From there he made it to Manchester United and eventually to Real Madrid, becoming one of the world's biggest soccer stars. He received his fourth world player of the year award this year.

Last year, vandals painted Lionel Messi's name and jersey number on Ronaldo's statue after Messi received the world player prize.

The statue was unveiled in 2014 in the presence of Ronaldo and his close relatives. His family is also expected to attend the airport today. **AP**

THE BIGGEST RISK FROM THE **DOLLAR'S DROP MAY NOT BE** WHAT YOU WOULD GUESS

A high-risk corner of the USD5.1 trilliona-day currency market has become the collateral damage of the dollar selloff.

Whipsawed by the greenback and confronted by U.S. policy confusion, carry trades were supposed to be a rare bright spot for investors who want to stay away from the world's biggest reserve currency. Under the strategy, you borrow in low-rate alternatives such as the yen, and buy high-yielding peers like the Mexican peso, benefiting from low volatility and the emerging-market rally.

Practitioners of the carry trade are learning there's no hiding from the dollar's influence. Growing doubts about the outlook for U.S. policy following the failed attempt at health-care reform not only led to a weaker dollar, it also caused investors to pile into havens such as the yen and the euro - the funding currencies carry traders sell as part of the strategy. The Japanese currency gained 2.2 percent against the dollar this month, while the euro rose 2.7 percent.

"The carry trade is far more important than the dollar move in the changing the currency market," said Bob Savage, chief executive officer of hedge fund CCTrack Solutions LLC in New York. "The rise in the yen may actually put the trade at risk. The dollar itself doesn't affect the biggest FX trade out there, but the yen does.3

There's no hard evidence available in analyzing the scale of carry trades. But according to Bank of America Corp.'s flow data, buying emerging-market currencies made up the biggest long position as of last week. The data blend positioning and sentiment surveys conducted with its hedge fund and real-money clients, and publicly available futures data.

Nonetheless, carry traders could still make a profit because of yield differentials or appreciation in emerging-market currencies. At a time when most investors have capitulated on the strong-dollar bet and currency funds struggle to yield any return for yet another year, the carry strategy may be the last oasis.

In fact, the trade is still worth it even though the funding leg of the trade goes south, according to Societe Generale SA, and investors should buy currencies such

CARLOS THE JACKAL' SENTENCED TO UZ LIFE FOR 1974 ATTACK

The man known as "Carlos the Jackal" has been convicted in a French court of a deadly 1974 attack on a Paris shopping arcade and sentenced to life in prison for the third time.

The Venezuelan-born Ilich Ramirez Sanchez is already serving two life sentences in France for murders and attacks he was convicted of perpetrating or organizing on behalf of the Palestinian cause or of communist revolution

in the 1970s and '80s.

As the trial wrapped yesterday, the 67-yearold known worldwide as "Carlos" denounced "an absurd trial" for a 42-year-old crime. Carlos had denied involvement, saying there was no proof against him.

Five judges found Carlos, the only defendant, guilty of throwing a grenade onto a shopping area, killing two and injuring 32.

American Airlines buys stake in China Southern Airlines

MERICAN Airlines has Agreed to pay USD200 million for a stake in China Southern Airlines, the biggest of China's three major stateowned carriers, in a bid for a bigger share of the country's growing travel market.

American and China Southern will expand commercial cooperation, possibly in sales, airport facilities and code-sharing, the Chinese airline said in an announcement yesterday through the Hong Kong stock exchange. It said the deal represents 2.76 percent of China Southern's shares and requires regulatory approval.

Foreign carriers are forging steadily closer ties with Chinese airlines to gain a bigger share of China's air travel market, which is growing strongly while travel in Europe and North America is leveling off. In exchange, Chinese carriers get access to

experience and management skills.

China is forecast to pass North America over the next two decades as the biggest air travel market.

China's economic growth is slowing but tourism spending is rising as communist leaders encourage growth of service businesses in an effort to reduce reliance on heavy industry.

Chinese spending on air travel rose 10.6 percent in 2015, compared with 1.7 percent in the United States, according to the International Air Travel Association.

Two years ago, Delta Airlines paid \$450 million for 3.55 percent of China Eastern Airlines. The third major U.S. carrier, United Airlines, has a partnership with Air China, the third major Chinese government-owned airline. Hong Kong-based Cathay Pacific Airlines owns 18 percent of Air China.

Regulators in both China


and the United States are reluctant to allow large foreign ownership stakes or management control of their airlines.

China Southern, headquartered in Guangzhou, near Hong Kong, is China's biggest carrier by passenger volume but is known for sometimes haphazard service, with flights delayed or canceled with little notice.

China Southern says it operates more than 2,000 flights a day to 224 destinations in 40 countries and regions in Asia, Europe, North America and Africa. It says it carried 115 million passengers in 2016.

The partnership with American Airlines "is expected to provide continuous impetus for the company's long-term growth," said China Southern's announcement.

American, headquartered in Fort Worth, Texas, says it operates 6,700 flights a day to nearly 350 destinations in more than 50 countries. AP
