Property expert calls for easing of license acquisition

CQUIRING operation li-Accenses remains a challenge for business operators keen on starting a firm in the region.

Real estate expert Oliver Tong called on the government to address the issue, noting that it should provide a degree of flexibility when it comes to licensing and even construction permits. Speaking yesterday on the sidelines of the annual business talk of the American Chamber of Commerce, British Business Association of Macao and the France Macau Chamber of Commerce, Oliver Tong, senior director and head of leasing at Jones Lang LaSalle said a number of clients at the firm had encountered licensing dilemmas.

Tong remarked that Macau has been actively promoting diversified development of tourism and different industries, which has attracted much attention from overseas operators. However, Macau's complicated laws, regulations and license application procedures have made them move back and give up their plans.

"Sometimes for food and beverages or supermarkets, it can take three to four months before you get the license ready. In those three to four months, they have to pay rent, so they are paying it for nothing [and] that is the very big challenge for [business owners]," Tong told the Times.

"[Licensing procedures] definitely need to be more effective, otherwise many international brands and retailers would say

that it is much easier in Hong Kong [so they may] focus on Hong Kong instead," he added.

The senior director noted that some operational licenses can take up to nine to 12 months before being ready to fully open a firm.

The expert made such comments on the food and beverage sector as it had showed steady growth, mentioning the opening of franchise stores such as Lady M, The Cheesecake Factory and Hey Tea amongst others.

"The other issue is human resources. This deserves more attention from the government because getting enough people to work for them is not easy, and getting foreign quotas is another challenge. It's always very tight," Tong commented in regards to other issues the retail sector faces.

"On the landlords' side, honestly speaking, I don't think they are open minded enough to accept new concepts. [...] They are not open minded and are just focused on developing traditional retail [firms]," he added. With the increasing supply of retail leasing space in Macau, it is forecasted that over 1 million square feet of retail space will enter the market in 2019.

According to 2019 predictions, a downward adjustment in retail rental costs is expected, yet at the same time, lower rental costs will create opportunities for experiential entertainment operators, such as VR game centers, trampoline parks, cinemas and food and beverage businesses amongst others.

Furthermore, when questioned over whether local residents are leaning towards purchasing real estate developments in Henggin, Tong noted that current policies and regulations are not yet attracting local residents to purchase apartments in the region.

"Hengqin always takes time. I don't think all the required policies are in place right now to attract tenants. Most build infrastructure and big buildings but in terms of software it is [still lacking]," Tong explained.

"I think it is happening progressively but not everything is ready. [...] It will take five to ten years at least," he added.

New sevices base well entrenched and 'here to stay'

AG Aviation, a private and business aviation services firm, has chosen Macau for its first fixed base operation in the Asia-Pacific region. Joining three existing operations in Farnborough, Geneva and Sion, the new base will provide business aviation services, including onsite customs and immigration clearance, flight planning and chartering, and aircraft maintenance and servicing.

It opened only a few weeks ago, but at a visit to the TAG Macau office this week the Times learned that the operation is already well entrenched.

Business aviation is flying high in China and global players are keenly eyeing the market. Forty percent of TAG's clients come from the Southeast Asia and mainland China region, according to a representative of the company, and despite having just opened the fixed base operation, the upcoming Chinese New Year has generated "more business than we expected."

That might be the case, but with a Hong Kong presence since 2006, Macau has long been on TAG's radar. In fact, company representatives said that TAG had scouted Macau as an expansion opportunity over a decade ago and were aware of the city's potential.

"We identified Macau as a good opportunity," said Jolie Howard, chief executive officer at TAG Aviation Asia. "When TAG first started operating [in Asia], we actually came to Macau to see if there was space for us. That was 12 years ago."

At that time there was just a single concession in Macau for a fixed base operation and fewer than 1,000 general and business flight movements.

Little over a decade later and the airport business is booming. The Macau International Airport recently opened the north extension to the passenger terminal building, with plans for the south extension scheduled to begin soon. General and business flight movements today exceed 3,100, according to latest information released by the Civil Aviation Authority, while local aviation authorities are projecting passenger traffic will climb to 8.7 million in 2019, following a 15 percent rise last year.

When TAG revisited Macau about two years ago, the company learned that the local government wanted to open up aviation services to international players in order to accommodate the fast-growing business at the airport. The firm decided to bid for a new concession providing ground handling services for private jets.

In Howard's words, TAG "saw the potential in Macau."

"We chose Macau because of the government's attitude, which is welcoming to general aviation," she explained. "It's good that the airport [authority] recognizes the need to expand as that will help with the development of Macau as a destination."

Rita Tam, who oversees the local arm of TAG as general manager of the Macau fixed base operation, said that according to her understanding of the Macau International Airport master plan, aviation authorities intend supply in neighboring Hong Kong, where the firm operates in aircraft operations support and maintenance services.

"In Hong Kong we have a lot of business, but the [problem] is a lack of parking space for airplanes," said Tam, adding that infrastructure improvements in Macau could prove the impetus to promote the local business aviation sector.

Indeed, the added space is a necessity for TAG as a business aviation firm that needs to be flexible in the services it provides to clients.

According to Howard, "we have to be more flexible [than commercial airlines] because we have to adapt to the individual owners. We don't know where they are going to want to fly, we can't predict that. We have to be like a limousine, and that's different to what the [commercial] airlines do."

Howard and Tam are optimistic about the future of the Macau International Airport. They said that the expansion projects are a good sign of local authorities' commitment to the development of the aviation sector, and that their new fixed base operation will help to build a presence in the Asia-Pacific business aviation market for both TAG and Macau.

"We certainly look at Macau from a long-term growth perspective over the next 10 to 15 years," nodded Howard. "We are expanding our footprint in this part of the world and we are here to stay."

198 extra flights approved for CNY



THE Civil Aviation Authority of Macau (AACM) has approved a total of 198 extra regular and charter flights to allow airlines to increase their capacity to meet the air transport demand for the 2019 Chinese New Year. The extra flights are to and from mainland China, Taiwan Vietnam, Thailand and Japan. The extra and charter flights have already been in operation since January 21 and will end on February 28. The operators of these flights are Air Macau, Juneyao Airlines, China Eastern Airlines and East Asia Airlines. The flights are destined to mainland China (151 flights to and from Shanghai, Wanzhou, Chengdu, Changzhou, Zhengzhou and helicopter services linking to Shenzhen); Taiwan (25 flights to and from Taipei); Vietnam (10 flights to and from Danang); Thailand (8 flights to and from Bangkok); Japan (4 flights to and from Osaka and Sapporo). The number of flights for the 2019 Chinese New Year has increased by 150 percent compared with the number in 2018. to build more airplane parking spaces in the coming years. TURKISH AIRLINES STILL WORKING ON ISTANBUL ROUTE

THE MACAU International Airport Company (CAM) said it is still working on a deal with Turkish Airlines to establish a longhaul flight connecting Macau with Istanbul. If successful, the airline would be allowed to carry both passengers and cargo. A long-haul connection between Macau and a European flight hub has long been anticipated in the MSAR, with various proposals having been made in recent years. At a Media Spring Dinner held last week, CAM's Director of Airport Operation Antonio Barros said that the airport was working toward establishing such routes that would open up connectivity to Europe. Currently, there are connections between Macau and Moscow, as well as plans to explore route development for the Indian subcontinent.

Yao also revealed that in 2019, Zhuhai will work with Macau and Hong Kong to launch a HKZMB sightseeing tour, which will include the bridge and sea tourism projects.

Additionally, the city places great importance on cooperating with Macau in promoting the construction of Hengqin's cross gate central business district.

According to Yao, regardless of the height and content of the buildings at the cross gate central business district, they must be connected with Macau, and they must promote the diversification of Macau's industry.

BNU profits fell 17 percent

THE profits of Banco Nacional Ultramarino (BNU) fell by 17 percent in 2018 when compared with 2017. The figures came from an analysis of the bank's Annual Trial Balance, published yesterday in the government's Official Gazette (BO).

According to the final balance sheet that closed the 2018 calendar year, dated to December 31, the banking institution made earnings that amounted to MOP585 million, a significant drop from the MOP706 million made in 2017.

Although the bank had been registering lower performance throughout the year, the drop was significantly larger in the second half of 2018.

To recall, the half-yearly bank results, which were made public in August 2018, already showed a 3.1 percent drop in profits. The situation was then aggravated during the second half of 2018, when BNU only achieved 46.9 percent of its annual results.

Noting the final total results, BNU recorded costs totaling MOP1.1 billion, making their total income MOP1.7 billion.



Tourism Tour groups above 9m benchmark in 2018

Visitors on package tours totalled 9,096,000 in 2018, up by 5.5 percent year-on-year, with those from mainland China (7,103,000), South Korea (616,000) and Taiwan (696,000) recording increases of 2.6 percent, 28.3 percent and 53.8 percent respectively.

According to information released yesterday by the Statistics and Census Service (DSEC), in 2018, guests at ho-tels and guesthouses reached 14,107,000, up by 7.2 percent year-onyear. Guests coming from mainland China rose by 12.5 percent to 9,717,000, whereas those from South Korea (484,000), Hong Kong (1,515,000) and Taiwan (477,000) dropped by 3.4 percent, 5.9 percent and 3.2 percent respectively. The average occu-



pancy rate of hotels and guesthouses went up by 3.9 percentage points year-on-year to 91 percent, with 5-star hotels leading at 92.4 percent, an increase of 4.6 percentage points. The average length of stay held steady year-on-year at 1.5 days.

In 2018, outbound residents using services of travel agencies totalled year-on-year.

1,579,000, up by 13.5 percent year-on-year. The number of residents travelling on package tours decreased by 6.1 percent to 527,000, with those visiting mainland China rising by 2.4 percent to 385,000.

In December, group visitors reached 917,000, up by 2.3 percent monthto-month and 1.6 percent year-on-year.

Duterte's ban clouds Philippines' casino push, regulator says

THE Philippines' gaming L chief said she will ask President Rodrigo Duterte to relax a ban on new casino licenses as the nation risks losing out on a gaming boom for which its Asian neighbors are lining up.

A moratorium on new casino licenses that took effect in January 2018 could drive away gaming investments, Andrea Domingo, the head of the state gaming regulator said in an interview on Tuesday in Manila. She hoped Duterte can be persuaded to implement a selective ban when she meets the president as early as this week.

"Gaming seems to be the sunrise industry now in Asia," Domingo said. "There are still areas in the Philippines that can still absorb and benefit

from these investments, which won't go here with the current ban.'

Domingo's efforts are aimed at ensuring the nation has a shot at becoming a regional gaming hub despite Duterte's decision to halt new casino approvals. While Philippines has shut its doors, others such as Japan, Vietnam, Cambodia and Myanmar have been aggressively raising their game.

"It's better to be discerning in giving new licenses rather than a complete ban," said Rick Santos, chairman at real estate consultant Santos Knight Frank. Domingo sees casinos as a tourism magnet and recommends banning them in areas not accessible for foreign travelers since that would encourage the locals to gamble. **Bloomberg**



T'S been a mournful start to 2019 for two of Asia's richest families. Eka Tjipta Widjaja, who began as a coconut and palm-oil trader at age 15 before building a multibillion-dollar empire in Indonesia, died Saturday at 98. A week earlier, Henry Sy, a shoe salesman who became the wealthiest man in the Philippines, died at 94. Their combined fortunes exceeded USD16.5 billion.

It's no coincidence that the world's richest people are also some of the oldest as it can take a long time to amass extraordinary wealth. About a fifth of the 500 people on the Bloomberg Billionaires Index are at least 80 years old, and 21 are nonagenarians, including eight from Asia with a combined net worth of \$125 billion. That's setting the stage for one of the most concentrated transfers of wealth in history.

"More and more families are thinking of succession," said Peng Qian, associate director of the Tanoto Center for Asian Family Business and Entrepreneurship Studies of Hong Kong University of Science and Technology. "We expect huge demand from Asia's richest for private wealth-management services in the next few years."

When a billionaire dies, it can

go at least two ways. An orderly split of assets or a battle royal among infighting heirs.

Sy attempted to adopt the first approach. He was worth \$7.2 billion when he died after giving stakes in his SM Investments Corp. to his six children more than a decade ago, making all of them billionaires.

Li Ka-shing retired from CK Hutchison Holdings Ltd. and CK Asset Holdings Ltd. last year, with his son Victor taking over the conglomerate. He recently brought in his 23-yearold granddaughter Michelle Li to the board of Chesterfield Realty Inc., a family-controlled unit of CK Hutchison Holdings.

For other scions of ultra-wealthy families, it can mean intense struggles for who will take control. Stanley Ho, 97, split most of his fortune among his wives and children in 2011 to settle a family dispute, but members of Ho's family, including his eldest daughter Pansy, are still embroiled in a decade-long battle for his Macau casino empire. **Bloomberg**





Ghosn says arrest due to plot within Nissan

NISSAN'S former chairman Carlos Ghosn, in his first interview since his arrest in November, blamed fellow executives opposed to forging closer ties with the automaker's French alliance partner Renault for scheming against him, the Japanese newspaper Nikkei reported yesterday.

The financial daily said it spoke with Ghosn for 20



month and remains in Tokyo.

Authorities have rejected Ghosn's requests for bail, saying he might tamper with evidence or possibly flee.

Ghosn told the Nikkei he had no intention of fleeing and wants to defend himself in court. But he questioned why he could not gain release on bail.

"I don't understand why I am still being detained," he was quoted as saying, adding he could not tamtors Corp. with Nissan's CEO, Hiroto Saikawa, in September.

The plan was to bring Nissan, Renault and Mitsubishi Motors closer together and ensure they had "autonomy under one holding company," he told the newspaper.

Nissan dismissed Ghosn as chairman shortly after his arrest. He was also dismissed as chairman of Mitsubishi. Earlier this month, he resigned as chairman and CEO of Re-

minutes earlier in the day at the Tokyo Detention Center, where the 64-yearold star executive has been held since Nov. 19.

Earlier, Ghosn only was allowed visits by his lawyers and embassy officials.

Prosecutors have charged Ghosn with falsifying financial reports in underreporting his compensation. He has also been indicted on charges of breach of trust related to his handling of investment losses and to payments made to a Saudi businessman.

In the interview, Ghosn reiterated his insistence

that he is innocent and said others in the company schemed to force him out with a "plot and treason."

"People translated strong leadership to [mean] dictator, to distort reality," he told the Nikkei. It was for the "purpose of getting rid of me," he was quoted as saying.

Nissan Motor Co. defended itself, saying prosecutors took action following an internal investigation set off by whistleblowers in the company.

"The sole cause of this chain of events is the mis-

conduct led by Ghosn and Kelly," company spokesman Nicholas Maxfield said. He was referring to Greg Kelly, another executive who has been charged with collaborating with Ghosn in underreporting his compensation. Kelly was released on bail last per with evidence because "All the evidence is with Nissan."

The newspaper said Ghosn did not appear tired or flustered and when asked about his health, he said he was "doing fine."

"In life there are ups and downs," the newspaper quoted him as saying.

Renault SA owns 43 percent of Nissan. It sent Ghosn to Japan in 1999 to help lead the Japanese automaker's turnaround from near bankruptcy. Ghosn said he had discussed a "plan to integrate" Nissan with Renault and their smaller alliance partner Mitsubishi Monault and was replaced by Jean-Donimique Senard, the former chairman of Michelin.

Ghosn refuted various allegations against him, saying most of the alleged violations were approved by Nissan's legal department or other senior executives.

He also denied any wrongdoing in buying expensive homes in Brazil and Lebanon, saying he needed a safe place to work and meet with people. The homes were no secret and if they had been a problem, he should have been consulted, Ghosn said. **AP**

TIMELINE: THE BATTLE OVER HUAWEI

DEC. 1: Canada arrests Huawei Chief Financial Officer Meng Wanzhou, the daughter of the company's founder, at America's request on a stopover at Vancouver airport. The U.S. is reported to be investigating Huawei's use of a Hong Kong shell company to sell equipment to Iran in violation of U.S. sanctions. The same day, President Donald Trump and President Xi Jinping meet in Argentina and announce a cease-fire in the U.S.-China trade war.

DEC. 6: A Chinese government statement says Meng broke no U.S. or Canadian laws and demands her immediate release. Canadian Prime Minister Justin Trudeau says Canada has an independent judiciary that will decide Meng's case "without any political involvement or interference."

DEC. 8-9: China summons Canadian Ambassador John McCallum and U.S. Ambassador Terry Branstad on successive weekend days to warn of "grave consequences" if Meng is not released and demand the U.S. cancel its order for her arrest.

DEC. 10: Two Canadians are detained separately in China in an apparent attempt to pressure Canada to release Meng. Former diplomat Michael Kovrig and Michael Spavor, who runs tours to North Korea, are taken into custody on suspicion of engaging in activities that endanger national security.

DEC. 11: Meng is released on bail of 10 million Canadian dollars (USD7.5 million), and Trump tells Reuters that he might intervene in her case "if I think it's good for what will be certainly the largest trade deal ever made." Meng is required to wear an ankle monitor, surrender her passports and stay in one of her two Vancouver homes from 11 p.m. to 6 a.m.

DEC. 21: Canada makes a formal demand for the release of Kovrig and Spavor. Foreign Minister Chrystia Freeland says "we are deeply concerned by the arbitrary detention by Chinese authorities of two Canadians earlier this month and call for their immediate release."

JAN. 14: A Chinese court sentences Canadian Robert Lloyd Schellenberg to death in a drug smuggling case, overturning his 15-year sentence from November. Trudeau suggests that China trying to pressure Canada and says that "all countries around the world" should be concerned about Beijing's arbitrary use of its judicial system.

JAN. 15: China expresses strong dissatisfaction with Trudeau's criticism of the death sentence. Foreign ministry spokeswoman Hua Chunying says the Canadian leader should "respect the rule of law, respect China's judicial sovereignty, correct mistakes and stop making irresponsible remarks."

JAN. 16: Huawei founder Ren Zhengfei, who is Meng's father, tells foreign reporters that Huawei obeys the law, including export restrictions, wherever it operates. "We are sure there will be a just conclusion to this matter," he says.

JAN. 22: China demands the U.S. withdraw its arrest warrant for Meng and not make an extradition request. Hua, the foreign ministry spokeswoman, says Canada's extradition treaty with the U.S. infringes on the "safety and legitimate rights and interests of Chinese citizens."

For US-China talks, hopes are high, expectations low

U.S. and Chinese negotiators start two days of high-level talks today [Macau time] aimed at settling a six-month trade war that has weakened both sides, shaken financial markets and clouded the outlook for the global economy.

Yet the odds seem stacked against any substantive resolution this week to the standoff between the world's two biggest economies. Perhaps the best that might be hoped for, analysts say, is for the two sides to agree to keep talking.

The differences between Beijing and Washington are vast. The United States is essentially demanding that China downsize its economic aspiration to become a supreme world leader in such fields as robotics and electric cars.

"A comprehensive deal that fundamentally changes their system - I don't think that's possible," said Christopher Adams, a former U.S. trade official specializing in China and now a senior adviser at the law firm Covington. Earlier negotiations flamed out. And this time President Donald Trump might be inclined to drive an especially hard bargain after being forced to cave in a dispute with congressional Democrats that partially shut the federal government for 35 days.

Moreover, a new complication injected itself into U.S.-China relations on the eve of the talks when the Justice Department brought criminal charges earlier this week against the Chinese tech giant Huawei, accusing it of stealing technology secrets and violating sanctions against Iran. Beijing shot back by demanding that the Trump administration pull back from what it called an "unreasonable crackdown" on the Chinese maker of smartphones and telecom gear. "We are anticipating no big outcomes this week," said Erin Ennis, senior vice president at the U.S.-China Business Council. A deadline looms. On March 2, the Trump ad-



ministration is scheduled to escalate its tariffs on USD200 billion worth of Chinese imports from 10 percent to 25 percent.

The American delegation to this week's talks is led by Trade Representative Robert Lighthizer, a longtime critic of aggressive Chinese trade practices and of U.S. policies that failed to blunt them. Heading the Chinese team is Vice Premier Liu He.

The core of the U.S. allegations against China is that Beijing systematically steals trade secrets, forces foreign companies to hand over technology as the price of access to the Chinese market and subsidizes its own tech companies.

But compelling China to reform its trade policies and treatment of foreign companies will be difficult.

"The idea of just grab-

in Chinese goods. If he did, Trump's import taxes would cover virtually everything China ships to the United States.

Last spring, it looked as if the two sides might avoid a full-blown conflict. Treasury Secretary Steven Mnuchin declared the trade war "on hold" after China had agreed to step up its purchases of U.S. goods, especially in agriculture and energy, and narrow America's huge trade deficit with China. The cease-fire didn't last. Critics dismissed Beijing's commitments as vague, and Trump backed away from Mnuchin's deal and decided to proceed with tariffs.

The trade war has magnified uncertainties for businesses, raised priced in some sectors and unsettled investors. Pointing to the U.S.-China conflict, economists at the International Monetary Fund, the World Bank and the Organization for Economic Cooperation and Development have downgraded their forecasts for global growth. The Dow Jones Industrial Average is down more than 8 percent since early October, though it has rebounded since Christmas. The Chinese economy is decelerating, having expanded last year at its slowest pace since 1990. U.S. officials and some analysts say they believe its weakening economy will pressure the Chinese into making concessions. "The economic circumstances are a powerful

bargaining tool," DeBusk said.

But she added that "the Chinese slowdown also impacts the United States." Indeed, U.S. heavy equipment maker Caterpillar reported that its China sales were slowing — news that sent its stock price tumbling.

Deepening the challenge is the U.S. view that China has pledged in the past to curb cyber-theft and forced transfers of technology — and then failed to do so. Lighthizer is sure to insist that any agreement be enforceable.

"The odds of them stonewalling and rope-a-doping in this meeting are close to zero," said Robert Atkinson, president of the Information Technology and Innovation Foundation think tank. "What are they going to put on the table? Are they going to put tidbits on the table, or they going to put

"You can't just flip a switch" and expect China to drop long-established practices.

The Justice Department's decision to charge Huawei, meanwhile, "has thrown a curveball" into the talks, said Patrick Chovanec, chief strategist at Silvercrest Asset Management Group.

U.S. officials insist that the Huawei case is entirely separate from the trade negotiations. But Atkinson said he thinks the Huawei indictment was meant to send a signal to the Chinese.

"This is about power politics," he said, "to get them to do what they should be doing." **AP**


Powerful Illinois speaker recorded in probe involving Chinese developer

Chicago newspaper reported that a lengthy federal court affidavit says the FBI secretly recorded Illinois' powerful House speaker in 2014 discussing a hotel development project and the possibility of its Chinese developer becoming a client of the speaker's private law firm.

The Chicago Sun-Times report on Michael Madigan, a formidable powerbroker in Illinois for decades, suggests a federal investigation may cast a much wider net than first thought after it led to an attempted extortion charge earlier this month against an influential Chicago alderman, Ed Burke.

Madigan, a 76-year-old Chicago Democrat, is the longestserving current speaker of a Statehouse in the U.S. He has held the post almost continuously since 1983. The recent swearing in of Democratic Gov. J.B. Pritzker only boosted Madigan's influence by ending four years of divided government with Republican Bruce Rauner at the helm of state.

In a statement to the Sun-Times, a Madigan attorney, Heather Wier Vaught, denied any wrongdoing by the speaker, adding neither he nor his law firm is under investigation to their knowledge. In none of the alleged Madigan comments cited by the Sun-Times does the speaker say he'd exchange official action for new legal business. The newspaper doesn't cite the affidavit as saying Madigan was ever an investigative target or faced any prospect of being charged.

The 120-page court affidavit obtained by the Sun-Times says an associate of the Chinese developer recorded Madigan during an Aug. 18, 2014, meeting at Madigan's downtown Chicago law office about the proposed hotel in the city's Chinatown neighborhood. It was never built, though developers did secure requisite zoning approval from the City Council.

The newspaper does not provide details about how it obtained the affidavit.

During the meeting, Madigan

allegedly said to the developer about his Madigan & Getzendanner law firm that "our interest would be that we represent buildings like that on the real estate taxes." A Madigan's law partner also explained, through the associate, who translated for the developer, that its fee would be 12.5 percent of any tax savings or a fixed annual fee of between USD3,000 to \$3,500, the newspaper reported.

The Sun-Times report says the 2014 meeting was arranged by Alderman Danny Solis, whose ward included the would-be hotel's location. The newspaper has previously reported Solis, a chairman of the City Council's zoning committee, was cooperating with a federal corruption investigation, including by secretly recording Burke. Yesterday [Macau time], Mayor Rahm Emanuel's office announced Solis has resigned as the head of the zoning committee. It offered no detailed explanation, but did include a brief statement from Emanuel saying Solis "recognized that he cannot effectively preside over the matters before" the committee.

Charging documents in Burke's case focus on his private law firm and accusations he tried to squeeze the owner of a Burger King franchise for legal business in exchange for city construction permits. Burke, who has personified Chicago machine politics for decades, is charged with one count of attempted extortion and has denied any wrongdoing.

The Sun-Times says the developer's associate telephoned Alderman Solis three days after the sit-down meeting with Madigan to tell the alderman the developer had agreed to hire Madigan's law firm. But neither the associate nor the developer signed a retention deal with the law firm by the time the 2016 affidavit was composed, the Sun-Times reports.

The Madigan attorney added that, if it was true that some of the speaker's conversations were recorded, Madigan was unaware of it and "has no concern if they were." She added Madigan "has no recollection of ever suggesting that he would take official action for a private law firm client or potential client."

Solis has not been charged. And he has previously denied cooperating with federal investigators or secretly recording others on their behalf.

Burke has also denied any wrongdoing in his criminal case.

A spokesman for the U.S. attorney's office in Chicago, Joseph Fitzpatrick, declined any comment. AP

THINA has banned the wife of a Taiwanese human rights activist jailed in China from visiting him for three months due to alleged improper behavior, a government spokesman said yesterday.

Lee Ching-yu made false statements and "interfered with prison operations" during and after a visit last month with her husband Lee Ming-che, the spokesman for the Cabinet's Taiwan Affairs Office, Ma Xiaoguang, said at a regularly sche-

seeking to extend its intolerance to criticism even outside its borders. The party allows no challenges to its authority and claims sovereignty over Taiwan, a freewheeling democracy with personal and political freedoms largely unknown on the mainland.

Protesters mourn death of wartime sex slave who fought Tokyo

Kim Tong-Hyung, Seoul

A South Korean woman who was forced as a girl into a brothel and sexually enslaved by the Japanese military during World War II was mourned yesterday by hundreds of protesters who demanded reparations from Tokyo over wartime atrocities.

Kim Bok-dong had been a vocal leader at the rallies that have been held every Wednesday in Seoul for nearly 30 years. She died on Monday at a Seoul hospital where she had been receiving treatment for cancer. She was 92.

On a street near where the Japanese Embassy used to be, protesters gathered around a bronze statue of a girl representing Korean sexual slavery victims and held a moment of silence for Kim. Many of them held signboards with Kim's photos and words including, "We will never forget the life of Kim Bok-dong" and "Japanese government, apologize!"

Kim was one of the first victims to speak out and break decades of silence over Japan's wartime sexual slavery that experts say forced thousands of Asian women into front-line brothels. She traveled around the world testifying about her experience, including at the United Nations World Conference on Human Rights in 1993 and at a U.N. Human Rights Council panel in 2016. Of the 239 Korean women who have come forward as victims, only 23 are still alive.

"We do not have much time left to spend with them," said Lee Seong-rim, one of the protesters, who said it would be "miraculous" if the Japanese government ever fully acknowledges accountability over the sexual slavery of Korean women.

South Korean President Moon Jae-in, who visited an altar set up for Kim at a Seoul hospital on Tuesday, said in a statement that Kim devoted her life to "restoring human dignity" and that her campaigning gave South Koreans

a "braveness to face the truth." According to Yoon Meehyang, who heads an activist group representing South Korean victims of Japan, Kim was dragged away from home at the age of 14 and forced to have sex with Japanese soldiers at military brothels in China, Hong Kong, Malaysia, Indonesia and Singapore from 1940 to 1945. She came forward as a victim in 1992, a year after Kim Hak-sun became the first South Korean woman to identify herself as a former sex slave.

"I am a victim of the Japanese military's comfort women system and I stand in front of the Japanese embassy every Wednesday fighting for the restoration of our honor and dignity, but I also know too well the pain of women all around the world who are currently suffering from wartime sexual violence," Kim Bok-dong said in 2012 as she launched the "Butterfly Fund" for helping victims of wartime sexual abuse with another former Korean sex slave, Gil Won -ok.

A 1991-1993 Japanese government investigation concluded that many of the women were recruited against their will, leading to a landmark Japanese apology. The investigation found no written proof in official documents, however, and conservatives in Japan have cited that in arguing the women were not coerced. Many South Koreans say past apologies didn't go far enough.

Kim's death comes as relations between South Korea and Japan have sunk to their lowest point in years over what South Korea says is Japan's refusal to fully acknowledge the suffering of the so-called "comfort women" during WWII and of forced Korean laborers during its colonial rule of the Korean Peninsula from 1910 through 1945.

Moon's government in November announced plans to dissolve a foundation founded by Japan to compensate South Korean sexual slavery victims, which if carried out would effectively kill a controversial 2015 agreement between the countries to settle a decades -long impasse over the issue.

Many in South Korea believed that Seoul's previous conservative government settled for far too less in a deal where Tokyo agreed to fund the foundation with 1 billion yen (\$9 million). There's also criticism that Japan still hasn't acknowledged legal responsibility for atrocities during its colonial occupation of Korea. **AP**

Bangkok shuts hundreds of schools as toxic haze shrouds city



THAI officials shut hundreds of schools in Bangkok yesterday as some of the world's most toxic air hung over the city.

The metropolis of about 10 million people closed 437 government schools until tomorrow, its local authority said, prompting private institutions to follow suit. The air quality index, or AQI, was around 170 in the afternoon, the fourth-worst major urban reading globally, according to data from AirVisual, which tracks pollution levels.

Prime Minister Prayu-

th Chan-Ocha, leader of Thailand's military government, said he's seeking temporary closure of some factories during pollution spikes to tackle the problem. He added that he's ordering soldiers to inspect and report back on the worst polluters.

"In the short-term, shutting down factories may mean accepting some economic damage, but protecting public health must be the utmost priority," said Kakuko Nagatani-Yoshida, the UN Environment Programme's regional coordinator for chemicals, waste

and air quality.

Bangkok is grappling with a severe seasonal deterioration in air quality for the second year in a row. Officials have faulted exhaust fumes, industrial emissions, construction dust, rubbish burning and smoke from rural regions, as farmers burn crops to clear fields.

The city has resorted to desperate measures to try and clear the visible gray haze, including spraying water off skyscrapers and flying rainmaking sorties to wash away the pollution, but with little success. "The state has come out with short-term measures but they don't fix the root causes," Sivalai Khantachavana, a researcher at Siam Commercial Bank, wrote in a report. Officials need to take steps such as limiting the number of polluting vehicles as well as restricting trash and crop burning, she said.

The smog spike is unwelcome for a city that relies on tourism for economic growth. Bangkok received more then 20 million international overnight visitors in 2017, the highest such figure in the



world, a Mastercard Inc. gauge shows.

The gray mist - including tiny, toxic PM2.5 particles that penetrate deep into the lungs and enter the bloodstream - has descended on the capital at a sensitive time.

A general election is due

in March, more than four years after Prayuth seized power in a coup. He's signaled he may ally with a political party and try to return as premier. Junta opponents have said the thickening smog is an example of the administration's failings. **Bloomberg**

HINESE President Xi Jinping already had plenty of reasons to rethink his grand plan to build railways, ports and other infrastructure across the globe. Malaysia has given him 20 billion more.

The Malaysian government's move to cancel a China-financed high-speed rail link across the Malay Peninsula raised new questions about Xi's so-called Belt and Road Initiative. The cabinet decided the USD20 billion project was "beyond the government's financial capability," Economic Affairs Minister Mohamed Azmin Ali said Saturday, previewing a move that could be formally announced by next week.

The deal's collapse adds urgency to a debate already growing in Beijing about the potentially \$1 trillion program, the main engine of Xi's effort to convert China's economic might into global influence. In recent months, countries across Asia have suspended, scaled back or terminated projects amid concerns over corruption, influencepeddling and rising debt.

"We are seeing more backlash and challenges," said Pang Zhongying, an international relations professor at Macau University of Science and Technology. "China needs to draw conclusions from its experience and absorb the lessons from the all these incidents, because the external landscape is changing rapidly and its internal economic challenges looming."


Xi will have a chance for a reset in April, when he is expected to convene leaders in Beijing for his second BRI summit. In September, the Chinese president promised African nations he wouldn't pursue "vanity projects," and last month the country's top regulator of stateowned enterprises published a report calling for greater "overseas social responsibility" in investments.

link, and warned against a "new version of colonialism" during a trip to Beijing.

Skepticism about Beijing's intentions was fed by a Wall Street Journal report earlier this month that Malaysia was investigating whether China offered to bail out 1MDB in exchange for infrastructure deals. Mahathir struck a conciliatory tone on Tuesday, saying the government's reason for canceling the rail was simply a lack of funds. "Concern about its development model, Malaysia's high debt and allegations of impropriety around 1MDB all weighed on this decision," said Oh Ei Sun, a senior fellow at Singapore Institute of International Affairs. Beijing was learning that its model of infrastructureled economic growth might be difficult to export, Sun said.

May seeks Brexit deal changes, but EU stands firm

BRITISH Prime Minister Theresa May yesterday [Macau time] won a few weeks to salvage a Brexit deal but headed toward a clash with the European Union by promising to overhaul the divorce agreement she spent a year and a half negotiating with the bloc.

Trying to break the U.K.'s Brexit deadlock, May got Parliament's backing for a bid to rework an Irish border guarantee in the withdrawal deal - a provision May and the EU both approved, and which the bloc insists cannot be changed.

"It is now clear that there is a route that can secure a substantial and sustainable majority in this House for leaving the EU with a deal," she said, promising to "obtain legally binding changes to the withdrawal agreement" from the EU.

The EU immediately ruled that out, insisting in a statement that the current deal with the U.K. remained the "best and only way" to achieve an orderly Brexit. French President Emmanuel Macron said the agreement "is the best accord possible. It is not re-negotiable." Guy Verhofstadt, the top Brexit official at the European Parliament, said there was "no majority to reopen or dilute" the deal.

It was the latest disorienting chapter in a Brexit process that has grown increasingly surreal since Parliament rejected May's divorce deal two weeks ago, leaving Britain lurching toward a cliff-edge no-deal" departure from the bloc on March 29.

A series of Commons votes on

next steps submitted by both pro-Brexit and pro-EU legislators ended up sending starkly mixed signals, as lawmakers backed a call to renegotiate the deal, and also approved a rival motion ruling out a no-deal exit.

May had urged lawmakers to "send an emphatic message" to the EU, but their response is likely to leave the bloc even more confused about British aims.

May believes her agreement can still win Parliament's backing if it is changed to alleviate concerns about the Irish border measure, known as the backstop. The backstop would keep the U.K. in a customs union with the EU in order to remove the need for checks along the border between the U.K.'s Northern Ireland and EU member Ireland after Britain leaves the bloc.

The border is crucial to the divorce deal because it will be the only land frontier between the U.K. and the EU after Brexit, and because the free flow of people and goods underpins both the local economy and Northern Ireland's peace process.

Opposition to the backstop by pro-Brexit lawmakers — who fear it will trap Britain in regulatory lockstep with the EU — helped sink May's deal on Jan. 15, when Parliament rejected it in a 432 to 202 vote.

Yesterday, Parliament backed, by 317 votes to 301 votes, a call for the border measure to be replaced by unspecified "alternative arrangements."

Leading Brexiteers praised the result. Former Foreign Secretary Boris Johnson said Parliament had sent a "clear, unambiguous" message that the backstop had to be removed.

"I hope that our friends in Brussels will listen and that they will make that change," he said.

But Green Party legislator Caroline Lucas, who wants a new referendum on Britain's EU membership accused May of chasing "heated-up fantasies that have already been rejected by the EU." May acknowledged that the EU had "limited appetite" for changing the Brexit deal. But she vowed to go to Brussels and seek "significant and legally binding change" to the backstop. May's office said that might include an end date to ensure it is temporary or an exit clause for Britain. Both those ideas have been repeatedly rejected by the EU.

"There can be no change to the backstop," said Ireland's European Affairs Minister, Helen McEntee. "It was negotiated over 18 months with the U.K. and by the U.K."

Lawmakers voted on seven Brexit proposals, including the border change supported by May and several measures that sought to rule out a "no-deal" Brexit.

Much of the business world says a no-deal Brexit would cause economic chaos by eliminating existing EU trade agreements and imposing tariffs, customs checks and other barriers between the U.K. and the EU, its main export market.

Most members of Parliament oppose leaving without a deal, but they rejected several proposals that tried to wrest control of the Brexit process from the government and give it to Parliament so lawmakers could stop Britain crashing out of the EU without a deal. Some opposition Labour Party members sided with the government, worried about being seen as obstructing Brexit.

Lawmakers approved, by a narrow 318 votes to 310 votes, a motion ruling out a "no-deal" Brexit but not saying how that should be achieved. The vote is not legally binding, but has political force as an expression of the will of Parliament.



Robert Hazell, professor of government and the constitution at University College London, said the EU was "pretty resolute in not being willing to reopen the negotiations unless the British government can come back with something more specific."

"Tonight's votes only kick the can down the road for another two weeks," he said. **AP**

Germany slashes growth outlook on Brexit, trade fears



THE clouds darkened over Europe's slowing economy as the German government slashed its growth forecast and said concerns about a chaotic Brexit and trade tensions were holding back the continent's powerhouse.

Germany's Economy Ministry said yesterday it was cutting its 2018 forecast to 1.0 percent from 1.8 percent in its previous outlook issued last fall.

Economy Minister Peter Altmaier said that while the German economy would grow for a 10th year in a row, "the headwinds, primarily from the external environment, are increasing." He cited Brexit and trade conflicts as key issues.

German businesses are unsettled about the possibility that Britain will leave the EU without agreeing on trade rules for a transition period. New import taxes imposed by the U.S. and China are also weighing on prospects for global trade. That hurts the outlook for Germany because the country is a major exporter.

Germany's economy grew 1.5 percent last year and 2.2 percent in 2017. Growth was also held back by automakers' troubles getting vehicles certified under new, tougher emissions tests.

Unemployment is low and wages are rising, thus far helping to keep the economic upswing going. But measures of industrial activity have sagged in recent weeks. Growth has been disappointing in Italy, where the central bank has indicated the country likely

slipped into a recession, defined as two straight quarters of declining output, at the end of last year.

European Central Bank head Mario Draghi said this month that risks for the 19 countries that use the euro currency have "moved to the downside," leading to speculation the bank could postpone raising interest rates from current record lows. The bank has said rates will stay at current lows at least "through the summer." **AP**

Intel heads list North Korea, not border, as threat to US

IRECTLY contradicting President Donald Trump, U.S. intelligence agencies told Congress yesterday that North Korea is unlikely to dismantle its nuclear arsenal, that the Islamic State group remains a threat and that the Iran nuclear deal is working. The chiefs made no mention of a crisis at the U.S.-Mexican border for which Trump has considered declaring a national emergency.

Their analysis stands in sharp contrast to Trump's almost singular focus on security gaps at the border as the biggest threat facing the United States.

Top security officials including FBI Director Christopher Wray, CIA Director Gina Haspel and Director of National Intelligence Dan Coats presented an update to the Senate intelligence committee on their annual assessment of global threats. They warned of an increasingly diverse range of security dangers around the globe, from North Korean nuclear weapons to Chi-

nese cyberespionage to Russian campaigns to undermine Western democracies.

Coats said intelligence information does not support the idea that North Korean leader Kim Jong Un will eliminate his nuclear weapons and the capacity for building more — a notion that is the basis of the U.S. negotiating strategy.

"We currently assess that North Korea will seek to retain its WMD [weapons of mass destruction] capabilities and is unlikely to completely give up its nuclear weapons and production capability because its leaders ultimately view nuclear weapons as critical to regime survival," Coats told the committee.

Coats did note that North Korean leader Kim Jong Un has expressed support for ridding the Korean Peninsula of nuclear weapons and over the past year has not test-fired a nuclear-capable missile or conducted a nuclear test.

The "Worldwide Threat Assessment" report on which Coats based his testimony said U.S. intelligence continues to "observe activity inconsistent with" full nuclear disarmament by the North. "In addition, North Korea has for years underscored its commitment to nuclear arms, including through an order in 2018 to mass-produce weapons and an earlier law — and constitutional change — affirming the country's nuclear status," it said.

The report said Kim's support at his June 2018 Singapore summit with Trump for "complete denuclearization of the Korean peninsula" is a formulation linked to an end to American military deployments and exercises involving nuclear weapons.

Trump asserted after the Singapore summit that North Korea no longer poses a nuclear threat. However, Coats and other intelligence officials made clear they see it differently.

"The capabilities and threat that existed a year ago are still there," said Lt. Gen. Robert Ashley, the director of the Defense Intelligence Agency.

Plans for a follow-up Trump-Kim summit are in the works, but no agenda, venue or date has been announced.

More broadly, the intelligence report on which Coats and the heads of other intelligence agencies based their testimony predicted that security threats to the United States and its allies this year will expand and diversify, driven in part by China and Russia. It says Moscow and Beijing are more aligned than at any other point since the mid-1950s and their global influence is rising even as U.S. relations with traditional allies are in flux.

The report also said the Islamic State group "remains a terrorist and insurgent threat" inside Iraq, where the government faces "an increasingly disenchanted public." **AP**



1983 BRITISH DRIVERS ORDERED TO BELT UP

Drivers and front seat passengers must wear seatbelts under a new law which came into force at midnight.

The Department of Transport says 30,000 people a year are killed or seriously injured in road accidents. It hopes the compulsory wearing of front seatbelts will save 1,000 lives a year.

Evidence suggests six out of 10 drivers currently ignore advice to belt up in the front.

Police are being urged to take a softly softly approach to start with - but drivers could eventually be fined £50 for not wearing their seatbelts.

The row over making front seatbelts compulsory has been going on for 15 years and there have been 11 previous attempts to make it law.

Critics have accused the government of operating a nanny state and some drivers have complained their personal freedom is being infringed and they find seatbelts uncomfortable.

The government has been urging drivers to check the position of their seatbelts and make the necessary adjustments before today's law came into effect.

Junior Transport Minister Linda Chalker said: "Nobody likes being told to do something when they haven't seen for themselves the sense of it.

"You can remain in control of a vehicle when you don't get knocked out. If you are held in your seat by a belt you have more chance of stopping your vehicle careering into another vehicle containing other people."

She dismissed claims some people would suffer worse injuries through belting up, saying the evidence suggested only a tiny proportion of front seat passengers would suffer worse injuries if they were restrained by seat belts.

There will be some exceptions to the new law. Taxi drivers will be exempt because of the possible threat to their safety from dangerous passengers. Drivers of electric delivery vehicles such as milk floats will also be exempt.

NEWCASTLE 2, MAN CITY 1

AFA Benitez never won the Premier League in his six years with Liverpool but he has done his old team a huge favor in its bid to end a 29-year wait for English soccer's biggest prize.

Newcastle, the injury-hit and relegation-threatened team now managed by Benitez, pulled off one of the surprise results of the season by coming from behind to beat Manchester City 2-1 yesterday [Macau time].

Still, the way United kept fighting and scored late goals will be viewed as a positive by United's hierarchy as it weighs up whether to give Solskjaer the job on a full-time basis.

"The comeback was brilliant," said Solskjaer, who was seeking a record-extending ninth straight win in all competitions to open his interim tenure. "The players have been asked about how they would react if they went 1-0 or 2-0 down, so I felt the comeback was fantastic."

United fell two points behind fifth-place Arsenal, which beat Cardiff 2-1, and fourth-place Chelsea, which plays away to Bournemouth on Wednesday, in the race for the four Champions League qualification spots.

Top officials discuss new global competition

 $R^{ugby's \ world \ go-}_{verning \ body \ says}$ "positive and productive" meetings have taken place between officials from the sport's top nations regarding the introduction of a new global competition.

British newspaper The Times has reported that

a World Rugby Nations Championship would see the sport's 12 leading countries play each other once throughout the year ahead of a playoff series that leads to the top northern and southern hemisphere sides meeting in a final.

The newspaper repor-

ted that the aim of the new league was to provide greater context to the international game, which has test matches in June and November along with the northern hemisphere's Six Nations tournament in February-March and the southern hemisphere's Rugby Championship in August to October.

World Rugby says chief executives from the top unions and tournaments attended a meeting in Los Angeles earlier this week about a global competition "that will deliver greater value and certainty to all unions by building on the strong foundations of existing competitions and invigorating the July and November windows."

The governing body added yesterday [Macau time] that it has been "tasked to continue exploring the viability of potential global competition formats" that would "enhance the international game for unions, players and fans."

The Times reported that World Rugby is looking to start the new competition in 2022 and that it would not be staged in Rugby World Cup years. AP

THE DON'TS FOR CNY

For many people, especially ladies, every weekend is shoe shopping time. But in the last week of the lunar year, there are even more reasons to buy shoes. First, it is customary to buy new outfits for the new year, so it is not surprising that even non-shopaholics will buy new shoes at this time. Second, most shoe shops offer high discounts right before Chinese New Year, so it is a good time to get a good bargain on shoes. That brings us to the third reason which is the cause for this discount: Traditionally, shoe shops were closed throughout the Chinese New Year period, sometimes for up to two weeks, so owners needed to make up for the two weeks of no business during CNY, and competition led to higher discounts right before the CNY.

So why did shoe shops use to close for such a long period of time during CNY? The answer is simple, because buying shoes is one of the big don'ts during the CNY period. But that was in the past. Nowadays, only a few small, traditional shoe shops still close for over a week. All the international brands stay open and still gets tons of customers during CNY, thanks to non-Cantonese speaking tourists.

Technically, buying shoes is bad luck only for the Cantonese speaking world, mostly in Macao and Hong Kong, because it has to do with the Cantonese pronunciation of shoes (= haai), which sounds like a sigh.

The new year has to be celebrated energetically with new hopes and resolutions. It is believed that if one sighs at the beginning of the new year bad luck follows, and he or she will be demotivated and unenergetic for the whole year. So for us Cantonese speakers, not only are we not allowed to sigh during New Year, we should definitely not "buy sigh (shoes)." But for those who are not superstitious, the best time to buy shoes is actually during the week of CNY, because whatever was not sold out before CNY will be even cheaper.

Aside from buying shoes, there are a few other things we need to be aware of which may bring bad luck upon the whole year. One of my favorite don'ts is not to sweep or dust one's abode. The superstition is that if we sweep and throw out garbage during the CNY period, we may be kicking out the god of fortune. Although I cannot understand how dust and dirt in my apartment has anything to do with the Chinese god of fortune, I strongly abide by this rule. It is the one time in a year I can tell my husband that I "cannot" clean the apartment with good reason, instead of "I do not want to because I am lazy."

US URGES CHINA TO RELEASE JAILED HUMAN RIGHTS LAWYER

The Trump administration is calling on China to immediately release a jailed human rights lawyer who was convicted of subverting state power.

The State Department says in a statement it is deeply concerned by the 4¹/₂-year prison sentence handed down to Wang Quanzhang. It says he had been held for 3¹/₂ years in pre-trial detention, often incommunicado and deprived of a lawyer of his choice.

ORGANIZED CRIME

The department says it was troubled by his treatment and is urging Chinese authorities to reunite him with his family.

Wang was arrested in a 2015 crackdown on legal advocates.

The statement comes as relations between the U.S. and China grow rockier over trade and criminal charges brought against a leading Chinese tech company.

Kate del Castillo glad to not testify in 'El Chapo' trial

KATE del Castillo said she's relieved she wasn't called to testify in the New York trial of Mexican drug lord Joaquin "El Chapo" Guzman.

But she doesn't regret arranging a 2015 meeting between Guzman and Sean Penn, although the fallout kept her from visiting and working in Mexico for more than three years, the actress said.

She filmed the upcoming Telemundo sequel to her 2011 telenovela "La Reina del Sur" outside of the country, with a double shooting her scenes in Mexico, she told a TV critics' meeting yesterday [Macau time].

The actress said was finally able to return last Christmas but had an unsettling experience upon arrival, when use of her Mexican passport triggered an alert. Del Castillo, an American citizen, said she could have presented her U.S. passport for entry but insisted on using the document from her native country.

"It shocked me," she said, when she was detained for about 20 minutes as officials scurried around. She recalled thinking, "Oh my God, they're going to arrest me right now or I'm going to be sent back to the United States."

Allowed to leave, she relished visiting her parents. "I slept right between them. [...] I needed that. I'm a 46-year-old woman but I felt like I was 7," she said.

In 2017, del Castillo filed a human rights complaint alleging she was unable to travel to Mexico to work because her communications with Guzman were under investigation.

In December, she announced said she was suing former Mexican officials for USD60 million in "moral and material damages" because of what she calls "political persecution" against her.


Del Castillo accused prosecutors in the administration of former President Enrique Pena Nieto of leaking information that suggested she might be linked to drug trafficking or sentimentally connected to Guzman, something she said cost her acting work.

Mexican authorities investigated del Castillo following the meeting she arranged between the then-fugitive Guzman and Penn, who wrote a magazine article based on it. Del Castillo introduced them because she was considering doing a documentary or film about Guzman's life, something she said last year isn't in her plans.

Guzman is on trial on drug and murder conspiracy charges that his lawyers say are fabricated.

Del Castillo said work has prevented her from following the proceedings closely and she is "happy" not to be involved. **AP**
