Japan U.S. retailer Walmart is selling off 85% of its wholly owned Japanese supermarket subsidiary Seiyu, while retaining a 15% stake, in a deal valued at 172.5 billion (\$1.6 billion), the companies said yesterday. HO IAT SENG ADMITS FLAWS IN BUREAUS' RECENT GUIDELINES

CHIEF Executive Ho Iat Seng admitted that several bureaus have committed flaws in their decision to ban local sporting activities last week.

The Health Bureau (SSM), the Sports Bureau (ID) and the Education and Youth Affairs Bureau (DSEJ) issued contradicting notices over the weekend on the arrangements of local sports events.

The government head admitted that the flipping of guidelines have generated confusion among the general public, specifically the sports circle.

It was valuable that the SSM changed its mind after getting feedbacks from the ID and the DSEJ on the new guidelines' impracticality, Ho explained.

The CE praised SSM, noting, "Since early this year, the workload of the SSM has been enormous."

"If someone should be held accountable, it would be me because I'm the head of the Covid-19 Center."

Ho inaugurated the Novel Coronavirus Response and Coordination Center during the peak of the local outbreak. While SSM is part of the Center, Ho is its head.

However, he hoped that in the



future, different bureaus can have better coordination.

At the press briefing where the top official answered queries from the media, cash handouts for next year were discussed, among several questions.

The CE assured in the Policy Address that it will remain at the level of MOP10,000, only that the form of distribution will be determined later.

The government head said that the amount has been included in the next year's public budget. It will be issued, if everything goes well, in July as in normal times. However, the government is still considering which form of distribution will be helpful for the economy. The distribution form will only be determined by July next year.

Ho explained that consumption expenditure did not increase in April this year when the cash handout was distributed. However, he pointed out that the consumption card, which was issued in May, did boost consumption.

He acknowledged that distribution in the form of cash is preferred by most residents, as it helps people pay bills and repay mortgages. However, if people keep the cash in their pockets, it will not help the economy recover, the CE explained. The current consumption card is not applicable in getting medical services, settling public utility bills, taking cross-boundary transports, or making payments to financial institutions.

Meanwhile, the CE hopes that Hong Kong people can enter Macau without undergoing quarantine once its Covid-19 situation has stabilized. The neighboring city is the region's second largest source of tourists.

Recently, Hong Kong has been seeing stippled Covid-19 cases which has stopped Macau authorities from delisting it from low-risk areas. "We have to follow national guidelines," the

CE stressed.

Yet, he suggested Hong Kong people to enter mainland China, where they will be quarantined with a smaller price tag for 14 days, before coming to Macau. In this case, they will be exempted from quarantine in Macau.

Later, when he was asked to lift quarantine on people coming in from Taiwan, where no local cases have been recorded in the past 200 days or so and is the third largest source of tourists in Macau, he stressed that Taiwan cannot yet be considered free from risks.

Meanwhile, he was displeased about how Taiwan treats entrants from Macau. "We have seen more than 200 days without a case," Ho said. "Even with that, Taiwan is not opening its borders to us, how can we consider them an area with low risk?"

In addition, a group of Macau students studying in Taiwan is calling on the government, under the assistance of lawmaker Sulu Sou, to lift quarantine measures, so that they can return to Macau to spend time with families during holidays.

When asked about its exit strategy for non-resident workers and the employment of local residents, Ho urged people to work in the construction or catering industries because they are lacking workforce.

With many local residents holding university degrees, it is unclear how the private sector will be convinced to take them in to work in strength-demanding positions.

Governance is constantly happening: HIS

I^T is the government's responsibility to make progress in its work and such works cannot wait, Chief Executive (CE) Ho lat Seng said yesterday in his reply to questions from the Times.

A lot of work needs to be concluded in the next four years in the transport and public works sector. This includes the 4th Macau-Taipa Bridge, the New Urban Zones and the planning of the civil aviation industry after 2022, when the monopoly of Air Macau will expire. would ensure the public that the works in these areas would be conducted satisfactorily.

The government head first admitted that there is a lot to work on in this aspect, keeping the transport and public works sector busy. However, the government's works have never been halted. The CE stressed that even when the first cases of Covid-19 emerged in the city, the "top government officials - which included Secretary Raimundo do Rosário from the sector – continued while

other civil servants were exempted from work."

"Whether works will be satisfactory, different people have different views," he explained.

In this Policy Address, the CE said that the government will encourage private entities, including hotels and integrated resorts, to hold more worldclass sports events and attempt to develop sports tourism. As to how the private sector can be encouraged to do so, the CE disclosed that the government's sports collaborations with hotels and resorts for the next 12 months are underway.

He did not let go of the chance to compliment the private sector on its contribution this year. "We are holding the Macau International Marathon, an international

However, the top official said that it is irresponsible to "put things there and do nothing."

"It is impossible to put off these consultations," Ho said, pointing to the Master Urban Plan and the Sandwich-class Housing consultations, adding that people have been waiting for these policies. "Work that should be done must be done," the government head remarked. He admitted that it may be overwhelming to residents with so many consultation plans within a short period of time. AL



CE warns residents to brace themselves for 2021

HE current economic and social situation is not likely to show significant improvement in the next year, forecasted Chief Executive (CE) Ho Iat Seng during yesterday's presentation of the government's Policy Address for 2021 (LAG2021).

Without being extremely pessimistic, Ho warned the population not to expect a fast economic recovery, especially during 2021, and to take into account that the economic recession regarding the fragilities of the local economy which, almost exclusively depending on just one sector, the gaming industry, is a serious risk.

For Ho, the days of solutions encountering a "vertical diversification" based on the tourism and gaming sectors are numbered, with it becoming necessary to "find and explore new directions to the achievement of economic diversification," as "time does not wait."

Also contributing to this not so optimistic scenario for the coming year is the government forecast that Macau's gross domestic product (GDP) will fall by 60.9% this year, Ho said during the presentation of the LAG2021 report. "It is expected [that there will be] a real contraction of the GDP by 60.9% for 2020," Ho said, forecasting an even deeper drop than that forecasted by the International Monetary Fund (IMF) in mid-October this year. At the time, the IMF predicted the contraction of the local GDP by 52.3%. To tackle the great difficulties and challenges that are also causing a significant drop in government revenues, Ho has called for collective resilience, noting that although many cuts are expected, the government's top priorities will be the protection of the lives, health, and the jobs of the residents.

On this topic, Ho announced that in 2021, the government will continue to reinforce measures oriented toward the well-being of the population, ensuring that the cuts to public expenditure would not affect these areas.

"We will continue to implement measures oriented to the well-being of the population, such as the wealth partaking scheme [cash handouts], the refund of the professional tax, the Addressing the employment topic, Ho ensured that it is the intention of the government to continue to grant residents priority in access to work to keep the unemployment rate as low as possible.

"We will supervise the job market and offer employment services to provide residents with more job posts and career progression opportunities," Ho said, adding that the government aims to further reduce the number of non-resident workers.

"We will optimize the ma-

will also prepare a preliminary project for a field hospital to enter into operation to accommodate possible future needs.

The acceleration of the economic recovery comes second as the government announced developing works on infrastructure and economic diversification. The East line of the Light Rapid Transit (LRT), the extension of Taipa line to Hengqin, and the Forth link Macau-Taipa are part of this effort. Ho also promoted the Airport expansion and the transformation of part of the Taipa Maritime Terminal into the Airport's Terminal 2, as well as the construction of the roads and other infrastructures on Zone A of the new landfills.

On the promotion of economic diversification, the government aims to step forth with the work on establishing a bond market as well as developing the conventions and exhibitions industry, cross-border e-commerce, and the industrialization of the cultural and sports sectors.

On the people's well-being, the government proposes to finalize the work of separating public housing into classes and continue to work on housing projects for senior citizens at Lot P of Areia Preta and promote several works on social housing at Areia Preta, Tamagnini Barbosa, and Mong-Há areas.

On the reform of public administrations, the government aims to develop the digitalization of official services to enhance administrative effectiveness. At the same time, Ho said that it is necessary to develop the mobility mechanism of civil servants to efficiently manage the number of these professionals in each public service.

Ho also promises a closer look at the audit of public spending to ensure a "no waste policy."

Importing talented people is also on the government's plan.

Ho pledged to support youth entrepreneurship, as well as to enable young people to work

caused by the Covid-19 pandemic is expected to continue for a relatively long period and will likely result in additional hassles to the population.

"The time required for economic revitalization will be long, which will result in significant pressures on the employment and the lives of the population," Ho said, adding, "As time progresses, job and life pressures on the population will gradually increase and profound problems and conflicts, previously covered by the accelerated economic growth, will arise, and the accumulated needs of the population will become more highlighted."

These strong words by Ho aimed to act as a wake-up call

According to the LAG2021 report, all the subsidies and tax reductions will remain the same as in previous years. The only novelty is in regard to the cash handouts as the government has not yet decided on how the money will be distributed. This could be through common bank checks, banking transference into the residents' accounts or making use of a different method.

For the year 2021, the government has a list of 10 priorities that will be part of the government's mission for the year. The government's priority is to normalize the epidemic prevention and control, as well as to make a vaccine available to the population as soon as possible. The government also said that it is aiming to promote culture and sports in Macau with the creation of new cultural and sports tourism programs.

Last but not least, the CE says that Macau needs to grab the opportunities arising from the 14th National Five Year Plan to boost cooperation with Hengqin as well as the regional cooperation and integration in the Greater Bay Area. ANOTHER 66 TREES LISTED AS ANCIENT PLANTS

The Municipal Affairs Bureau (IAM) has classified another batch of 66 trees as ancient trees, according to a statement released yesterday. Together with previously listed ancient trees. Macau now has a total of 584 ancient trees. In June, IAM renewed the list of protected ancient trees. For the first time, it has included four trees owned by the private sector. Some 53 trees in the list are being planted in different religious sites and in the city's heritage sites. IAM plans to renew the name tags of the ancient trees including adding a QR code for each of the trees.



GAMING VIP baccarat revenue sees 56% uptick in (

THE gross gaming revenue (GGR) from VIP baccarat was recorded at MOP2.34 billion in the third quarter (Q3) of 2020, a sharp increase of nearly 56% from MOP1.5 billion in the previous quarter.

The jump in Q3 has brought the year-to-date revenue of VIP baccarat to MOP18.7 billion the largest share of overall profits generated from games of fortune in the first three quarters of 2020. This is followed by MOP15.1 billion from mass-market baccarat, MOP2.36 billion from slot

machines, and MOP927 million in Cussec.

However, the Q3 figure in VIP baccarat is still not on par with the great gains of MOP14.8 billion collected in the first quarter of this year, when the impact of Covid-19 on gaming revenue had not yet been realized.

The latest statistics were released by the Gaming Inspection and Coordination Bureau (DICJ) yesterday.

The recovery in the VIP segment follows the reinstatement of Individual Visit Scheme (IVS) permits for all mainland tourists since September 23.

Following the resumption of tourist flow between Macau and China, a large volume of high--value bettors from the mainland have gravitated towards the city's gaming tables, Cloee Chao, president of the New Macau Gaming Staff Rights Association, mentioned to the Times in an earlier interview.

The rise in VIP income in Q3 coincided with a jump in GGR in October, which totaled MOP7.27 billion, equivalent to a rapid month-over-month increase of 229% from MOP2.21 billion in September.

However, the uptick could not offset the fall caused by the pandemic. The GGR in October registered a huge drop of 72.5% from the same month last year.

The SAR government is expecting the annual GGR to be around MOP130 billion by the end of 2021.

> According to the Policy Address, the government is now engaging in endeavors designated to enhance the Judiciary Police's internal operational mechanism to perform law enforcement in full force.

Macau's national security law was passed in February 2009 and came into effect in March that year. The law criminalizes

acts of treason, secession, sedition, subversion, theft of state secrets, and acts by foreign political organizations or Macau groups found to endanger national security.

The decision on amending Macau's national security law came after the neighboring city, Hong Kong, introduced its wide-ranging national security law on June 30.

The bill in Hong Kong

was enacted to restore stability to the society, following the year-long social unrest against the debated yet now-withdrawn extradition bill which would allow criminal suspects to be extradited to China.

Analysts and experts commented that the national security law in Hong Kong was stricter than that introduced in Macau over a decade ago.

MP APPEALS FOR A HARSHER SENTENCE ON JACKSON CHANG

 $T^{\rm HE \ Public \ Prosecutions}_{\rm Office \ (MP) \ has \ lodged}$ an appeal against the sentence acquitting former president of the Macau Investment Trade Promotion Institute (IPIM), Jackson Chang, of bribery charges.

Despite him being exculpated from serious charges, in October the Court of First Instance (TJB) sentenced Chang to two years behind bars.

The latest move by the MP is intended to appeal against the TJB rulings, seeking to see the former president sentenced to more than two years, the MP said in a reply to Portuguese news outlet Hoje Macau.

In the ruling, Chang was convicted of leaking confidential information concerning IPIM's criteria in granting residence permits to investors or skilled professionals to another defendant, Ng Kuok Sao.

Sao was also sentenced to 18 years for leading criminal syndicates which represented several other defendants to process illicit immigration applications and forge documents.

Chang was also found

guilty of inaccurately declaring his wealth.

Earlier, the presiding judge, Leong Fong Meng, criticized Chang for showing no remorse and failing to act as a role model as the highest leader of the IPIM.

In the ruling, Glória Batalha Ung, a former executive board member of the IPIM, was also found guilty of violating confidentiality and abuse of power, which carries a sentence of one year and nine months.

Miguel Ian Iat Chun, the former chief of the IPIM's residency application and legal affairs division, was sentenced to four years' imprisonment.

Chang's wife and daughter were found not guilty of money laundering as there was not enough evidence, the court ruled.

The window for filing appeals against the TJB's ruling spans for 20 days from October 30 to November 18.Earlier, Álvaro Rodrigues, Chang's defense lawyer, told the media after the court session that he was only "partially pleased" with the ruling and intended to file an appeal.

Special subsidy for three categories of disadvantaged families

- Learning activity subsidy:
- From 300 patacas to 750 patacas per month Medical subsidy:

Special living allowance under the Social Inclusion Scheme

Major Policies on Various Areas

Administration and Justice

Looking to the year ahead, deepening public administration reform will remain the major task in the area of administration and justice. We will promote e-governance as an entry point for public administration reform, to facilitate e-services development for commonly used public services.

We will review the functions and related legal system regulating public funds; improve the systems for ranking, recruiting and training civil servants; review the regulations on the powers and responsibilities of management-level officials; optimise civil servant management; and strengthen civil servants' service awareness.

Meanwhile, we will continue enhancing the effectiveness of the legislative coordination mechanism, and prioritise legislation work that is closely related to people's livelihoods and social and economic affairs. We will intensify the promotion of the Constitution, the Basic Law, and the laws and regulations for safeguarding national security, enabling the public to fully understand the social and practical significance of "One country, two systems", thus proactively safeguard national sovereignty, safety and development interests.

To build a healthy city is another important task in the area of administration and justice. We will strengthen the inspection, dredging and maintenance of the drainage network, and develop new green leisure walkways in Islands District.

To normalise disease prevention, we will continue strengthening inspection and quarantine of refrigerated and frozen food, to prevent food contaminated by the novel coronavirus from entering Macao. We will also continue improving wet market management, to establish a new image for wet markets that are clean and tidy with transparent pricing.



Commission Against Corruption

The seventh Legislative Assembly election of the Macao Special Administrative Region will be held in 2021. The Commission Against Corruption (CCAC) will perform its function of monitoring the Legislative Assembly election in accordance with the law, devote its full effort to combat votebuying, and adopt a multi-pronged approach to maintaining a clean election.

Bribery prevention to build a corruption-free society

- Together with the long-term anti-corruption publicity campaign, promote clean elections through various channels; and
- Continue with various integrity education activities, to raise integrity awareness in families, schools and the community.

Anti-corruption and monitoring of use of public funds

- Establish an anti-bribery group, set up an online platform and hotline for reporting vote-buying, and monitor highrisk bribery venues; and
- Continue cracking down on bribery in the public and private sectors, and fraud related to public funds.

Integrated review and departmental collaboration

- Encourage the public to report complaints using real names;
- Implement the reinvestigation mechanism and review the Corruption-free Management Programme;
- Promote cooperation with audit departments on specific regulatory scopes involving public assets; and
- Facilitate cross-departmental collaboration in handling complaints to the ombudsman.

Exchanges with Greater Bay Area to broaden horizons

- With regard to the development plan of the Guangdong-Hong Kong-Macao Greater Bay Area and Macao's development positioning of "One Centre, One Platform, One Base", strengthen in-depth communication and exchanges with the National Supervisory Commission and relevant executive authorities of the Guangdong-Hong Kong-Macao Greater Bay Area; and
- Optimise information technology to support the country in deliberations by the United Nations Convention against Corruption (UNCAC).

Systems creation, consolidation and innovation

- Cooperate with the development of electronic public administration, and establish a CCAC electronic case filing system;
- Introduce online appointments for reporting complaints in person and submitting property and interest declaration forms, for the convenience of the public;
- Attach great importance to training staff regarding professional knowledge and skills; and
- Review the legal system regarding organisational structure, and the organisation and operation of the commission, and strive to propose legislation and amendments to laws in a timely manner.

Commission of Audit

In 2021, the Commission of Audit (CA) will closely follow the Government's policy vision, and uphold the principles of working independently and conducting audit in accordance with the law, to ensure government accounts are compiled in compliance with the law and regulations. The CA will focus on the implementation of major policies, and strive to expand the breadth and depth of auditing and supervision.

Audit and "Auditor Office"

According to the Budget Framework Law and the requirements and practice of its related regulations, and its implementation during the previous fiscal year, the Commission of Audit will again review the workflow of audit and optimise the details of each item of work.

ON THE ROAD TO GP INTERVIEW | NICHOLAS LAI

Living a childhood dream

N illustrious unknown for those unfamiliar with the local motorsports' panorama, Macau's Nicholas Lai is set to move from the virtuality of the racing simulators to the reality of the streets of Macau this year.

Behind the wheel of a BMW M4 GT4 from the Son Veng Racing Team, Lai is living a childhood dream with the opportunity to participate in the notorious Macau Grand Prix event.

To learn more about Lai's path in motorsports and his expectations for this year's race, the Times spoke to him in an exclusive interview.

Macau Daily Times (MDT) – Tell us a little bit about how you started racing.

Nicholas Lai (NL) – I started race driving back in 2015 after proper training with Asia Racing Team (ART). It took me three years to build my confidence in controlling the car.

In 2018, I finally had enough confidence to move forward into racing so I joined the "Radical Challenge Series" in Shanghai. It was my first-ever race and I think I made a mistake in the last half of the last lap, where the engine stopped and I couldn't restart the car after it stopped. I missed a place in the podium on that first race because I didn't know how to restart the car. After all, it had some kind of "power lock" in the gear.

This happened with the Radical SR3 car. It took me over 30 seconds to restart the car and although I had some advantage over the next driver, I saw him pass through. After that race, I decided to engage in proper physical training as I knew I wasn't prepared for races. It took me some six months of training in a gym to reach the level of fitness I needed and at the same time, I also started to do some [racing] simulator sessions as well.

Last year, I also raced in Formula 4 (F4). It was something that I always wanted to do – to race in a formula car. I raced in Shanghai in April 2019 in one of the support races for the F1 event [F1 Chinese Grand Prix]. We only had one race that weekend and I got only 14th position so it didn't go so well. I experienced a lot of problems with the car. It had several engine failures during both practice and qualifying sessions so I had to start from the back.

Later in 2019, I raced in Zhuhai and I managed to score some good results. I was awarded a rookie trophy; I was really happy with that as it was my first time racing in Zhuhai.

Then the championship moved to the next race in Ningbo [Zhejiang province] and I was improving a lot and could see my progress but after the Ningbo event, the car problems reappeared. I guess it was the Engine Control Unit that became wet due to the heavy rain.

I was disappointed as I had started 4th from the grid but by Turn 5, I was already leading the race but the engine died on me.

I then started thinking that maybe it was time to change again as the F4 car was not reliable. I thought it was time to move forward to something better so I joined the Asian Formula Renault (AFR) series in Sepang, Malaysia.

I found it interesting that it was

not that difficult to learn the car and track as I thought it would be. In Sepang, there is a lot of gravitational force (g-forces) that results from high-speed cornering, braking, and acceleration, but since I had been physically preparing, it wasn't that difficult.

I attained three podium finishes after that and I was thinking to join this year's AFR series as I was interested in race in the brand-new Hanoi circuit [in Vietnam] but eventually, that race never happened [due to the Covid-19 outbreak that halted the motorsports calendar].

MDT – How did you get the opportunity to participate in this year's Macau GP?

NL – In March this year (amid all the complications), I got an invitation from Son Veng Racing Team, asking me if I wanted to join the Macau race as they were planning to have two races on the Mainland in preparation for the Macau event.

And I thought this was my chance to race in Macau and even be able to get any kind of support from the government as I have been spending my own money for the past five years without any support.

It took me a lot of sacrifices and spending of all my savings to reach here.

I only started to join racing activities and training in 2015 because that is when I finally had the money for it. Also, I learned these skills from my job roles, where most of my duties included 'set targets and building goals'. I did apply the same concept to myself. I have been always fascinated by the F1 and its drivers.



I need to had that fortunately and although the many difficulties I found support from Dongbo Group that is sponsoring my race this year, to which I am very thankful.

MDT – For the Macau GP, you will be racing in a completely new and different type of car. How do you feel about that change?

NL – Yes, I am both excited and a little anxious about it. I have always been racing formula cars (single-seat, open-wheel, and open-cockpit cars) and I never raced any touring cars (modified road cars). I only had a practice session in Zhuhai in an Audi RS3 TCR car and I didn't quite like it as I felt it was very slow in the car and like driving in a shell without seeing the wheels.

I still prefer the formula cars. It's a different experience where you can feel everything that is going on and you feel like being part of the car. In a touring car, you don't feel a lot as all the forces are transferred to the cage [roll cage] and chassis.

One of the scariest parts of driving in Macau and especially with a touring car is that if you don't drive carefully, it is very easy to 'total' the car [destroy completely]. This is what makes me more nervous and anxious about.


MDT – What are your expectations for the Macau GT Cup race event, in which you are participating?

NL-This is a very unusual year for everyone and as we speak it's not even possible to know or even forecast who is going to participate in this race as [at the time of the interview] the entry list has not yet been published. There were a lot of changes and I was initially to race in the Greater Bay Area GT Cup, but then finally we decided to change my entry

GUIA CIRCUIT - ALMOST UNTOUCHED GP TRIVIA

ORIGINALLY lengthened by a little over 6.28 km (3.9 miles), the final layout of the Guia Circuit was 6.2 km since the fifth edition of the Macau Grand Prix, in 1958. Many years later, in 1993, the start-finish line, which was originally located a few meters before the Mandarin bend, was moved to its current location at the Outer Harbor.

This was the most significant change ever made to the circuit. The line, the control tower, and all the support facilities, including the pit garages and the spectators' stands, were moved to the new location. The Grand Prix headquarters was also moved to the new location, marking the 40th edition of the Grand Prix.

Since there were no qualification races this year, it is impossible to know who will be racing and in which car.

I only had a very short session to try out the car and the next time I'll be jumping in the M4 GT4 will be to race in Macau.

MDT – How are you coping with the lack of opportunities to practice and gain routines? Are you using simulators to practice?

NL - What I am doing to prepare for the race is mostly to build up my [physical and psychological] strength.

The simulator is important but I

don't practice on the simulator every day because, in my opinion, if you get too attached to the simulator and use it every day, you soon start treating it as a game. But, if you try to use it like once a week, this will be just like your real practice session.

I don't focus so much on the race simulator; I prefer to focus more on the physical training as we know many older racers in Macau do not usually focus on the physical part of the training but they know the track quite well as they have been racing here for many years.

I think I can compensate my lack of track experience with better physical preparation as I feel that physical preparation plays a very important role.

MDT - Do you agree with the introduction of more junior or support races to Macau GP?

NL-I think so. Macau GP should accommodate people like myself. It is not easy to get to [race] in Macau because you need to spend a lot of money. Unless you come from a rich family [that can support you], which I am certainly not.

I think if there is such support especially for the youngsters, so that they can focus just on one thing, which is racing and practicing for the sport itself.

It takes a lot of strength to get to the position of being able to race in Macau.

Then, if you can't race in Macau, you are barred from applying for support from the government. Current regulations state that for racers to get a subsidy from the government, they must participate in the local racing event and should be included in the final classification list

I hope that the government and the sport entities will find a way to encourage new drivers to get more exposure and support in Macau as this is our race and our track, we somehow have the duty to promote it.

CRIME Women falsify police REPORT AFTER RMB500,000 LOSS TO GAMBLING

 $T^{\mathrm{HE}}_{\mathrm{charged \ two \ mainland \ wo-}}$ men with filing a false police report, the police department said yesterday during the joint police press conference.

The two suspects, Wang, who is unemployed, and Jiang, who is a self-claimed student, are in their 20s.

Police information shows that in October, the two met a mainland man, surnamed Xia, in Shenzhen.

Wang and Jiang invested 300,000 yuan and 200,000 yuan, respectively, to Xia so that he could gamble in Macau on their behalf.

On November 5, Wang and Jiang travelled to Macau to meet the two victims in this case, both surnamed Meng, who are mainland residents. The four met in a hotel room at a casino located in Cotai.

On November 11, after meeting with the two victims, Wang and Jiang filed a police report



claiming that both Mengs were fraudsters.

The two women told police that, in October, Xia had tricked them into investing a total of half million vuan into Macau's casino projects. They also accused the two victims of signing an agreement regarding the made--up investment fraud.

However, during interrogation, police officers learned, from Wang and Jiang's WeChat conversation records, that the half million Chinese yuan was invested to trustee Xia to find people to gamble in Macau in hopes of profiting.

On November 13, PJ forwarded the two to the prosecution authority.

In addition to this case, PJ also reported four fraud cases involving counterfeit notes. Across the four cases, PJ apprehended four suspects, all mainlanders, who claimed they were paid to deliver fake notes to the victims.

In total, five victims reported a total loss of approximately HKD500,000.

SUSPECT OF MULTIPLE CRIMES APPREHENDED

THE Judiciary Police (PJ) **L** has apprehended a suspect accused of committing multiple crimes, including robbery, assault, and usury, the PJ said during yesterday's joint police press conference.

The suspect is a 48-year--old mainland man, surnamed Wang, who has identified himself as a businessman.

Wang is accused of committing crimes in January. The alleged victim is a mainland woman in her 40s.

Police intelligence shows that, on January 29, the victim borrowed 1.2 million Hong Kong dollars from the suspect to gamble in local casinos. The victim then lost all this money.

Later, on the same day, Wang and the victim dined together in a restaurant in Macau. During the meal, the victim drank alcohol to the point of unconsciousness.

On January 30, when the victim woke up in a hotel room within a casino located in the NAPE area, she realized that she had been beaten up, injured, and robbed. Afterwards, she immediately reported the crime to the police authority. The victim claimed that one of her rings, which was worth HKD1.23 million, had been stolen, in addition to HKD130,000 in cash.

On the same day, she was taken to hospital to receive medical treatment after she reported the case to the police authority. The medical treatment process lasted seven hours.

However, due to the outbreak of the pandemic, Wang had to leave Macau soon after the woman received medical treatment in the city.

On November 9, the victim returned to Macau and visited the PJ to assist the police investigation in her case.

The police authority found out that the suspect was also in Macau on November 9. On the next day, at 5 p.m., when the suspect was crossing the border to mainland China, the police authority intercepted him.

Wang admitted that he had taken the victim's money and ring as payment for the money the victim had borrowed from him.

The suspect refused to cooperate with the police authority in regard to the usury charge. JZ



UTHORITIES in Hong Kong said at least seven people were killed and 11 injured in a fire at an apartment building that may have started at a gathering of people from the city's Nepalese community.

The blaze broke out Sunday night in Yau Ma Tei, a usually bustling area in Kowloon packed with old apartment blocks, shops and businesses.

The apartment where the fire started may have been operating as an unlicensed restaurant, according to the area's district council member, Leslie Chan.

The Hong Kong government said those who died were four men and three women, with the ages of those killed and injured given as between 8 and 48. Chan said the dead and injured were from the Nepalese community.

Fire officials said at a news conference early yesterday that the cause of the blaze was still unknown. The building lacked a sprinkler system and people were trapped in the back of the kitchen, according to fire services department officer Cheung Kwong-yuen.

Local media reports said that people in the restaurant were celebrating Diwali, a Hindu festival, as well as a birthday when the blaze occurred. Lit candles had set soundproofing materials on fire, according to the media reports.

Residents in the neighborhood said those caught in the fire were from Nepal. Many Nepalese live in the area and work in Hong Kong's finance, retail and security businesses.

Fire in apartment building kills 7, injures 11

The apartment in the low-rise building where the fire broke out had some of its windows blown out and exterior walls were charred with soot. The building was cordoned off while police stood guard.

Chan said the district council is providing assistance to those evacuated from the building and some will need to stay temporarily in hostels while the fire is investigated.

Hong Kong leader Carrie Lam issued a statement shortly after midnight saying she was "deeply saddened that the fire in Yau Ma Tei last night caused a number of deaths and injuries." She also visited the site of the fire yesterday morning.

Local media said the fire was the deadliest since a 2011 blaze that killed nine people.

The incident highlights fire safety issues in older buildings in the city, home to some of the world's most expensive real estate. Deadly fires used to be a regular occurrence in Hong Kong, one of the world's most densely populated cities, but have dwindled in recent years as the government implemented stricter fire safety measures. **AP**

ANALYSIS CRACKDOWNS EVERYWHERE SHOW XI STRENGTHENING PARTY GRIP ON CHINA

THE past few weeks have shown that Chinese President Xi Jinping can move extremely fast when he hones in on long-term threats to the Communist Party. And right now they revolve around the convergence of technology, finance and Hong Kong.

Since unveiling a goal last month to double the size of the economy by 2035, China has embarked on a sweeping crackdown of some of its most valuable companies. The shock suspension of Ant Group Co.'s \$35 billion initial public offering was quickly followed by more anti-monopoly rules to rein in former tech darlings Tencent Holdings Ltd. and Alibaba Group Holding Ltd., leading to a \$290 billion equity sell off last week.

At the same time, he's moved to further snuff out any opposition in Hong Kong's legislature, the most democratic institution under Chinese rule. And authorities are forcing bond investors to take more responsibility for risk in a debt market where defaults have been historically rare, helping to deflate a potential debt bubble while also avoiding an inadvertent funding crunch.

The moves reflect an increased urgency among China's top leaders to stem growing threats to their rule, whether it be a 2008-style financial crisis, a color revolution or a new class of billionaires becoming more powerful by the

day. And while some of the measures are prudent steps to de-risk the economy, one common thread runs through them all: The need for the Communist Party to control all the levers of power.

"Xi Jinping certainly seems to be cracking the whip with a purpose and a force that, if not new,

is certainly designed to impress upon the party, entrepreneurs, ci-

The U.S. has pressured allies to shun equipment from Huawei Technologies Co., barred dozens of China's largest tech companies from buying American parts, and even slapped bans on ByteDance Ltd.'s TikTok and Tencent's We-Chat. While Chinese leaders are calling for enhanced cooperation as President-elect Joe Biden prepares to take office, the Trump administration is planning more steps before leaving office in January that could further sour ties between the world's biggest economies.

Those trends, exacerbated by the pandemic, prompted a shift in Beijing's strategy toward greater self-reliance. Party leaders vowed to build their own "core technologies" to avoid relying on the U.S., while also focusing more on revving up domestic growth as part of Xi's "dual circulation" model. His ambition of doubling the size of the economy would imply an annual average growth rate of 4.7%-5%, according to a range of forecasts from economists

'SHARE THE GROWING PIE'

Still, it will take years for local companies to match foreign counterparts in both basic manufacturing and design expertise: China imports more than \$300 billion worth of integrated circuits each year and its semiconductor developers rely on U.S.-made chip design tools and patents.

the finances of a prominent stateowned chipmaker - an industry seen as strategically important for Beijing - are also under scrutiny.

Such defaults mark a stepchange for China's onshore bond markets, where debt sold by state-owned enterprises has tradilitics at the University of Oxford. "However, it also seems likely that the CCP is concerned that major business figures may have political ideas about power, beyond mere wealth. So the use of regulators is in part to reinforce the message that nobody is bigger than the par-

tizens and the rest of the world his authority and determination," said George Magnus, research associate at Oxford University's China Centre. "I don't see much that is pre-emptive or getting ahead the curve here. If there were, Xi would be channeling his inner 'reform and opening up' appetite. The point is that he doesn't really have any."

Last month's unveiling of the Communist Party's latest five-year plan came at a crucial time. The West began to see China's rise more as a threat than an opportunity over the past four years, and President Donald Trump took a series of steps to cut the country off from key technologies to thwart its growing economic and military might. between limiting the powers of the giants and nurturing homegrown innovation. The new draft rules, for instance, aim to minimize over-concentration of user data and algorithms, which are crucial to leveraging artificial-intelligence applications that drive the modern economy.

"It is about how best to share the growing pie of economic development and tech innovation," said Hong Hao, chief strategist for Bocom International in Hong Kong.

While it's unclear how harshly the new anti-monopoly rules will be implemented, the draft released last week gives the government wide latitude to rein in tech entrepreneurs like Jack Ma who until recently were given relatively free Alibaba and Tencent had become as powerful in China as the likes of Facebook Inc. and Apple Inc. in the U.S., according to Rebecca Fannin, author of "Tech Titans of China" and founder of Silicon Dragon Ventures.

"Startups will welcome any decline in their monopolistic power because these huge Chinese companies have stifled them, and used their leverage and size to out-innovate them quickly or buy them out," she said.

Beijing is walking a similarly fine line in demonstrating that even government-backed institutions won't automatically be rescued from financial missteps. A stateowned coal miner defaulted on a 1 billion yuan note last week, while tionally been backstopped by local governments. China's most influential billionaires are also on notice.

In explaining his 2035 vision last month, Xi emphasized that "common prosperity" is the ultimate goal for China's socialist economy. The country's state-run media have featured a slew of articles on Xi's push to end extreme rural poverty - those who earn less than 11 yuan (\$1.63) per day - by the end of this year.

'NOBODY IS BIGGER THAN THE PARTY'

"Making it clear that the ultrarich can be brought to heel is important symbolically," said Rana Mitter, professor of Chinese poty."

Hong Kong illustrates the extent to which the Communist Party doesn't want to allow dissent on any territory it controls. China's legislature in Beijing passed a resolution last week establishing a loyalty test for elected lawmakers in Hong Kong, leading to disqualifications that prompted the opposition to resign en masse.

"The party values stability over everything," said Kendra Schaefer, head of digital research at the Trivium China consultancy in Beijing. "They value it over competition, over fairness, over money. Maybe the only thing they value more than stability is power, and it's stability that maintains their power." **BLOOMBERG** MacauDaily

Covid pushes steep drop in foreign college students

JUST two semesters short of earning a cybersecurity master's degree in the U.S., Sai Naini is stuck in India, unsure what his future holds.

He rushed home this summer after learning that his father was in failing health after being diagnosed with COVID-19, making it to his hospital bedside only four hours before he died.

"He was emotional; he was in tears," Naini said. "I was fortunate to see him. I think he was waiting to see someone who would take care of my mother, and then he left."

Two months later, when the 28-year-old was ready to return to the University of Toledo, his visa application was denied even though he had letters from his college advisers explaining why he had gone home and that he already was enrolled in classes. The only explanation he got, he said, was that he was turned down "based on guidelines they received from the White House."

"Everything changed," he said. "The goals I had changed. The milestones I had changed."

Complications and new policies brought on by the coronavirus pandemic have stopped thousands of international students from attending universi-



ties in the U.S. this fall, raising concerns that the steep decline could foretell a long-lasting shift for universities that have come to rely on attracting international students. At risk are millions of dollars in tuition for the universities and some of the world's brightest minds for U.S. employers.

While the number of new international enrollees has been on the decline during the past few years because of new rules limiting student visas and competition from other countries, the pandemic has been a crushing blow.

This fall, new international students enrolled at U.S. uni-

versities online or in person fell by 43%, according to a survey of more than 700 schools released Monday. That's the largest decrease recorded by the Institute of International Education, which has been publishing data on international enrollment since 1954.

Including both new and returning students, total international enrollment fell by 16%. The survey found that among those who did enroll at U.S. colleges, about one in five were studying online from abroad.

Some of the nation's largest universities saw big losses. The number of undergraduate and graduate international students at Michigan State University was down 20% and the University of Texas fell by 17%, while Arizona State University and Ohio State University each reported declines of 15%.

Administrators agree the pandemic caused a wide variety of hurdles for students, ranging from financial strains brought on by job losses to worries over a Trump administration proposal that sought to force international students to leave if their schools held online-only classes.

With American consulates closed in many countries, quite a few first-time students were unable to get visas, while others were stranded because of travel restrictions and flight cancellations.

Universities were flooded with questions from worried parents who wanted to know where their children would live if schools closed their dorms and what would happen if they got sick. Some decided to stay home because of those unknowns.

"At a human level, we can all relate to that," said Barbara Kappler, assistant dean of International Student & Scholar Services at the University of Minnesota, which saw a 15% decline.

It all has forced to students make tough choices. One University of Toledo student decided not to go home even though two relatives had died of CO-VID-19, said Tracey Hidalgo, the school's assistant director for international student services.

"They just bawl their eyes out and tell me 'no' because they're worried they're not going to be able to come back," she said.

Compounding the problems of the pandemic is a growing belief that the U.S. is no longer as welcoming for international scholars because of President Donald Trump's repeated moves to curb immigration.

"The confluence of the pandemic and these policies has created an incredibly tough situation," said Leonardo Villalon, dean of the University of Florida's International Center. "International higher education is under the greatest stress it has been in decades."

The sudden drop in enrollment will be felt in budgets at colleges because foreign students typically pay higher tuition rates. The University of Illinois alone estimates it will lose about \$26 million this semester. But the impact goes beyond that.

High-tech companies depend on foreign-born people who come to the U.S. for training, Villalon said.

U.S. President-elect Biden has proposed giving foreign graduates of U.S. doctoral programs a pathway to citizenship.

But U.S. universities are facing increased competition from countries, including Canada and Australia, that are trying to woo more foreign students. And China is heavily investing in its colleges. **AP**

Pandemic-hit economy returns to growth July-September

JAPAN'S economy grew at an annual rate of 21.4% in the last quarter in a recovery from the shocks of the pan-



vember 2019, according to yesterday's data. Growth was flat in July-September 2019, underscoring stagnant conditions even before the pandemic. tinue at a gradual pace.

"The driver of growth will shift to the service sector," Makino said in a recent report, stressing consumption growth in that sector wears masks.

The administration of Prime Minister Yoshihide Suga has been trying to balance the need to curtail the infection's spread with kee-

demic driven by both private spending and exports.

The world's third largest economy had logged three straight quarters of contraction and was already in recession by the time the crisis hit. Preliminary data from the Cabinet Office released yesterday show a distant road to a full recovery.

News that the economy returned to growth in the July-September quarter sent share prices higher in Tokyo. About an hour after the market opened the Nikkei 225 index was up 1.6%.

Japan, like the rest of the world, is suffering from the

slowdown brought on by business closures, plunging tourism and travel and social distancing measures for COVID-19.

On a quarterly basis, the economy grew 5.0%. The annual rate measures how much the growth would have been if that had continued for a year.

The data showed im-

provements in private consumption, the main driver of growth, and exports, including vehicles and auto parts. The rebound was expected, although analysts warn it won't be enough to mark a return to normal.

The economy shrank 8.2% in the April-June quarter; 0.6% in January-March and 1.8% in October-No"The Japanese economy for July-September 2020 is still in a severe situation due to the COVID-19, but it is showing movements of picking up later in the quarter," the government said in a statement.

The decline earlier this year was the worst the government had on record, at least since it began keeping comparable records in 1980. Japanese media reports characterized it as the worst since World War II.

Junichi Makino, chief economist at SMBC Nikko Securities, said the GDP data reflect a halfway recovery that is expected to contends to be moderate, compared to the consumption of goods.

"The momentum for growth on the macroeconomic level is therefore expected to slow down," he said.

Japan has never had a total lockdown but incoming tourism has largely vanished. Many stores and restaurants are still open, and schools and government offices are mostly running as usual, despite widespread efforts in the private sector for remote working. Some shopping districts are packed, although nearly everyone ping the economy going. That has prompted some criticism over policies such as the government's "GoTo campaign" of discounts for domestic travel that some believe may have caused surging cases in rural areas, such as on the northern main island of Hokkaido.

Japan has had fewer than 2,000 deaths related to COVID-19.

Some companies have sunk into losses, mostly those related to travel and exports. Others like Nintendo Co. have held up relatively well, as people staying home turn to video games. **AP** MacauDaily 澳門每日時報 ◎

Pro-Western candidate Sandu wins presidential election

AIA Sandu, a former World Bank economist who favors closer ties with the European Union, has won Moldova's presidential runoff vote, decisively defeating the staunchly pro-Russian incumbent, according to preliminary results released yesterday.

Sandu captured over 57% of the vote, leaving the incumbent, Igor Dodon, behind by over 15 points, according to preliminary data from the Central Election Commission, CEC, that said nearly 100% of the vote has been counted.

Sunday's election was seen as a referendum on two divergent visions for the future of the small Eastern European nation sandwiched between Ukraine and Romania. Sandu and Dodon, who Russian President Vladimir Putin identified as his preferred candidate, have been rivals since he narrowly defeated her in the 2016 presidential race.

"People voted in very large numbers ... they voted because they care, because they want their voices to be heard," Sandu, who promised during the campaign



to secure more financial support from the EU, said late Sunday after it became apparent she was leading. "People want the ones in power to offer solutions to their problems."

On Monday, Dodon conceded after the results were published and congratulated Sandu.

"I call for calm and peace, absolutely no disturbances or protests, we must not allow any destabilization of the country," he said.

The current pro-Russian

government controls only 51 of 101 seats in the parliament. The new president can dissolve parliament if the prime minister resigns and there are two failed attempts to find a successor.

Commenting on Sandu's win, Kremlin spokesman Dmitry Peskov said Monday that Moscow respects "the choice of the Moldovan people" and hopes to establish "a working relationship" with the new president.

"We know that Maia Sandu said she would work in the interests of the Moldovan people, and we're convinced that building good and close relations, cooperation in all areas with our country, Russia, is in the interest of the Moldovan people," Peskov told reporters.

Ever since gaining independence a year after the Soviet collapse in 1991, Moldova has been divided between those favoring closer relations with Europe and those who prefer stronger links with Moscow.


Moldova is one of the poorest countries in Europe with nearly 1.2 million of its people estimated to be living abroad. It relies heavily on remittances, and closer ties with the EU are generally seen as more likely than those with Moscow to lead to a long-elusive political stability and economic recovery.

Yet in this election, those choices might have been overshadowed by the heavy social and economic toll inflicted on Moldova by the coronavirus pandemic. So far, the nation of 3.5 million people has tallied close to 89,000 virus cases and over 2,000 deaths. On Saturday, it reported a record 1,411 new daily infections. AP

1997 EGYPTIAN MILITANTS KILL TOURISTS AT LUXOR



More than 60 people have been killed after an attack on a group of foreign tourists visiting a temple in southern Egypt.

The tourists' bus was fired on as they visited the temple of Hatshepsut, one of the main attractions in the town of Luxor in southern Egypt. An Egyptian police spokesman said most of

the dead were Swiss and Japanese tourists. The spokesman said the six gunmen were killed in an ensuing two-hour gun battle with po-

lice. According to initial figures released by Egypt's interior ministry, 57 tourists, a local guide and two policemen died in the attack.

Other reports say the number of people who have been killed could rise to 75 with up to 85 people injured.

An Islamic extremist group, the outlawed al--Gamaa al-Islamiya, is reported to have said it carried out the attack.

It came as 65 alleged members of the Islamic group went on trial in Cairo accused of conspiracy to murder.

Islamic militants have targeted tourists since beginning a campaign in 1992 to topple the government of Hosni Mubarak and set up a strict Islamic state.

Two months ago, nine Germans and an Egyptian driver were killed when gunmen opened fire on a bus in Cairo.

Two men have since been sentenced to death for the shootings.

Luxor, about 310 miles (500 km) south of Cairo, is visited by about two million tourists a year.

Dter Boris Johnson said yesterday he is as "fit as a butcher's dog" after being instructed to self-isolate for 14 days because he recently came in contact with someone who has since tested positive for the coronavirus.

In a video message posted on Twitter from his London apartment at Downing Street, Johnson said it didn't matter that he has already endured COVID-19 and is "bursting with antibodies."

The quarantine requirement comes at the start of a crucial week for Johnson's Conservative government that includes discussions

with the European Union. Negotiators are meeting in Brussels this week with time on a deal fast running out.

Johnson contracted the virus in April and spent three days in intensive care as his symptoms worsened. He met with a small group of lawmakers for about a half-hour on Thursday, including one, Lee Anderson, who subsequently developed symptoms and tested positive.

Johnson was notified by the National Health Service's Test and Trace system Sunday and told he should self-isolate because of facthe meeting.

"We've got to interrupt the spread of the disease and one of the ways we can do that now is by self isolating for 14 days when contacted by Test and Trace," Johnson said.

Health Secretary Matt Hancock said it was right that the prime minister goes into self-isolation even though he's already had coronavirus as people "can catch it twice."

"The prime minister is following exactly the same rules as every other person in the country," Hancock told BBC Radio.

Hancock also brushed

days of the pandemic in the spring, many in the heart of government contracted the virus, including Hancock. Danny Altmann, professor of immunology at Imperial College London, said the self-isolation rules "probably are sensible."

He told BBC Radio there have been more than 25 confirmed cases of CO-VID-19 reinfection globally, but that he thought the actual rate of reinfection is "quite a lot higher than that, but not enormous."

"I think my bottom line is not to be alarmist because whatever the risk is, it is low," he said. AP







Korean air aims for top-10 world **RANKING WITH ASIANA DEAL**

COUTH Korea's two biggest Jairlines plan to merge, with Korean Air Lines Co. acquiring Asiana Airlines Inc. for 1.8 trillion won (\$1.6 billion) following an injection via its parent, Hanjin Kal Corp.

The main goal of the acquisition is to stabilize South Korea's aviation industry amid the coronavirus pandemic and improve its competitiveness, said Hanjin Group, which operates airlines and logistics businesses through its subsidiaries. It expects Korean Air to be ranked as one of the world's top 10 airlines once the deal is completed.

"In general, countries with a population less than 100 million have a single full service carrier," Hanjin said in a statement. "However, Korea has two full service carriers, which gives it a competitive disadvantage compared to countries like Germany, France and Singapore with a single major airline."

The merger should streamline route operations and lower costs, while the consolidation of slots at Seoul's Incheon International Airport may increase joint ventures with global airlines and demand for transit flights, the parent company said. That should also spur growth in the domestic aviation industry.

"Korean Air's acquisition and the expansion of its routes, fleet and capacity will give the airline the competitiveness to compete with global mega airlines," Hanjin said.

Asiana and Korean Air both soared on the stock exchange vesterday. Asiana's shares rose just under 30% to their highest since Dec. 26, while Korean Air closed with a gain of over 12% after earlier jumping as much

as 26%, the most on record. The pair are back above where they were at the pandemic's onset in January. Hanjin Kal rose 5.7%.

Korean Air plans to issue new shares in early 2021 to raise 2.5 trillion won. Hanjin Kal will participate in the issue after receiving 800 billion won from Korea Development Bank, which it will transfer to Korean Air. The airline will invest 300 billion won of that to buy perpetual convertible bonds from Asiana

and another 300 billion won as a down payment on a 1.5 trillion won contract to buy new Asiana shares, according to the statement.

"Korean Air's initial investment will enable Asiana Airlines to secure the funding needed for operations until the end of the year, as well as improve its financial position by adding 300 billion won worth of perpetual convertible bonds to its capital assets," Hanjin said.

State-run Korea Development Bank said earlier yesterday that it hopes to complete the transactions this year and seek approvals from antitrust bodies globally by the end of 2021. The bank will likely own about 10% of Hanjin Kal, according to Hanjin Group.

Kumho Industrial terminated talks to sell a 31% stake in Asiana to HDC Hyundai Development Co. in September after the parties failed to agree terms as the pandemic threw valuations into doubt.

Airlines around the world have been plunged into crisis because of the coronavirus and its impact on travel. Founded in 1988 to compete with Korean Air, Asiana flew to 61 cities in 21 countries prior to Covid-19. It has two budget carriers, Air Seoul and Air Busan.

Korea Development Bank said Hanjin may look at consolidating low-cost carriers after the Asiana acquisition. Hanjin Kal is the parent of budget operator Jin Air Co. MDT/BLOOMBERG


Belgium ends England's Nations League hopes with clear win

BELGIUM 2, ENGLAND 0

RIES Mertens scored a superb free kick as a resilient Belgium ended England's hopes of reaching the Nations League finals with a 2-0 win yesterday [Macau time].

With one round of games left, Belgium has a five-point lead over third-place England in the top tier's Group 2 but has not yet secured qualification. Top-ranked Belgium will host second-place Denmark on Wednesday with a place in the finals next year at stake. A draw will be enough for Belgium, which leads Denmark by two points.

Held without fans because of coronavirus restrictions, the match got off to a promising start with both teams determined to play with intensity. England pressed high throughout and enjoyed long spells of domination but la-

cked efficiency in the final third. Belgium, in contrast, defended well and had that finishing touch. "I'm very satisfied to keep a

clean sheet against a team like

England," Belgium coach Roberto Martinez said.

Belgium took the lead in the 10th minute after captain Jan Vertonghen made the most of a

loose pass from Eric Dier to recover the ball and ignite a quick move. Romelu Lukaku set up Youri Tielemans, whose low shot from the edge of the box took a deflection, hit the post and ended in the back of the net.

Harry Kane, making his 50th appearance for England, was dangerous throughout. He came close two minutes after England had conceded but his goal-bound header was cleared off the line by Lukaku.

Mertens made it 2-0 with his 21st international goal. After Kevin De Bruyne won a free kick close to the area in the 23rd minute, Mertens expertly curled his kick above the English wall -which mostly failed to jump and lodged the ball into the left corner.

England coach Gareth Southgate called the free kick "a turning point" and said he did not think it should have been awarded.

"They are a top team who

defended very well," Southgate said. "In a top-level game we had a fair proportion of chances at goal. I can only praise the players who were here tonight."


With a 2-0 lead, the hosts then let the opposition have the ball as England pushed hard to pull one back but could not find a cutting edge.

England continued to apply pressure in the second half and still wasted chances, notably from set-pieces. Despite enjoying possession and winning nearly all the duels in midfield, England remained ineffective. Kane's low effort was stopped by Belgium goalkeeper Thibaut Courtois following a good combination near the hour mark, shortly before Aston Villa midfielder Jack Grealish fired over the bar from inside the area.

"We were dominant. We were unlucky to concede the two goals," Kane claimed.

Belgium finally created its first second-half chance with 15 minutes left following a team move between De Bruyne, Mertens and Lukaku, only for Lukaku to shoot straight at England goalkeeper Jordan Pickford.

Inter Milan striker Lukaku had another chance to add more luster to the win but shot wide at the conclusion of a fast counterattack in added time. AP

BEEF OR NO BEEF, THAT IS THE QUESTION

I was walking by a fast food chain the other day when my attention was caught by a drop-down banner hanging on the window, facing the street. The restaurant was highlighting their three new – but not quite new – burgers, all featuring a prime type of beef from the US.

The chain has always restlessly pushed its beef products, while inventing – or introducing – new hamburgers made with this kind of prime beef. Whether the beef tastes good isn't much of a concern, but having the chance to consume, or abuse, the beef type bearing that prime name at a cost of little more than pennies, when compared with steak houses in casino-resorts, is a steal for many, especially when they get off from a tough day's work near midnight and their appetite has them craving for protein and carbs.

Anyway, seeing the banner that day, I was prompted to dig through my memories to see if the chain has ever marketed new burgers with prime types of pork or chicken. Feel free to remind me but my memories yielded no trace of such occasions.

To be fair to the chain – because it has not been rare that journalists get sued by people about whom they write – I didn't have to lookfar for pork-related burger innovations pushed by the chain. Should my memory serve me well, when it revealed the rice-burger, the chain did infuse it with pork cooked according to eastern recipes, although mental pictures are vague now as to how exactly it was completed.

Back to the point of introducing burgers made with higher-grade pork – I was thinking, at the moment I saw the banner that day, that the fast food chain could have marketed burgers made with Agu pork from Ishigaki, Japan or Jinhua Ham from mainland China. The former is by itself a type of sumptuous pork, while the latter is one of the icons of the cuisine.

On the other hand, the fast food chain could have offered an African Chicken Burger or a Portuguese Chicken Burger to, firstly, expand its market and, secondly, provide localized fusions for local residents and the many tourists eager to visit Macau.

Localization is not new to the fast food chain. The idea of rice burger has come up in this part of the world because the company found burgers were not appealing to people when it touched ground. Rice is the main staple food in this part of the world – although the culinary culture is diverse and colorful across the region – which is why the

UAE NATIONAL CARRIER TO START FLYING TO TEL AVIV NEXT SPRING

Etihad Airways, the national airline of the United Arab Emirates, announced yesterday it would start operating daily nonstop flights to Tel Aviv next spring, a move that deepens ties between the UAE and Israel after the two countries agreed to normalize relations.

Direct flights on Etihad between the emirates' capital of Abu Dhabi and Tel Aviv will begin March 28, giving "Emiratis and UAE residents the opportunity to discover Israel's historical sites, beaches, restaurants and nightlife," the state-owned carrier said in a statement. Tickets are already available on Etihad's website. The announcement comes after Dubai's budget carrier flydubai said it would begin offering direct flights between Dubai and Tel Aviv later this month.

The UAE and Israel signed a U.S.-brokered accord establishing formal diplomatic ties on the White House lawn in September.

The deal marked a diplomatic achievement for President Donald Trump ahead of his reelection campaign and reflects a changing Middle East, in which shared enmity of Iran has largely overtaken traditional Arab support for the Palestinians.

TRUMP CAMPAIGN RETREATS FROM KEY CLAIM IN PENNSYLVANIA SUIT

PRESIDENT Donald Trump's campaign is withdrawing a central part of its lawsuit seeking to stop the certification of the election results in Pennsylvania, where Democrat Joe Biden beat Trump to capture the state and help win the White House.


Ahead of a hearing today in the case, Trump's campaign dropped the allegation that hundreds of thousands of mail-in and absentee ballots — 682,479, to be precise — were illegally processed without its representatives watching.

The campaign's slimmed-down lawsuit, filed in federal court yesterday [Macau time], maintains the aim of blocking Pennsylvania from certifying a victory for Biden in the state, and it maintains its claim that Democratic voters were treated more favorably than Republican voters.

The Associated Press on

Nov. 7 called the presidential contest for Biden after determining that the remaining ballots left to be counted in Pennsylvania would not allow Trump to catch up. Trump has refused to con-

cede.





and did not provide a notice and cure process, disenfranchising many," the lawsuit said.

Cliff Levine, a lawyer representing the Democratic National Committee, which is seeking to intervene, said it's unclear how many voters were given the chance to fix their ballot.

franchisee decided to make rice burgers.

Another chain that sells coffee has not been innovative too. As I remember, in the past decade or so, it has posted the same three Christmas-themed drinks, with the slightest alterations at the most, for example adding mint syrup, turning liquid drinks to crushed ice, among others.
