DSSOPT CORRUPTION CASE

TUI DENIES APPEALS OF MP AND NG LAP SENG, SENDS CASE BACK TO TSI

THE Court of Final Appeal **⊥** (TUI) has decided on the \{\bar{2}} appeals to the final court by the Public Prosecutions Office (MP) and Ng Lap Seng, one of the defendants in the case.

The case is known as the "Land, Public Works, and Transport Bureau (DSSOPT) Case," as it involved several businessmen in the construction sector and two former bureau directors, Jaime Carion and Li Canfeng.

In the TUI ruling, the judges concluded that "no concrete and objective factual elements proved the existence of a criminal organization beyond the individual purposes of its members. Therefore, the court did not agree with the conviction of the defendants for this crime."

Regarding the charges of corruption and money laundering, TUI acquitted defendant Li of six charges of passive corruption, since he was not yet a public official when he received the benefits offered by the businessmen. This decision has also direct consequences for several other defendants who were accused of money laundering crimes.

The same court notes that since the previous conviction for



participating in a "secret society or association" was overturned, the defendants could not be convicted of money laundering cri-

The TUI also evaluated the requests from defendant Ng in response to MP's appeal. The court considered that there was no need to discuss criminal procedures for the crime of participating in a secret society or association since the defendant had already been acquitted of that crime. Accordingly, the TUI considered that the request to suspend the sentence execution was legally inadmissible.

Finally, considering the acquittal of several defendants from various crimes, the TUI decided to send back the case to the Court

of Second Instance (TSI) to reevaluate the sentences imposed on the defendants who did not file an appeal, such as Carion. In late November last year, the TSI had already decided to reduce the sentences imposed on several defendants in the case.

TSI reduced Li's prison term from 24 to 17 years, acquitting him of seven of the 12 crimes of passive corruption for which he had been found guilty by the Court of First Instance (TJB).

The TSI judges also reduced Li's count of money laundering crimes from 10 to four.

The TJB had initially sentenced the former public works heads, Li and Carion to 24 years and 20 years in prison respectively on charges of corruption, forgery, participation in a secret society or association, and money laundering.

The TSI also resulted in reduced sentences for other defendants such as developer Sio Tak Hong from 24 to 12 years, as well as for another two real estate businessmen, William Kuan and Ng, whose prison sentences were reduced from 18 years to five years and six months, and from 15 years to four years and six months respectively.

The reduction in sentences was also granted to other defendants, including Si Tit Sang (from 20 years to eight years), Ng Kei Nin (from eight years and six months to two years), Lau Pou Fong (from 10 years to three years and nine months), Miguel Wu (from 10 years to three years and nine months), and Siu Ka Kuen (from nine years to three years and six months). Huang Qijun, who had been initially sentenced to six and a half years, was fully acquitted.

The TSI retained the 20-year jail term handed to Carion, sentenced in absentia, who had not filed an appeal. The TUI wants this case to be resolved by the TSI in light of the new decision.

Court asked to apply measures to young offenders in bullying case

guardianship actions for young offenders involved in the bullying of an elderly citizen, according to a statement released.

Under the Macau Penal Code, criminal liability begins at age 16. Individuals aged 12 but under 16 may face seven educational interventions aimed at fostering legal compliance through increased supervision and intervention, the statement said. The severity and recurrence of offenses, family support, and educational circumstances are taken into account when determining the appropriate measures.

The prosecutor may propose supervision of minors for up to three years or placement in temporary housing for one year. Internment, the harshest choice, may be considered for a period of up to eight years until age 21.

For individuals under 12, universal social protection ensures follow-

-up arrangements until the age of 18. In cases where family support is lacking, alternative arrangements such as placement with another family, third party or organization may be considered. Parents must participate in counseling from the Social Welfare Bureau for ensure their proper parental duties are fulfilled appropriately.

Bullying incidents frequently involve crimes like assault, verbal abuse, defamation or distribution of inappropriate content involving minors. As cognitive development and the ability to distinguish right from wrong are still developing in young people, they may be liable to offend due to influence from online sources. Officials emphasized the importance of family and community support in instilling a sound conception of ethical principles and life skills among young people.

S Macau continues to undergo social and economic development, local legislators are calling for comprehensive revisions to the city's labor laws to better safeguard the rights and interests of workers.

Lawmaker and president of the Macau Civil Servants' Association, José Pereira Coutinho, has called on a comprehensive revision to the Labor Relations Law, highlighting that the current law imposed would need to keep up with the times.

"Over the past 10 years, Macau has experienced rapid social development and changes. Due to the unique nature of labor relations, it is time for the 2008 Labor Relations Law to be comprehensively amended," Coutinho said in an interview with the Times.

Coutinho noted that under the current law, employers can dismiss employees at will, and workers in the gaming industry are not provided with any allowances for night and shift work.

"All in all, 25 years after the handover, the SAR Government has not yet been able to fully protect the basic rights and interests of laborers," he said.

Coutinho also highlighted the lack of transparency in the amendment process, which is handled by the Standing Committee for the Coordination of Social Affairs, and the need for relevant departments to address public complaints against illegal workers

more promptly.

As Macau's economy continues to evolve, lawmakers and advocates agree that comprehensive labor law reforms are necessary to ensure that the rights and interests of workers are fully protected.

Echoing similar sentiments, lawmaker and head of the Macau Federation of Trade Unions (FAOM) Ella Lei emphasized the need to review all labor laws, rather than just addressing specific issues such as minimum wage and compensation for work accidents.

"Compensation for work

accidents, labor union protection, and many other issues related to labor law protection are impossible to change all at once," Lei told TDM

"But the government cannot always say that there are no steps to be taken, and only conduct a few inspections every year."

Lei noted that while the government does inspect minimum wage provisions and work accident compensation annually, there is no clear plan for addressing other pressing labor issues.

"In some stages, where

social demands are more severe, such as those we have been strongly advocating for many years, the mechanisms for seeking compensation should be optimized, and the enforcement mechanisms and punishments for illegal work need to be optimized," she said.

The Labor Day was first marked in Macau in 1965, despite not being celebrated in Salazar's Portugal at the time. Only in 1974, right after the Carnation Revolution coup, fifty years ago, the Portuguese authorities instituted the mandatory May Day holiday.

NURSING HOME IN ZONE A NOW OPEN The Public Works Bureau (DSOP)

The Public Works Bureau (DSOP) has opened a public tender for the construction of a nursing home in Zone A. The project, to be executed on lot A8, will encompass an area of 2,840 square meters. The project is expected to be completed within 700 working days, commencing in the fourth quarter of 2024.

AO IEONG APPOINTS 11 WORKERS TO COTAI HOSPITAL

The Secretary for Social Affairs and Culture, Elsie Ao leong, appointed 11 Health Bureau workers to work at the Islands Healthcare Complex until April 30, 2025. According to the order published today in the Official Gazette, the monthly remuneration of these workers will be set by the Macau Medical Center of the Peking Union Medical College Hospital. Discounts under the retirement and survival scheme will be calculated based on the original salary, with costs associated with the employer borne by the Islands Healthcare Complex. This order takes effect from May 1,

TAM KUNG FESTIVAL TO FEATURE PARADE PERFORMANCES

The Tam Kung Festival will be held on May 15 in Coloane, with over 30 teams partaking in parade performances, alongside charity sales and beer carnivals. Organized by the Coloane Lutheran Welfare Association, the festival celebrates the birthday of god Tam Kong, a deity revered by fishermen. The festival's main attraction will be a parade running from 10 a.m. to 1 p.m., as announced in a press conference yesterday. A performance team from Hong Kong has been invited to join the event, along with local groups. Organizers are expecting the number of participants to be around 5,000, similar to last year.

ELDERLY DRUNK DRIVER HITS PEDESTRIAN IN CROSSWALK

A 60-year-old man is facing charges after allegedly striking a pedestrian recently while driving under the influence of alcohol. The incident occurred around 8 a.m. at the intersection Av. da República and Gonzaga Gomes/ Auto-Silo Da Rua De Malaca. Authorities said that the driver, whose identity has not been released, hit a passerby who was crossing a zebra crossing, causing multiple contusions on the victim's body. A breath test revealed the driver had a blood alcohol content of 1.62 grams per liter, well over the legal limit. The driver admitted to drinking at home the night before the accident. He has been charged with driving under the influence of alcohol

Golden Week meets visitor number expectations

THUS far, the Worker's Day Golden Week holiday has been meeting expectations in terms of visitor numbers.

According to figures from the Public Security Police Force (PSP), some 121,750 visitors crossed the border into Macau on the first day of the five-day holiday.

Although the day one figure fell slightly short of the average of 130,000 expected by the Macao Government Tourism Office (MGTO) and the tourism industry, preliminary fi-



gures for the second day (May 2) indicate that the influx of visitors has either met or exceeded the anticipated average.

Both the MGTO and tourism operators earlier anticipated a higher influx of visitors compared to Easter and the Ching Ming Festival, which fell short of expectations, delivering an average of about 96,000 per day.

leased by the PSP for May 2 (yesterday) indicate that 145,664 visitors entered Macau, with available data spanning until 9 p.m.

Complete data from May 1 also shows that on this day, 6,554 foreign visitors entered Macau, a figure slightly lower than the average of 7,774 per day recorded over the 11 days of Easter and Ching Ming.

Nevertheless, the number of tourists at major hotspots such as the Ruins of St Paul's, Senado Square, and Avenida de Almeida Ribeiro has been notably high, prompting the PSP to implement crowd control measures in the vicinity of the Ruins of St Paul's.



IAS PUBLISHES LIST OF **CHILDREN ACCEPTED IN SUBSIDIZED NURSERIES**

The lists of children admitted to subsidized nurseries in Macau for the upcoming school year have been published by the Social Welfare Bureau (IAS). Registration for children listed will be conducted by subsidized nurseries from May 9 to 11. They will also contact parents or legal guardians of children on the waiting list if there are any cancellations.

In the same statement, the IAS reminded that each child can only be enrolled in one subsidized nursery. If parents want to change nurseries for a child who is already registered but not placed in a nursery, they can go to the new nursery to handle the transfer.

DSF TO START REFUNDING PROFESSIONAL TAX TO SOME 158,000 TAXPAYERS

Some 158,000 taxpayers will begin receiving a refund of a part of the professional tax paid in 2022 late this month, the Financial Services Bureau (DSF) informed. Refunds will commence on May 24. According to the provisions in the 2024 Budget Law, taxpayers will see a refund of 60% of the professional tax paid over the 2022 year up to a maximum of MOP14,000. This rule applies only to taxpayers who were Macau residents (ID holders) on or before Dec. 31 2022. It is expected that the entire refund process will be completed by early June.

MACAU'S casino gross gaming revenue (GGR) in April exceeded market expectations and historical trends, according to industry analysts. The region reported MOP18.55 billion in GGR for the month, a 26% increase from the previous year, despite a 4.9% month-on--month decline.

"The 1.7% sequential contraction per day was better than historical trends, as the average sequential decline in April, relative to March, over the 2013 to 2019 period, was -4.1 %," said Carlo Santarelli. an analyst at Deutsche Bank Securities Inc.

JP Morgan also noted that April's tally surpassed GGR expectations. According to the analysts, "GGR grew 26% year--on-year to MOP18.5 billion in April, implying a daily run-rate of MOP618 million and a 79% recovery versus pre-Covid levels, above the 75% recovery rate in fourth-quarter 2023 and first-quarter 2024."

The positive performance was driven by strong recovery in Macau's mass-market segment, which JP Morgan estimated had reached over 110% of pre-Covid levels. In contrast, the VIP segment remained at around 25% of its pre-pande-

mic levels.

Looking ahead, Deutsche Bank forecasts May GGR in Macau to reach just under USD2.45 billion, representing a 2% monthly sequential increase per day, compared to the 2.6% average seen in previous Mays.

The April results bring Macau's total GGR for the first four months of 2024 to MOP75.87 billion, up 53.7% year-on-year

and equivalent to 76.1% of pre--pandemic levels seen in the same period of 2019.

Brokerage CLSA recently revised upwards its 2024 GGR forecast for Macau, estimating a full year tally of USD30.3 billion due to higher visitation trends in traditionally slower months. If accurate, the updated projection would see Macau's GGR growing by 34% year-on-year from USD22.8 billion in 2023.

Citigroup's monthly survey of Macau's premium mass gaming tables indicated that player quality remained robust in April. However, the institution noted that Macau GGR in April was likely generated by fewer "premium-mass players" compared to previous months, due to the timing of the Labour Day holidays on the Chinese mainland, Macau's primary source of tourism.

MGM executes strong first quarter performance with record-breaking revenues

GM China Holdings Limited has reported record--breaking financial results for the first quarter of 2024, outperforming the industry's recovery in Macau.

The casino operator saw net revenue surge 70.6% year-on--year to HKD8.3 billion, reaching 143% of pre-pandemic levels in the first quarter of 2019. Adjusted EBITDA skyrocketed 77.3% to HKD2.5 billion, marking a new high and representing 155% of Q1 2019 figures.

MGM China's market share in Macau reached an all-time high of 17% in the first quarter, up from 15.2% in 2023 and 9.5% in 2019. The company's mass market gaming segment saw particularly strong growth, with mass GGR recovering to approximately 110% of pre-COVID le-

"We are delighted to have achieved record-breaking results in the first quarter this year. This is mainly driven by the Company's deep understanding of the market, especially our extensive insights in premium mass customers," said Kenneth Feng, president and executive director of MGM China.

"Our efficient and agile business strategies are the key driving factor for us to seize opportunities arising from the resumption of global tourism," he added.

Meanwhile, as cited in an earnings call with analysts, MGM Resorts noted that MGM China and MGM Resorts both agree there is no longer a need for MGM to support its liquidity. In March, the subordinated loan agreement was terminated.

Bill Hornbuckle, CEO and president of MGM Resorts, revealed that new villas at MGM Macau and Suites in Cotai will be introduced because, in his words, "We are under-seated in that market."

LEADING MARKET IN SMART TABLE IMPLEMENTATION

The gaming operator asserts that it has "at least several years lead" in the implementation and use of "smart tables" over its competitors in the Macau casino market.

In the earnings call, Hubert Wang, president and COO of MGM China, stated that while other operators are striving to adopt smart tables, MGM China has a significant advantage.

These smart tables enable gaming chip tracking and authenti-



cation, providing operators with valuable customer data for precision marketing and new game development. "For instance, we already launched insurance [bet] baccarat in this market and this is impossible to do manually," Wang said.

Feng, meanwhile, noted the company had this technology in place since 2016, giving it a significant head start. Feng credited

the company's "deep understanding" of its premium mass customers as a key differentiator, stating, "What differentiates us in the market is that company-wide, we possess a deep outstanding of our customers, particularly the premium mass segment, encompassing their culture, habits, behavior, background profiles, and even their home provinces and dialects."

MELCO TO EXPAND PORTFOLIO IN Sri Lanka, gains recovery in Q1

LYNZY VALLES

MELCO Resorts & Entertainment Limited is working with John Keells Group in Sri Lanka to develop a groundbreaking integrated resort in central Colombo, with an investment exceeding USD1 billion.

Formerly known as the "Cinnamon Life Integrated Resort," the integrated resort will be rebranded as City of Dreams Sri Lanka and will be the first of its kind in Sri Lanka and South Asia.

The gaming operator's local subsidiary has obtained a 20-year gambling license from the Sri Lankan government, and is set to supervise the casino activities at City of Dreams Sri Lanka and take charge of the uppermost five levels of the hotel, operating under its Nuwa label, providing ultra-luxurious accommodations.

The rebranded property will offer 800 hotel rooms, as well as retail outlets, food and beverage options, MICE facilities, and more.



"We will be responsible for the fit-out and operations of the casino, which we expect to open in mid-2025, while the City of Dreams Sri Lanka Integrated Resort itself is expected to open in the third quarter of 2024," Lawrence Ho, Chairman & CEO of Melco Resorts, said in an earnings call with analysts.

Meanwhile, Ben Lee, managing partner at IgamiX, said that the reliance on the Indian feeder market will be an "interesting challenge as no major jurisdictions have been able to successfully develop that market."

"There is however some anecdotal data to suggest that there is some chinese business to be had on the ground, presumably from the BRI participants involved in local projects," he told the Times.

Moreover, Melco has hired Tim Kelly as the property president of City of Dreams Macau.

Kelly, a former executive at Wynn Palace and Atlantis Dubai, has a strong background in the integrated resort industry, having started his career at MGM Grand in Las Vegas.

REVENUES AT USD1 BILLION

Melco Macau's first quarter property EBITDA reached 89% of 2019 levels as operating revenues for the quarter reached USD1.11 billion, a 55% increase compared

to the same period in 2023.

The operating income for the $first\,quarter\,of\,2024\,was\,USD125.4$ million, a significant improvement compared to MOP0.4 million in the first quarter of 2023.

Melco generated Adjusted Property EBITDA of MOP298.8 million in the first quarter of 2024, compared to MOP190.8 million in the same period last year.

In the sam earnings call with analysts, Ho said that in March, both City of Dreams Macau and Studio City "recorded the highest [number of] mass table games dropped ever.'

"In April, we continued to gain market share, recording the highest daily gaming revenue since Macau's reopening in January 2023," he added.

Meanwhile, the executive has hailed initiatives recently announced by the Chinese government, such as the multi-entry group tour visas between Macau and Hengqin, the new cities added to the Individual Visit Scheme (IVS) in March.

"An easier online visa application process for residents of China's 20 largest cities, along with the proposed connection of Shenzhen to the Macau Zhuhai bridge, increases accessibility to Macau and enlarges our customer base," he said.

Criminal group caught exploiting counterfeit chips in casino

THE Judiciary Poli-L ce (PJ) uncovered a large-scale fraud operation involving a criminal group using counterfeit casino chips. The case involves 14 suspects, all mainlanders.

The police received a report stating that fake chips had been used in a casino.

During the investigation, it was discovered that 13 gamblers had used fake chips. The police quickly conducted an investigation in collaboration with security guards and identified five men suspected of deliberately using fake chips in the casino.

An investigation revealed that on April 30, the group of suspects arrived in Macau from the mainland.

They inspected the ca-

sino where the fraud occurred and divided their fake chips into multiple pockets.

The five suspects brought MOP10,000 worth of fake chips to the casino for gambling. After the crime, they returned to the mainland and divided the stolen proceeds among themselves. They successfully defrauded the casino using at least 149 counterfeit chips, causing a temporary loss of MOP1.8 million according to the gaming company's assessment.

The PJ found a total of 585 fake chips, equivalent to HKD5.84 million, with 130 of them in the casino and 113 on the five detainees.

When questioned, suspects revealed that the criminal group organized and centralized their planning and training at a mainland

hotel, where they were briefed by the syndicate's leadership on the plan, trained in the modus operandi, and supplied with fake chips.

Upon entering a casino, they mixed genuine casino chips with fake chips concealed in their

Some individuals involved in the case managed to evade capture due to the criminal group's decentralized structure, with regular members never meeting the kingpin of the group in person. Communication was strictly limited to text messages, with no video or voice calls to further conceal their identities.

The fugitives remain at large and investigations are ongoing to apprehend other individuals associated with the syndicate.

Microsoft will invest \$2.2 billion in cloud and Al services in Malaysia

ICROSOFT is investing \$2.2 billion over the next four years in Malaysia's new cloud and artificial intelligence infrastructure as well as partnering with the government to establish a national AI center, its CEO Satya Nadella said yesterday.

It marks Microsoft's single largest investment in Malaysia, as the tech giant seeks to bolster support for AI development in the region and worldwide.

"We are committed to supporting Malaysia's AI transformation and ensure it benefits all Malaysians," he said. "Our investments in digital infrastructure and skilling will help Malaysian businesses, communities and developers apply the latest technology to drive inclusive economic growth and innovation across the country."

Nadella on Tuesday also announced a \$1.7 billion investment in cloud and AI services in Indonesia during his visit there as part of his Southeast Asia tour. On Wednesday, he said Microsoft will build its first regional data center in Thailand.

In April, the tech giant similarly unveiled a \$2.9 billion investment in Japan and \$1.5 billion in G42, an AI firm in Abu Dhabi.

Microsoft also pledged to provide AI training for 2.5 million people in Malaysia, Indonesia,

the Philippines, Thailand and Vietnam by 2025.

Nadella earlier met Prime Minister Anwar Ibrahim, who said the investment will be the key support pillar for the government's goal to enhance AI capacity in Malaysia.

The new investment will include AI training for another 300,000 people, the establishment of a national AI center of excellence, enhancing the nation's cybersecurity capabilities and supporting the growth of Malaysia's developer community, Anwar said on Facebook.

Microsoft runs one of the world's largest cloud computing operations and has taken a leap into artificial intelligence through its partnership with OpenAI, developers of ChatGPT.

Since then, Microsoft has integrated an AI assistant into its Microsoft Edge browser, named Copilot, helping lift its profits by 20% in the first quarter.

Microsoft sees Southeast Asia, with its population of over 600 million people, as a growing market and potential location for more AI product development. A study held by global consulting firm Kearney said AI could contribute nearly \$1 trillion to Southeast Asia's GDP by 2030. Indonesia is expected to capture \$366 billion of the total and Malaysia \$115 billion. MDT/AP

RENOWNED EDUCATOR SAYS MACAU CAN HELP **OVERCOME EAST-WEST MISUNDERSTANDINGS**

INTERVIEW BY HOWARD TONG

ROFESSOR Tang Lixing, the chair professor and doctoral supervisor of the Chinese Teacher Development Center at New York University, who recently visited Macau, strongly advocates for the significance of cultural exchanges between China and foreign countries, particularly in the field of education.

In an exclusive interview with the Macau Daily Times, Professor Tang highlighted the importance of education in promoting understanding and suggested that schools and educational agencies have a crucial role to play in facilitating international exchan-

He specifically emphasized the unique position of Macau, with its rich history of cultural exchange spanning almost 500 years between the East and the West. Professor Tang believes that Macau can leverage this history to foster cultural exchanges, enhance mutual understanding among nations and individuals, and utilize education to cultivate intercultural competence.

"I think it has everything to do with the education of the next generation. It's not just between nations, but it's between people. Schools, and educational agencies are the best route for international exchanges. Now,

take me for example. I've been teaching in the United States for over 30-plus years. But my roots are in China. So, I'm more of a bicultural and bilingual person. And I feel there's such a need for people in both nations and around the world to get to know each other."

"I have seen too many misunderstandings. I don't think the Chinese people understand the West the same way the West understands the Chinese."

He believes that these misunderstandings arise from a lack of knowledge and exposure to each other's cultures. Through cultural exchanges, he aims to bridge these gaps and foster a deeper understanding between different societies.

The professor shares his involvement in bringing Chinese students to the United States and American students to China, promoting cultural exchange, and addressing misunderstandings. He highlights the need for people from both nations to get to know each other and advocate for dialogue between individuals rather than just governments.

He further elaborates on how Macau can utilize its distinctive global position to facilitate meaningful exchanges between the East and the West. One of his suggestions is for universities in Macau to admit a greater number of international students and promote diversity among faculty members. Although he acknowledges that efforts have been made to internationalize universities and the broader SAR, he believes that there is still room for further progress in this regard.

To facilitate cultural exchanges, Professor Tang advocates for a two-way flow of students and scholars between countries. By immersing themselves in different cultural contexts, students gain a broader perspective and develop a more nuanced understanding of each other's societies.

"The number one [measure] is to bring international students in. Once you have brought them in, you need to create opportunities to have local students and international students mingle together." he said, offering ideas such as mixed dormitories, group projects, and studies on the unique differences and commonalities between East and West."

"Secondly, allow Macau students to go out of Macau. So instead of studying for four years, for example, for an undergraduate locally, consider allowing them to study in, say, Shanghai, Beijing, New York, London, or Paris. In other words, give them opportunities to see the world, enabling them to broaden their perspectives and interact with people from diverse backgrounds."

With its unique history of cultural exchange, Macau can leverage its position to foster cultu-

ral exchanges, enhance mutual understanding, and promote intercultural competence. The professor advocates for dialogue between individuals and suggests these practical measures to promote cross-cultural interactions in Macau's universities.

Professor Tang was in Macau last week at the invitation of the Macau University of Science and Technology (MUST) as part of its 24th anniversary activities.

In a ceremony held on April

24, Professor Tang Lixing was appointed Distinguished Professor and gave a lecture on "Humanizing teaching: A humanistic approach to teaching languages," which attracted over a hundred graduate students from MUST School of International Studies.

His views are particularly relevant in the context of the Greater Bay Area's goals to enhance international connectivity and foster an environment of cultural and educational exchange.

As of the latest official data, there are over 22 thousand international students in universities across Guangdong province. The largest groups come from South Korea, Thailand, and Russia, with substantial numbers also arriving from Vietnam and Indonesia. Students from nearby regions, such as Hong Kong and Macau, also contribute notably to the international student body in Guangdong.

Death toll jumps to 48 as search continues in highway collapse

HE death toll from a collapsed highway in southeastern China climbed to 48 yesterday as searchers dug for a

HE death toll from a second day through a treachecollapsed highway in rous and mountainous area.

One side of the four-lane highway in the city of Meizhou gave way about 2 a.m.

on Wednesday after a month of heavy rains in Guangdong province. Twenty-three vehicles fell down a steep slope, some sending up flames as they caught fire. Construction cranes were used to lift out the burnt-out and mutilated vehicles.

Officials in Meizhou said three other people were unidentified, pending DNA testing. It wasn't immediately clear if they had died, which would bring the death toll to 51. Another 30 people had non-life-threatening injuries.

The search was still ongoing, Meizhou city Mayor Wang Hui said at a late-afternoon news conference. No foreigners have been found among the victims, he said.

Search work has been hampered by rain and land and gravel sliding down the slope. The disaster left a curving earth-colored gash in the otherwise verdant forest landscape. Excavators dug out a wider area on the slope.

"Because some of the vehicles involved caught fire, the difficulty of the rescue operation has increased," said Wen Yongdeng, the Communist Party secretary for the Meizhou emergency management bureau.

"Most of the vehicles were buried in soil during the collapse, with a large volume of soil covering them," he said.

He added that the prolonged heavy rainfall has saturated soil in the area, "making it prone to secondary disasters during the rescue process."

Over 56 centimeters of rain has fallen in the past four weeks in the county where the roadway collapsed, more than four times as much as last year. Some villages in Meizhou flooded in early April, and the city has seen more rain in recent days.

Parts of Guangdong province have seen record rains and flooding in the past two weeks, as well as hail. A tornado killed five people in Guangzhou, the provincial capital, during rain and hail storms last weekend.

The highway section collapsed on the first day of a five-day May Day holiday, when many Chinese are traveling at home and abroad.

Chinese leader Xi Jinping said that all of China's regions should improve their monitoring and early warning measures and investigate any risks to ensure the safety of the public and social stability, state broadcaster CCTV said. MDT/AP

Over 40% of Americans see China as 'an enemy': Pew report

MORE than 40% of Americans now label China as an enemy, up from a quarter two years ago and reaching the highest level in five years, according to an annual Pew Research Center survey released yesterday [Macau time].

Half of Americans think of China as a competitor, and only 6% consider the country a partner, according to the report. The findings come as the Biden administration is seeking to stabilize U.S.-China relations to avoid miscalculations that could result in clashes, while still trying to counter the world's second-largest economy on issues from Russia's war in Ukraine to Taiwan and human rights.

Secretary of Sta-



te Antony Blinken and Treasury Secretary Janet Yellen have both recently visited China in the administration's latest effort to "responsibly" manage the competition with Beijing.

Despite those overtures, President Joe Biden has been competing with former President Donald Trump, the presumptive Republican nominee in November's election, on being tough on China.

The Pew report, which is drawn from an April 1-7 survey of a sample of 3,600 U.S. adults, found that roughly half of Americans think limiting China's power and influence should be a top U.S. foreign policy priority. Only 8% don't think it should be a priority at all.

For the fifth year in a row, about eight in 10 Americans report an unfavorable view of China, the Pew report said.

"Today, 81% of U.S. adults see the country unfavorably, including 43% who hold a very unfavorable opinion. Chinese President Xi Jinping receives similarly negative ratings," the report said.

About eight in 10 Americans say they have little or no confidence in Xi to do the right thing regarding world affairs. About 10% said they have never heard of him.

American attitudes

toward China have turned largely critical after the U.S. launched a trade war against China in 2018 and since the emergence of CO-VID-19, which was first reported in China.

At the same time, the U.S. government has been overt about competing with China on economic and diplomatic issues.

Following that, 42% of Americans say China is "an enemy of the U.S.," the highest level since 2021, when Pew began asking the question.

The share is much larger among Republicans and Republican-leaning independents, Pew said, with 59% of them describing China as an enemy, compared with 28% of Democrats and those leaning Democratic.

Older Americans, conservative Republicans and those with a sour view of the U.S. economy are more critical of China and more likely to consider the country an enemy, the report said. MDT/AP

Virologist Zhang Yongzhen allowed BACK IN HIS LAB AFTER SIT-IN PROTEST

DAKE KANG, BEIJING

THE first scientist to publish a **■** sequence of the COVID-19 virus in China said he was allowed back into his lab after he spent days locked outside, sitting in protest.

Zhang Yongzhen wrote in an online post on Labor Day, just past midnight, that the medical center that hosts his lab had "tentatively agreed" to allow him and his team to return and continue their research for the time being.

"Now, team members can enter and leave the laboratory freely," Zhang wrote in a post on Weibo. He added that he is negotiating a plan to relocate the lab in a way that doesn't disrupt his team's work with the Shanghai Public Health Clinical Center, which hosts Zhang's lab.

Zhang and his team were suddenly told they had to leave their lab for renovations last week, setting off the dispute, he said in an earlier post that was later deleted.

On Sunday, Zhang began a sit-in protest outside his lab after he found he was locked out, a sign of continuing pressure on Chinese scientists conducting research on the coronavirus.

Zhang sat outside on flattened cardboard in drizzling rain, and members of his team unfurled a banner that read "Resume normal scientific research work," pictures posted online show. News of the protest spread widely on Chinese social media, putting pressure on local authorities.

In an online statement Monday, the Shanghai Public Health Clinical Center said that Zhang's lab was closed for "safety reasons" while being renovated. It added that it had provided Zhang's team an alternative laboratory space.

But Zhang responded the same day his team wasn't offered an alternative until after they were notified of their eviction, and the lab offered didn't meet safety standards for conducting their research, leaving his team in limbo.

Zhang's ordeal started when he and his team decoded the virus on Jan. 5, 2020, and wrote an internal notice warning Chinese authorities of its potential to spread — but did not make the sequence

Foreign scientists soon learned that Zhang and other Chinese scientists had deciphered the virus and called on China to release the sequence. Zhang published it on Jan. 11, 2020, despite a lack of permission from Chinese health

Sequencing a virus is key to the development of test kits, disease control measures and vaccinations. The virus eventually spread to every corner of the world, triggering a pandemic that disrupted lives and commerce, prompted widespread lockdowns and killed millions of people.

Zhang was awarded prizes overseas in recognition for his work. But health officials removed him from a post at the Chinese Center for Disease Control

and Prevention and barred him from collaborating with some of his former partners, hindering his research.

Still, Zhang retains support from some in the government. Though some of Zhang's online posts were deleted, his sit-in protest was reported widely in China's state-controlled media.

"Thank you to my online followers and people from all walks of life for your concern and strong support over the past few days!" Zhang wrote in his post Wednesday. MDT/AP

Misinformation surges on social media: 'The whole country is paying the price'

OLLYWOOD stars seldom weigh in on politics, so videos showing two celebrities criticizing Indian Prime Minister Narendra Modi — and endorsing his main opposition, the Congress party — were bound to go viral.

But the clips of A-list actors Aamir Khan and Ranveer Singh were fake, AI-generated videos that were yet another example of the false or misleading claims swirling online with the goal of influencing India's election. Both actors filed complaints with police but such actions do little to stanch the flow of such misinformation.

Claims circulating online in India recently have misstated details about casting a ballot, claimed without evidence that the election will be rigged, and called for violence against India's Muslims.

Researchers who track misinformation and hate speech in India say tech companies' poor enforcement of their own policies has created perfect conditions for harmful content that could distort public opinion, spur violence and leave millions of voters wondering what to believe.

"A non-discerning user or regular user has no idea whether it's someone, an individual sharing his or her thoughts on the

other end, or is it a bot?" Rekha Singh, a 49-year-old voter, told The Associated Press. Singh said she worries that social media algorithms distort voters' view of reality. "So you are biased without even realizing it," she said.

In a year crowded with big elections, the sprawling vote in India stands out. The world's most populous country boasts dozens of languages, the greatest number of WhatsApp users as well as the largest number of YouTube subscribers. Nearly 1 billion voters are eligible to cast a ballot in the election, which runs into June.

Tech companies like Google and Meta, the owner of Facebook, WhatsApp and Instagram, say they are working to combat deceptive or hateful content while helping voters find reliable sources. But researchers who have long tracked disinformation in India say their promises ring hollow after years of failed enforcement and "cookie-cutter" approaches that fail to account for India's linguistic, religious, geographic and cultural diversity.

Given India's size and its importance for social media companies, you might expect more of a focus, say disinformation researchers who focus on India.

"The platforms are earning money off of this. They are benefiting from it, and the whole country is paying the price," said Ritumbra Manuvie a law professor at the University of Groningen in the Netherlands. Manuvie is a leader of The London Story, an Indian diaspora group which last month organized a protest outside Meta's London offices.

Research by the group and another organization, India Civil Watch International, found that Meta allowed political advertisements and posts that contained anti-Muslim hate speech, Hindu nationalist narratives, misogynistic posts about female candidates as well as ads encouraging violence against political opponents.

The ads were seen more than 65 million times over 90 days earlier this year. Together they cost more than \$1 million.

Meta defends its work on global elections and disputed the findings of the research on India, noting that it has expanded its work with independent fact-checking organizations ahead of the election, and has employees around the world ready to act in case its platforms are misused to spread misinformation. Nick Clegg, Meta's president of global affairs, said of India's election: "It's a huge, huge test for us."

"We have months and months and months of preparation in India," he told The Associated Press during a recent interview. "We have teams working around the clock. We have fact checkers in multiple languages operating in India. We have a 24-hour escalation system."

YouTube is another problema-

tic site for disinformation in India, experts say. To test how well that video-sharing platform was doing in enforcing its own rules, researchers at the nonprofits Global Witness and Access Now created 48 fake ads in English, Hindi and Telugu with false voting information or calls for violence. One claimed India raised its voting age to 21, though it remains 18, while another said women could vote by text message, though they cannot. A third called for the use of force at polling places.

When Global Witness submitted the ads to YouTube for approval, the response was disappointing, said Henry Peck, an investigator at Global Witness.

"YouTube didn't act on any of them," Peck said, and instead approved the ads for publication.

Google, YouTube's owner, criticized the research and noted that it has multiple procedures in place to catch ads that violate its rules. Global Witness removed the ads before they could be spotted and blocked, the company said.

"Our policies explicitly prohibit ads making demonstrably false claims that could undermine participation or trust in an election, which we enforce in several Indian languages," Google said in a statement. The company also noted its partnerships with fact-checking groups.

AI is this year's newest threat, as advances in programs make it easier than ever to create lifelike images, video or audio. AI deepfakes are popping up in elections across the world, from Moldova to Bangladesh.

Senthil Nayagam, founder of an AI startup called Muonium AI, believes there is growing demand for deepfakes, especially of politicians. In the run up to the election, he had several inquiries on making political videos using AI. "There's a market for this, no doubt," he said.

Some of the fakes Nayagam produces feature dead politicians and are not meant to be taken seriously, but other deepfakes circulating online could potentially fool voters. It's a danger Modi himself has highlighted

"We need to educate people about artificial intelligence and deepfakes, how it works, what it can do," Modi said.

India's Information and Technology Ministry has directed social media companies to remove disinformation, especially deepfakes. But experts say a lack of clear regulation or law focused on AI and deepfakes makes it harder to squash, leaving it to voters to determine what is true and what is fiction.

For first-time voter Ankita Jasra, 18, these uncertainties can make it hard to know what to believe.

"If I don't know what is being said is true, I don't think I can trust in the people that are governing my country," she said.

MAY DAY

Workers' rallies confront turbulent times around the world

ORKERS and activists around the world marked May Day with largely peaceful protests on May 1st over rising prices, low wages and calls for greater labor rights. Pro- Palestinian sentiments were also on display.

Police in Istanbul used tear gas and fired rubber bullets to disperse thousands of people who tried to break through a barricade and reach the main Taksim square in defiance of a ban. Interior Minister Ali Yerlikaya said at least 210 people were detained.

President Recep Tayyip Erdogan's government has long declared Taksim off-limits for demonstrations on security grounds. In 1977, unidentified gunmen opened fire on a May Day celebration there, causing a stampede and killing 34 people. Yesterday [Macau time], a small group of trade union representatives lay a wreath at a monument to victims.

May Day, which falls on May 1, is observed to celebrate workers' rights. It's also an opportunity to air economic grievances or political demands. "Tax the rich," one banner in Germany read. "Don't touch the eight-hour workday!" another read in Sri Lanka.

In Paris, police fired tear gas as thousands of protesters marched through the French capital, seeking better pay and working conditions. Police said 12 officers were hospitalized after a homemade explosive was set off on the sidelines of the march and at least 45 people were detained after instances of scattered violence

Pro-Palestinian groups joined the Paris rally, chanting slogans in support for people in Gaza. There were similar scenes in other parts of the world. In Greece, pro-Palestinian protesters joined May Day rallies, waving a giant Palestinian flag as they marched past the Greek parliament. Others displayed banners in support of pro-Palestinian protesting students in the United States.

Several thousand protesters joined the Athens marches as labor strikes disrupted public transport across Greece. The largest union demands a return to collective bargaining after labor rights were scrapped during the 2010-18 financial crisis.

In the German capital, around 11,600 people marched through the immigrant neighborhoods of Kreuzberg and Neukoelln, waving Palestinian flags and holding banners that read "No weapons for Israel" or "Free Palestine," German news agency dpa reported.

Throughout Latin America, workers marched to protest austerity measures and demand higher wages. In Argentina, unions galvanized crowds to vent their rage over libertarian President Javier Milei's economic policies, which they say benefit the wealthy while inflicting pain on the poor and middle class.

"Paying rent is difficult, buying rice is difficult, everything under this guy (Milei) is difficult," said 40-year-old garbage collector Leandro Rosas, trailing protesters down the street with a broom because this May Day, he said he couldn't even surrender a shift's pay.

Meanwhile, Bolivian President Luis Arce joined the workers' march and decreed a 5.8% increase in the national minimum wage, a bid to mobilize support as a worsening economic crisis raises the specter of social unrest. The thousands-strong protests in Santiago, Chile, turned violent in some areas as security forces unleashed water cannons and tear gas on corwds, drenching and dispersing protesters who vandalized shops and government buildings.

In Brazil, President Luiz Inácio Lula da Silva ratified a law that extends income tax exemptions to those earning up to two minimum wages per month, or about \$544.

"In our country there will be no tax breaks to favor the richest, but to favor those who work and live off their wages," Lula told a crowd sweltering in the sun at a soccer stadium in São Paulo.

In Nigeria, where inflation is the highest in 28 years, at over 33%, unions demanded bigger salary increases. In South Africa, pro-Palestinian demonstrators joined May Day events and in Kenya, President William Ruto called for an increase in the country's minimum wage.

In Lebanon, pro-Palestinian marchers mingled with

workers demanding an end to a miserable economic crisis. "Politicians do not feel the pain of the worker or the economic conditions," said one demonstrator, Abed Tabbaa. In Iraq, protesters demanded better wages, the reopening of closed factories and the end to privatization of certain businesses.

Tens of thousands Sri Lankans paraded through the capital as the country struggles through its worst economic crisis, two years after declaring bankruptcy. Discontent has grown over efforts to increase revenue by raising the price of electricity and imposing taxes on professionals and small businesses.

In South Korea's capital, thousands of protesters shouted pro-labor slogans at a rally that organizers said was meant to step up criticism of what they call anti-labor policies pursued by President Yoon Suk Yeol's conservative government.

"In the past two years under the Yoon Suk Yeol government, the lives of our laborers have plunged into despair," Yang Kyung-soo, leader of the Korean Confederation of Trade Unions, said in a speech. Union members criticized Yoon's recent veto of a bill aimed at limiting companies' rights to seek compensation for damages caused by union strikes.

In Japan, more than 10,000 people gathered in Tokyo, demanding salary increases to set off price increases.

Indonesian workers demanded protections for migrant workers abroad and a minimum wage raise. They gathered amid a tight police presence, chanting slogans against the new Job Creation Law and loosened outsourcing rules.

In the Philippines, hundreds of workers and left-wing activists marched to demand wage increases and job security amid soaring food and oil prices. Riot police stopped them from getting close to the presidential palace. MDT/AP

2000 LEADING STOCK EXCHANGES PLAN MERGER



The London Stock Exchange and Germany's Deutsche Boerse have confirmed they are to merge, creating the world's second largest stock market.

The combined firms will be called iX, standing for International Exchanges.

Stock markets across Europe are already planning to group together in response to the international movement of capital.

The Paris Bourse recently announced its intention to merge with the Brussels and Amsterdam stock exchanges and rename itself Euronext. Norway, Sweden and Denmark are pooling their exchanges, too.

The London-Frankfurt venture would initially be traded in their home currencies, with a view to moving eventually to an entirely euro-based exchange.

But there could be dangers for British pensioners. The pension fund industry has warned that if firms are forced to price their shares in euros it would mean bigger risks for British investors and extra costs, too.

London Stock Exchange chief executive Gavin Casey, who will step down once the merger goes through, tried to reassure sceptics saying the plan had been driven by what customers wanted and it would build on the strengths of both organisations.

At a press conference with London stock exchange chairmen Don Cruickshank, Werner Seifert, chief executive of Deutsche Boerse and prospective chief executive of iX, emphasised the "open" nature of the agreement, particularly where other exchanges were concerned.

There are also plans to link up with New York's hi-tech exchange Nasdaq which could pave the way for a unified global stock exchange.

Nasdaq already has agreements with markets in Japan, Hong Kong and Singapore.

The merger is expected to be completed by autumn 2000.

In context

Just four months later, the merger between the two exchanges floundered.

Many of its prospective clients in the UK said there would be confusion about how iX was regulated and were unhappy that trading would eventually be carried out in euros.

Added to this, on 29 August Swedish technology company OM Group launched a hostile bid to take over the LSE. The bid failed but, as a result, the LSE board decided to drop plans for iX.

Gavin Casey resigned as chief executive and his place was taken by Clara Furse, the first woman head of the LSE.

Under her direction, the LSE tried to take over the London derivatives exchange, Liffe. It was beaten by Euronext, a consortium of leading exchanges in Paris, Brussels and Amsterdam, created in September 2000.

In April 2006 the US Nasdaq Stock Market bought a 15% share in the LSE. Two weeks later the New York Stock Exchange was reported to have made an offer to take over the LSE.



IN 'THE IDEA OF YOU,' A BOY BAND IS CENTER STAGE BUT HATHAWAY STEALS THE SHOW

thaway plays a 40-year-old divorcee and Silver Lake art gallery owner who, after taking her teenage daughter to Coachella, becomes romantically involved with a 24-year-old heartthrob in the boy band August Moon. They first meet after she mistakes his trailer for the bathroom. There are a few hundred things about this premise that might be farfetched, including the odds of finding love anywhere near the porta johns of a music festival. But one of them is not that a young star like Hayes Campbell (Nicholas Galitzine) would fall for a single mom like Solène (Hathaway).

Solène is stylish, unimpressed by Hayes' celebrity and has bangs so perfect they look genetically modified. And, most importantly, she's Anne Hathaway. In the power dynamics of "The Idea of You," Hayes may be a fictional pop star but Hathaway is a very real movie star. And you don't forget it for a moment in Michael Showalter's lightly appealing showcase of the actor at her resplendent best.

"The Idea of You," which debuts Thursday on Prime Video, is full of all the kinds of contradictions that can make a rom-com work. The highly glamorous, megawatt-smiling Hathaway is playing a down-to-earth nobody. The showbiz veteran in the movie is played by Galitzine, a less well--known but up-and--coming British actor whose performance in the movie is quite authentic. And even though the whole scenario is undeniably a glossy high-concept Hollywood fairy tale, Showalter gives it enough texture that "The Idea of You" comes off more natural and sincere than you'd expect.

The only thing that really needs to make perfect sense in a movie like "The Idea of You" is the chemistry. The film, penned by Showalter and Jennifer Westfeldt from Robinne Lee's bestseller, takes its time in the early scenes between Solène and Hayes — first at Coachella, then when he stops by her gallery allowing their rapport to build convincingly, and giving each actor plenty of time to smolder.

Once the steamy hotel-room encounters come in "The Idea of You," the movie has, if not swept you away, then at least ushered you along on a European trip of sex and room service. At the same time, it stays faithful to its central mission of celebrating middle-aged womanhood. The relationship will eventually cause a social media firestorm, but its main pressure point is whether Solène can stick with Hayes after her ex-husband (Reid Scott) cheated on her. This is a fairy tale she deserves.

While Showalter (
"The Big Sick") has long showed a great gift for juggling comedy and drama at once, "The Idea of You" leans more fully into wish-fulfillment romance. That can leave less to sustain the film, which has notably neutered some of the things that distinguished the book.

The May-December romance has been shrunk a little. In the book, the singer is 20.

Given that Galitzine is 29 and the 41-year-old Hathaway is no one's idea of old, this is more like a July-September relationship. In the book, the daughter (Ella Rubin) is a huge admirer of the pop singer, adding to the awkwardness, but in the movie, August Moon is "so 7th grade" to her.

There are surely more interesting and funnier places "The Idea of You" could have gone. But Hathaway and Galitzine are a good enough match that, for a couple hours, it's easy to forget.

But the most convincing thing about "The Idea of You"? August Moon. The movie nails the look and sound of boy bands so well because it went straight to the source. The original songs in the film are by Savan Kotecha and Carl Falk, the producer-songwriters of, among other pop hits, "What Makes You Beautiful," One Direction's debut single.

That connection will probably only further the sense that "The Idea of You" is very nearly "The Idea of Harry Styles." The filmmakers have distanced the movie from any real-life resemblances. But one thing is for sure: With August Moon following 4(asterisk)Town of "Turning Red" (whose songs were penned by Billie Eilish and Finneas O'Connell), we are living in the golden age of the fictional boy band.



Taylor Swift's 'Tortured Poets' is great sad pop, meditative theater

Who knew what Taylor Swift's latest era would bring? Or even what it would sound like? Would it build off the moodiness of "Midnights" or the folk of "evermore"? The country or the '80s pop of her latest re-records? Or its two predecessors in black-and-white covers: the revenge-pop of "Reputation" and the literary Americana of "folklore"?

"The Tortured Poets Department" is an amalgamation of all of the above, reflecting the artist who — at the peak of her powers — has spent the last few years re-recording her life's work and touring its material, filtered through synth-pop anthems, breakup ballads, provocative and matured considerations.

In moments, her 11th album feels like a bloodletting: A cathartic purge after a major heartbreak delivered through an ascendant vocal run, an elegiac verse, or mobile, synthesized productions that underscore the powers of Swift's storytelling.

And there are surprises. The lead single and opener "Fortnight" is "1989" grown up — and features Post Malone. It might seem like a funny pairing, but it's a long time coming: Since at least 2018, Swift's fans have known of her love for Malone's "Better Now."

"But Daddy I Love Him" is the return of country Taylor, in some ways — fairytale songwriting, a full band chorus, a plucky acoustic guitar riff, and a cheeky lyrical reversal: "But Daddy I love him / I'm having his baby / No, I'm not / But you should see your faces." (Babies appear on "Florida!!!" and the bonus track "The Manuscript" as well.)

The fictitious "Fresh Out The Slammer" begins with a really pretty psych guitar tone that disappears beneath wind-blown production; the new wave-adjacent "My Boy Only Breaks His Favorite Toys" brings back "Barbie": "I felt more when we played pretend than with all the Kens / 'Cause he took me out of my box."

Even before Florence Welch kicks off her verse in "Florida!!!," the chorus' explosive repetition of the song title hits hard with nostalgic 2010s indie rock, perhaps an alt-universe Swiftian take on Sufjan Stevens' "Illinois."

As another title states, "So Long, London," indeed.

It would be a disservice to read Swift's songs as purely diaristic, but that track — the fifth on this album, which her fans typically peg as the most devastating slot on each album — evokes striking parallels to her relationship with a certain English actor she split with in 2023. Place it next to a sleepy love ode like "The Alchemy," with its references to "touchdown" and cutting someone "from the team" and well ... art imitates life. MDT/AP

HIGH INTEREST RATES AREN'T GOING AWAY ANYTIME SOON

The U.S. Federal Reserve held interest rates steady at its May 1, 2024, policy meeting, dashing the hopes of potential homebuyers and others who were hoping for a cut. Not only will rates remain at their current level—a 23-year high—for at least another month, there's little reason to believe the Fed will start tapering until the fall. Indeed, if inflation starts to heat back up, it's plausible—though at the moment unlikely—that the Fed will consider ratcheting up rates another 25 basis points or so in the coming months.

As recently as a few months ago, investors were betting that 2024 would bring a slew of rate cuts.

But speaking as a business economist, I think it's clear that the latest economic data discouraged the Fed from easing up as it gathered for its latest policy meeting. There's no sign of an imminent recession. Employment is still pretty strong, with the U.S. adding 303,000 jobs in March 2024 and 270,000 in February, and the unemployment rate – at 3.8% in March – ticked up only slightly from 3.5% in March 2023. That is simply not a large enough increase to be concerned that high rates are slowing the economy down too abruptly.

While it's true that inflation-adjusted gross domestic product growth, after posting a remarkable 4.8% annualized increase in the fourth quarter of 2023, slowed significantly to 1.6% in the first quarter of 2024, slower growth is exactly what the Fed has been attempting to engineer by raising interest rates. By controlling demand for good and services, price growth slows. That's still not a recessionary indication.

Getting inflation rates down to the Fed's 2% target — a number that Federal Reserve Chair Jerome Powell repeated several times during his news conference — has been challenging, to say the least. The Fed began hiking interest rates in early 2022. Initially, it had some success in reducing inflation that had peaked at about 9% that year. Indeed, as Powell said, the reduction in inflation was historically fast, due in part to both rate increases and easing international supply chain disruptions. But since June 2023, when inflation was 3.1%, there's been little decline. Indeed, consumer price index growth hasn't fallen below 3% since March 2021.

One of the main reasons inflation has stayed high is that there aren't enough workers. Economic growth increases labor demand, and labor supply simply hasn't kept pace. The result is higher wages. With higher wages, firms need to cut costs elsewhere, increase prices, or both, to maintain profitability.

Another important driver of inflation, which Powell took pains to mention, is the rising cost of rent. With higher mortgage rates, the housing market has slowed considerably, and many Americans — especially younger ones — are renting instead of buying. Sustained demand for apartments, combined with increased costs of maintenance and upkeep of rental properties, is pressuring rents upward.

The next rate decision, in June, is "unlikely" to bring an increase indicate [and] the current regime of high rates should be sufficient to tame inflation.

Indeed, as he noted, new job openings have fallen from a peak of 12.1 million in March 2022 to 8.4 million in March 2024. While that's still high in absolute terms, it's a significant decline, which suggests slower labor demand. This should then reduce pressure on wages.

So, what about rate cuts? After all, some observers were expecting rate cuts to begin this summer. Based on the information I'm looking at, that is simply not going to happen. No move will occur until September at the earliest. Until then, expect a sluggish housing market and costly borrowing, but moderating inflation and slow but steady growth.

The White House has a new curator and Donna Hayashi Smith is the first Asian American to hold the post.


The White House announced her appointment yesterday [Macau time], the start of Asian American, Native Hawaiian and Pacific Islander Heritage Month.

As curator, Hayashi Smith will oversee the care of thousands of artifacts in the White House collection, cataloguing and preserving everything from presidential portraits to furniture and more.

Hayashi Smith led the curator's office through a process in 2022 to ensure that the White House continues to be recognized nationally as an accredited museum.

First lady Jill Biden cited Hayashi Smith's service under five presidential administrations and said she looked forward to working with her to preserve the White House's "living history."

AMID RISING ANTISEMITISM

HOLOCAUST SURVIVORS TAKE ON DENIAL AND HATE IN NEW DIGITAL CAMPAIGN

HERBERT Rubinstein was 5 years old when he and his mother where taken from the Jewish ghetto of Chernivtsi and put on a cramped cattle wagon waiting to take them to their deaths. It was 1941, and Romanians collaborating with Germany's Nazis were rounding up tens of thousands of Jews from his hometown in what is now southwestern Ukraine.

"It was nothing but a miracle that we survived," Rubinstein told The Associated Press during a recent interview at his apartment in the western German city of Duesseldorf.

The 88-year-old Holocaust survivor is participating in a new digital campaign called #CancelHate. It was launched yesterday by the New York-based Conference on Jewish Material Claims Against Germany, also referred to as the Claims Conference.

It features videos of survivors from around the globe reading Holocaust denial posts from different social media platforms. Each post illustrates how denial and distortion can not only rewrite history but perpetuate antisemitic tropes and spread hate.

"I could never have imagined a day when Holocaust

survivors would be confronting such a tremendous wave of Holocaust denial and distortion, but sadly, that day is here," said Greg Schneider, executive vice president of the Claims Conference.

"We all saw what unchecked hatred led to — words of hate and antisemitism led to deportations, gas chambers and crematoria," Schneider added. "Those who read these depraved posts are putting aside their own discomfort and trauma to ensure that current and future generations understand that unchecked hatred has no place in society."

The Claims Conference's new digital campaign comes at a time when antisemitic incidents, triggered by Hamas' deadly attack on Israel on Oct. 7 and Israel's ensuing military campaign in Gaza, have increased from Europe to the U.S. and beyond, to levels not seen in decades, according to major Jewish organizations.

Hamas and other militants abducted around 250 people in the attack and killed around 1,200, mostly civilians. They are still believed to be holding around 100 hostages and the remains of some 30 others. The war has ground on with little end in sight: Israel's offensive in Gaza has killed over 34,000 Palestinians, displaced around 80% of the population and pushed hundreds of

thousands of people to the brink of famine.

The war has inflamed tensions around the world and triggered pro-Palestinian protests, including at college campuses in the U.S. and elsewhere. Israel and its supporters have branded the protests as antisemitic, while critics of Israel say it uses such allegations to silence opponents.

The launch of the Claims Conference campaign also comes days before Yom HaShoah — Israel's Holocaust Remembrance Day next Monday.

In one of the videos, Rubinstein reads out a hate post — only to juxtapose it with his personal testimony about his family's suffering during the Holocaust.

"We have all been cheated, lied to, and exploited. The Holocaust did not happen the way it is written in our history books," he reads and then says: "That is a lie. The Holocaust happened. Unfortunately, way too many members of my family died in the Holocaust."

Rubinstein then continues to talk about his own persecution as a Jewish child during the Holocaust. While forced into the ghetto of Cernisvtsi, his family managed to obtain forged Polish identity documents, which were the only reason he and his mother were taken off the cattle train in 1941. Gaza Strip If the Israel-Hamas war stopped today, it would still take until 2040 to rebuild all the homes that have been destroyed in nearly seven months of Israel's bombardment and ground offensives in the territory, according to United Nations estimates released yesterday. The U.S. has pressured Israel to increase aid deliveries during the war, and yesterday [Macau time], Israel reopened a border crossing with hard-hit northern Gaza Strip for the first time since it was damaged at the start of the war.



USA President Joe Biden is staying mum about student protests and police crackdowns as Republicans try to turn campus unrest over the war in Gaza into a campaign cudgel against Democrats. Tension at colleges and universities has been building for days as some demonstrators refuse to remove encampments and administrators turn to law enforcement to clear them by force, leading to clashes that have seized attention from politicians and the media.



Congo is struggling to contain its biggest mpox outbreak, and scientists say a new form of the disease detected in a mining town might more easily spread among people. Since January, Congo has reported more than 4,500 suspected mpox cases and nearly 300 deaths, numbers that have roughly tripled from the same period last year, according to the World Health Organization. Congo recently declared the outbreak across the country a health emergency.
