CHINA'S REFORM IN THE NEW ERA: OPPORTUNITIES FOR THE WORLD

The 20th Central Committee of the Communist Party of China (CPC) has just successfully concluded its third plenary session in Beijing. The Resolution of the Central Committee of the Communist Party of China on Further Deepening Reform Comprehensively to Advance Chinese Modernization is the most important outcome of the Session, which is a new blueprint for China's reform and opening up, sending a strong message to the world on China's steadfast commitment to reform and opening up as well as creating more opportunities for the world in the new era.

Reform and opening up have been crucial to the cause of the Party and the people, enabling us to catch up with the times in great strides.

The Third Plenary Session of the 18th CPC Central Committee ten years ago was of epoch-making significance. China has remained the world's largest trader in goods for seven years running, and the world's largest exporter and second-largest importer for 15 consecutive years. It has been among the world's top three sources of outbound investment for 11 years in a row. 155 countries and regions around the world are beneficiaries of the funding that China provides.

As Chinese modernization has been advanced continuously through reform and opening up, it will surely embrace broader horizons through further reform and opening up.

The present and the near future constitute a critical period for our endeavor to build a great country and move toward national rejuvenation on all fronts through Chinese modernization. To deal with complex environments both at home and abroad, adapt to the new round of scientific and technological revolution and industrial transformation, and live up to the new expectations of our people, it is vital that we continue to advance reform. It was pointed out at the Third Plenary Session of the 20th CPC Central Committee that the overall objectives of further deepening reform comprehensively are to continue improving and developing the system of socialism with Chinese characteristics and modernize China's system and capacity for governance. By 2035, China will have finished building a high-standard socialist market economy in all respects, further improved the system of socialism with Chinese characteristics, generally modernized our system and capacity for governance, and basically realized socialist modernization. All of this will lay a solid foundation for building China into a great modern socialist country in all respects by the middle of this century. To steadily advance reform, we will focus on building a high-standard socialist market economy, advancing whole-process people's democracy, developing a strong socialist culture in China, raising the people's quality of life, building a Beautiful China, advancing the Peaceful China Initiative to a higher level, and improving the Party's capacity for leadership and long-term governance. In order to realize these reform goals, the Resolution elaborates on reform plans in specific fields such as the economy, politics, culture, society, environmental conservation, national security, and national defense and the military, involving over 300 concrete measures. It has been made clear that the reform tasks laid out in the Resolution shall be completed by the time the People's Republic of China celebrates its 80th anniversary in 2029.

Chinese modernization is the modernization of peaceful development.

The Resolution solemnly states that China remains firm in pursuing an independent foreign policy of peace and is dedicated to promoting a human community with a shared future. We will stay committed to the common values of all humanity, pursue the Global Development Initiative, the Global Security Initiative, and the Global Civilization Initiative, and call for an equal and orderly multipolar world and universally beneficial and inclusive economic globalization. We will deepen institutional reforms related to the work of foreign affairs and get involved in leading the reform and development of global governance system. We will resolutely safeguard China's sovereignty, security, and development interests and foster a favorable external environment for further deepening reform comprehensively to advance Chinese modernization. In addition, more development opportunities will emerge because of China's reform and Chinese modernization. The important reform measures enshrined in the Resolution include steadily expanding institutional opening up, deepening the foreign trade structural reform, further reforming the management systems for inward and outward investment, optimizing the layout for regional opening up, and improving the mechanisms for high-quality cooperation under the Belt and Road Initiative, among others. I believe that the implementation of these measures will enhance various institutions and mechanisms, remove obstacles, provide a steady source of dynamism for Chinese modernization, and create more opportunities for China and the rest of the world to deepen mutually beneficial cooperation and thrive and prosper together. The first half of 2024 has seen China's economy doing better in speed and quality, with GDP growing by 5% and investment in high-tech sectors rising by 10.6%. The International Monetary Fund has revised up its forecast for China's economic growth rate in 2024. The global business community has also expressed stronger optimism about China's economic prospects, with new foreign enterprises in China increasing by 14.2%. China welcomes all countries to actively integrate into the Chinese market and share China's development opportunities, so as to achieve common development and deliver benefits to all the people

Macao plays an integral part in China's further comprehensively deepening reform.

The Resolution underlines supporting Hong Kong and Macao in building themselves into international hubs for high--caliber talent, improving relevant mechanisms to see the two SARs playing a greater role in China's opening up to the outside world, and encouraging cooperation between Guangdong, Hong Kong and Macao in the Greater Bay Area by promoting closer alignment of rules and mechanisms. The Office of the Commissioner of the Ministry of Foreign Affairs will fully support all sectors of the society in Macao in implementing the spirit of the Third Plenary Session of the 20th CPC Central Committee by further leveraging Macao's unique advantages endowed by the "One Country, two Systems" and its role as a platform for international cooperation. We will also give a boost to Macao's efforts to develop new quality productive forces, promote appropriate economic diversification in compliance with its 1+4 plan through technological innovation and industrial upgrading, and develop the In-depth Cooperation Zone in Hengqin and the Greater Bay Area. Since its return to the motherland 25 years ago, Macao has enjoyed the biggest constitutional advantage-"One country, two systems", abundant horizons for development, a highly internationalized business environment, the strong economic foundation, the advantage of multiculturalism, and a traditional passion of patriotism and loyalty. I believe that with these advantages and through embracing the new opportunities created by further deepening reform and opening up, Macao's golden business card as an international metropolis can and will be polished even brighter!

upheld an appeal by the Public Prosecutor's Office, leading to a retrial of ex--assistant prosecutor general Kong Chi. It remains unclear whether the retrial will cover all original charges or focus solely on the secret society offence, for which he was previously acquitted, as cited in a TDM report.

THE Court of Final Kong Chi to face retrial after appeal upheld

Kong Chi received a 17year prison sentence for various offences including corruption, abuse of office, and unjustified enrichment. He was acquitted of the secret society charge due to insufficient evidence. The Public Prosecutor's Office appealed in April,

citing significant errors in the court's case assessment. They argued for the conviction of all defendants on the secret society charge, as cited in the same report.

The retrial will also involve three other defendants, including lawyer Kuan Hoi Lon, who was previously acquitted of all charges. The prosecution has requested a minimum 10-year sentence for Hoi Lon.

For the secret society offence, the prosecution seeks an additional 12-year sentence for Kong Chi and six--year sentences for each of the other three defendants.

Lawmakers veto ride hailing debate

RO-GOVERNMENT lawmakers have voted en bloc against two debate proposals submitted to the plenary of the Legislative Assembly (AL) by lawmaker Ron Lam.

Lam was seeking a debate session to discuss the need for ride-sharing platforms in Macau, offering visitors and locals alternative solutions to the current, buckling taxi system.

He also sought to debate the construction of the local crematorium.

Both proposals were voted down by all lawmakers except two directly elected "New Hope" lawmakers, José Pereira Coutinho and Che Sai Wang, and Lam himself.

Lam noted the inadequacies of the taxi system, which has been unable to meet demand from local and visiting customers over the years, and argued that commuters, based on current worldwide trends, favored ride-sharing platforms to traditional taxi services.

He did not convince any pro-government lawmakers, who immediately voted down the debate proposals, claiming they were "unnecessary" and "time-consuming."

Among the few lawmakers who intervened to substantially contribute to Lam's proposals

was Iau Teng Piu, a lawmaker appointed directly by the Chief Executive (CE).

He was against debate due to the government's promotion of public transport, especially Light Rapid Transit (LRT), as well as improvements to pedestrian infrastructure, stimulating increased foot traffic.

Iau said transforming every car into a potential taxi contradicts the government's policy of restricting the number of vehicles on the roads.

"The government is optimizing the taxi system, and in the future we will have some 2,000 new taxis available," he said.

Another lawmaker appointed by the CE, Chan Hou Seng, picked up where Iau ended, adding, "To produce laws to regulate the ride-sharing system would take too long."

Chan said modernizing and, therefore, improving the current system was a better and faster solution, "saving time and resources."

He said he favored including better technologies to aid the calling of taxis, as well as electronic payment methods, as opposed to simply opting for ride-sharing.

A third lawmaker from the list of those appointed by the CE, Kou Kam Fai, also addressed the plenary.

He also said it was best to "improve the current system rather than create a whole new one." Indeed, a new system, he added, "has the potential to create even more problems, instead of solving the current ones." Ma Io Fong, in his name and representing Wong Kit Cheng, repeated the same speech claiming there was no need to debate the topic because it was easier to improve the current system.

Making a new system would take too long a time, he said.

Chui Sai Peng, Ip Sio Kai, and Wang Sai Man, all of whom are lawmakers elected by indirect suffrage, representing the business sector, also said the government was already addressing the problems surrounding the taxi system.

They said a unified platform to manage all taxis, allowing for the better management of existing resources, was in development, remarking, "Since the government is already doing the work then there is no need for debate."

Of those in favor of the debate, Pereira Coutinho said he would always support the discussion of matters that were considered of public importance, even in circumstances during which he already held strong opinions.

"A debate is always an opportunity to learn more on a particular topic and to share valuable ideas," he said.

He noted that, while the government is making a huge effort to bolster Macau's image among tourists from abroad, a necessity existed to analyze just how the city's reputation was suffering from the current incongruence between Macau and, for example, the neighboring regions of Hong Kong, with which the local government is cooperating to reach some visitor sources.

"It makes no sense that China has this [ride-sharing] and Hong Kong has this, but we cannot have it," he said.

CREMATORIUM NOT FEASIBLE

BUILDING a crematorium facility is not feasible, a large majority of AL plenary lawmakers decided, without debate.

Lawmaker Ron Lam's second debate proposal, which dealt with the construction of a crematorium, was voted down by all except, again, Lam, Pereira Coutinho, and Che.

The majority of the lawmakers claimed the crematorium was not a topic that deserved to be debated.

They argued the government had already conducted studies and presented proposals on the matter, and these had been rejected by the city's population.

Several lawmakers said the number of cremations from Macau performed in the neighboring regions like Hong Kong or the city of Zhuhai is too small to justify investment in a local facility, which would require a significantly large, unused land plot.

These opinions were shared by lawmakers including, among others, Ma Shi Seng, Cheung Kin Chung and Ip Sio Kai.

Dissenting lawmakers argued debate on the matter would be insensitive, owing to the cultural beliefs and habits of Macau's diverse people. Such a debate, lawmakers feared, might inspire social discord.

"We need to be very careful when talking about this. We should not propose a debate on this matter," lawmaker Ma said. Also unanimous among the lawmakers that voted against the debate proposal was the belief that Lam's intentions to discuss the matter stemmed from the high prices of cremations in neighboring regions.

Ma and Ip said, "The government can try to negotiate with the neighboring authorities to lower costs. There is no need for a debate."

Ip added the government, settled in its decisions, would resort to "regional cooperation" to address pricing concerns.

Earlier, Lam noted that in 80% of recent deaths, residents had opted for cremation. In his opinion, Macau was mature enough to discuss the matter.

The lawmaker noted that, for Macau locals, cremation procedures in neighboring regions invoke many bureaucratic hurdles, and can cost 10-fold those paid normally by the residents of those places

This situation is unfair for Macau residents, who should not have to shoulder such high expenses simply because Macau does not have a crematory.

In his presentation, Lam said that, considering his previous proposal about ride-sharing legalization, this was the 26th time a debate proposal had been brought to the plenary by the initiative of lawmakers only to be immediately voted down by other lawmakers that have formed a large, pro-government bloc. **RM**



SLAUGHTERHOUSE CONCESSION RENEWED

The concession agreement governing the operation of Macau Slaughter House Ltd. has been extended for an additional five years. As per a notification from the Financial Services Bureau, the concession awarded by the SAR to the slaughterhouse is currently in effect and will remain so until June 4, 2029. This renewal follows two years after the initial contract was signed, which has now undergone revisions. The company is required to pay a land rent of 411,750 patacas. Furthermore, the government has indicated it "will not authorize any loans" that the slaughterhouse may seek; however, it may provide subsidies "as financial assistance."

OVER 30 SPECIALIST DOCTORS FOR CHRONIC DISEASES

The Health Bureau currently employs 34 specialist physicians to address the main chronic diseases in the community, such as hypertension, diabetes and cardiovascular diseases. This assurance was provided by Wong In, the director of the Praia do Manduco Health Centre, during the Ou Mun Tin Toi forum program. The program's focus yesterday was on the pilot project for managing chronic diseases in the community. The project, which has no specified start date yet, aims to enhance collaboration between the public and private sectors. It also aims to improve the family medicine system by establishing a team of specialist doctors in this field, along with general practitioners from health centers and community family doctors.

EXPORTS TO THE BELT AND ROAD COUNTRIES DOUBLE IN H1

External merchandise trade totaled MOP70.70 billion in the first half of 2024, down by 9% compared to the same period last year (MOP77.69 billion), according to data from the Statistics and Census Service (DSEC). The total value of merchandise exports grew by 4% yearon-year to MOP6.62 billion, of which value of re-exports (MOP5.89 billion) increased by 4.5%, while value of domestic exports (MOP728 million) decreased by 0.2%. Analyzed by destination, merchandise exports to the Belt and Road Countries (MOP469 million), mainland China (MOP407 million) and the EU (MOP116 million) expanded respectively by 101.8%, 2.7%, and 67.1% year-on-year in the first half of 2024

3,000 HOTEL ROOMS UNDERWAY

The ongoing construction of five new hotels in Macau is expected to add nearly 3,000 hotel rooms to the region, according to data from the Land and Urban Construction Bureau. Additionally, seven other hotel projects are currently being planned, with a combined capacity of approximately 900 rooms. In addition to hotel projects, the bureau also provided information on residential developments, stating that two private residential projects with a total of 11 flats had received final approvals during the second quarter. Furthermore, there are 56 private housing projects in various stages of construction, which could potentially offer an additional 2,375 flats.

Macau to capitalize on Thailand's USD15b casino market

MACAU is strategically positioning itself to capitalize on the potential opportunities arising from Thailand's likely entry into the lucrative casino market, which is estimated to reach a substantial value of USD15.1 billion (MOP121.55 billion) in the near future.

Thailand, as projected by brokerage CLSA, is expected to inaugurate its first entertainment complex by 2029, potentially introducing a 17% gaming tax on gross gaming revenue (GGR).

CLSA analysts Jeffrey Kiang, Naphat Chantaraserekul, and Leo Pan have underscored the distinct disparities in tourism dynamics between Macau and Thailand, emphasizing the diverse visitor profiles, the varying lengths of stay, and tourists' nationalities in each region.

These variations highlight the unique strengths and potential growth opportunities each destination offers within the broader context of the gaming and hospitality sectors.

"Even though mainland tourists are likely to be a major source of Thailand's post-COVID tourism rebound, we see sharp differences between Macau and Thailand tourism, with these ensuring Macanese gaming resilience," said the analysts.



The analysts also drew attention to the contrasting profiles of visitors to Macau and Thailand, with Macau predominantly attracting visitors from Hong Kong and the mainland, while Thailand remains an untapped market for those from the mainland and India.

According to CSLA, the low travel penetration rates in Thailand present a significant growth potential, especially if the rates increase to levels comparable to those observed in Macau. This could result in a substantial surge in annual visits from the mainland and India.

In terms of market considerations, visitors to Thailand and Macau stay for different amounts of time and are of

varying demographics.

While both destinations welcomed around 40 million visitors in 2019, Thailand's visitor base is more international, with a significant proportion arriving from countries beyond China and Hong Kong.

Moreover, tourists tend to stay longer in Thailand, averaging over a week, in contrast to the shorter stays observed in Macau.

"Visitors also stay in Thailand for over a week on average, compared with less than two nights in Macau," the analysts wrote. From 2005 to 2019, the average length of stay in Thailand was 9.3 days, with Asian visitors staying between 5.5 and 9.9 days.

Recently, the brokerage reported that four of Macau's six gaming operators are interested in investing in Thailand

The report suggested the annual gross gaming revenue (GGR) value of the Thai casino industry could be as high as USD30.8 billion, with a base projection of USD15.1 billion.

Among the Macau gaming concessionaires, Galaxy Entertainment Group Ltd, Las Vegas Sands Corp, MGM Resorts International, and Wynn Resorts Ltd are believed to be considering investments in the country.

The proposed gaming licenses would be valid for 20 years, with a 17% tax rate, targeting foreign visitors as the primary clientele.

Guangdong to issue RMB2.5b in offshore bonds in Macau

In a move to further integrate the Guangdong-Hong Kong-Macau Greater Bay Area, Guangdong's Department of Finance plans to issue offshore yuan-denominated bonds worth up to 2.5 billion yuan in Macau and an additional 5 billion yuan in Hong Kong, according to a report by the South China Morning Post.

This will be Guangdong's fourth issuance of so-called "dim sum" bonds in Macau, but



the first time the provincial government has issued them in

Hong Kong.

The upcoming five--year bonds are aimed

at "further promoting the integrated development of the Greater Bay Area," the authority said in a notice released earlier this week.

Guangdong is not the only Chinese region tapping the offshore yuan bond market.

Both the Shenzhen municipal government and the Hainan provincial government have also recently issued dim sum bonds in Hong Kong, while the central government issued five-billion-yuan worth of sovereign bonds in Macau last September.

The move to issue more offshore yuan bonds in Macau and Hong Kong is part of China's broader efforts to develop the Greater Bay Area. **LV**

Deland Leong, director of the Cultural Affairs Bureau, unveiled the festival's details during a media conference held at The Londoner Macao yesterday.


"This year's festival continues our commitment to inviting exceptional musicians from around the globe, many of whom are making their debut in Macau or are at pivotal moments in their careers," Leong said.

Notable performers include jazz legend Herbie Hancock, who has received the Grammy Lifetime Achievement Award, and the esteemed Mariinsky Theatre Orchestra from St Petersburg, Russia.

The festival will begin with a grand performance of Puccini's opera "Tosca," presented by the Mariinsky Theatre and the Macao Orchestra.

This timeless masterpiece





will be showcased over three consecutive nights, highlighting its enduring appeal and emotional depth. "Tosca" is celebrated for its powerful arias, including the famous "E lucevan le stelle," which resonates with audiences worldwide.

In addition to the opening opera, the festival will feature a closing performance by acclaimed Portuguese Fado singer Marisa, accompanied by the Macao Chinese Orchestra, held at The Londoner Theater.

This collaboration exemplifies Macau's unique position as a cultural bridge between East and West, blending traditional Chinese music with Western influences.

The festival will present 12 distinct programs, including 16 community outreach activities designed to engage both locals

and tourists.

These activities will encompass workshops, lectures and backstage explorations, allowing participants to gain deeper insights into the world of music.

The outreach initiative underscores the festival's commitment to fostering a vibrant musical community, with a "budget of MOP33 million, consistent with last year's funding."

Among the highlights of this year's festival are performances by renowned artists, such as Ivo Pogorelich, a pianist known for his innovative interpretations of Romantic music, and conductor Valery Gergiev, who will lead the Mariinsky Orchestra in two concerts featuring Russian symphonic works.

"These performances are not to be missed," Leong said, noting the rarity of such talents gracing Macau's stages.

The festival also aims to celebrate cultural diversity through unique collaborations.

MPU WINS INNOVATION COMPETITION

They intercepted and investigated 119 people (78 men and 41 women) but no suspicious persons were brought in for further questioning. PSP affirmed that it would adjust its strategies to suit the present security situation, increasing patro in key areas at relevant times.

Health Bureau records 22 suicide deaths in Q2

THE Health Bureau (SSM) has reported 22 suicide deaths during the second quarter of this year.

The deceased comprised nine males and 13 females, aged between 12 and 76.

Among them, 19 were Macau residents, accounting for 86% of the cases, while three were non-residents. The number of cases remains unchanged from the previous quarter and is two persons lower than the

same period in 2023.


An analysis of the data has revealed the primary causes of these suicide deaths were mental illness, gambling issues and financial problems.

SSM said the causes of suicide are multifaceted, often involving a combination of mental illness, psychological factors, socio-economic pressures, family dynamics, interpersonal relationships, and biogenetic factors.

The bureau has advised residents to maintain close contact with friends and family who can offer care and a listening ear.

To reduce the incidence of suicide, the SSM has encouraged individuals who are emotionally distressed to seek professional help.

The Social Welfare Bureau (IAS) encourages residents to remain conscious of their psychological and emotional wellbeing, as well as the health of relatives and friends. If in need, residents can call Caritas' Life Hope hotline (28525222) or IAS' counseling hotline (28261126).



PJ BOOST CRIME PREVENTION EFFORTS

According to a press release published by the Judiciary Police (PJ), crime prevention initiatives are being carried out across the city, focusing on local businesses. In July, officers visited over 60 restaurants and shops, including those on San Ma Lou and Avenida de Horta e Costa, to educate owners on preventing telecommunication fraud and theft. The outreach included distributing anti-deception leaflets, as well as advising merchants to exercise vigilance, especially if they receive large orders from unfamiliar suppliers.

FIRST MAINLAND TRAVEL PERMITS ISSUED TO FOREIGN RESIDENTS

THE first batch of mainland travel permits for non-Chinese permanent residents of Macau and Hong Kong has been officially issued.

This marks a significant step towards enhancing crossborder mobility.

The newly-introduced permits allow holders to travel to and from the mainland multiple times within a five-year validity period, with each stay capped at 90 days, according to the report from CCTV News.

Since July 10, eligible residents have been applying for these permits, which promote greater exchanges in business, tourism, education and cultural activities between the



mainland and the two Special Administrative Regions.

The permits, designed as electronic card-type travel documents, eliminate the need for a visa for short-term visits.

China Travel Service (CTS) has announced the agency is prepared to manage around 30 applications daily, accommodating

both online and walk-in applicants.

The application process is streamlined, allowing for completion in as little as 10 to 20 minutes – so long as all required documents are correctly provided.

Applicants must be at least 18 years old and possess a valid Macau or Hong Kong permanent identity card, a passport with at least six months of validity, and a recent photo.

In some instances, a photo can be taken at the travel service center.

The application fee is HKD260 for Macau and Hong Kong residents, while those from the mainland seeking to renew or replace permits will pay RMB230.

Elderly woman loses HKD1.42 million in fraud

An elderly woman is suspected of having fallen victim to a fraud scheme orchestrated by someone posing as a police officer.

She lost contact with her relatives and friends for about 20 days, during which time she stayed in a hotel as instructed by the fraudster.

Additionally, she paid "bail money," resulting in a loss of HKD1.42 million.

According to police report yesterday, the woman received a call on June 18 from a person claiming to be a mainland bank employee. The caller alleged her identity had been used to defraud others of HKD5 million and requested her assistance in an investigation on the mainland.

When the woman explained she could not stay in the mainland, the call

was transferred to someone claiming to be a mainland law enforcement officer.

This individual knew her name, Home Visit Permit number and telephone number, which convinced her of his legitimacy.

Following his instructions, she refrained from contacting anyone and rented a guesthouse in the Taipa District.

On July 9, the supposed officer told her she needed to transfer all the money from her Macau account to a designated Hong Kong account to be released on bail, pending trial. She complied with this instruction.

It was not until July 30 that the woman received a call from her Hong Kong bank inquiring about the reason and source of the large fund transfer. LV

MAN THREATENS COFFEE SHOP OWNER WITH KNIFE AFTER DISSATISFACTION WITH SERVICE

Alocal man in his 30s has allegedly slapped a coffee shop owner and threatened him with a knife after expressing dissatisfaction with the shop's

service. In a report by the Public Security Police and according to the shop owner, the confrontation began around 4:30 p.m. two days prior, when the suspect exhibited sudden emotional distress.

During the altercation, the shop owner was struck in the face. Approximately five minutes after leaving the establishment, the suspect returned, placed an 11-centimeter fruit knife on the counter, and issued a threat, stating, "I will get a gun next time," before departing.

The police apprehended the suspect on a nearby street roughly 10 minutes after the report was made.

Witnesses indicated that the dispute arose over the service attitude of the shop owner while purchasing coffee, after which the suspect allegedly retrieved a fruit knife from his residence with the intent to intimidate the owner. The suspect has denied any physical attack.

However, police confirmed through surveillance footage that the suspect had indeed inflicted harm by slapping the shop owner in the face. LV

Starbucks quarterly revenue falls on weak traffic in US and China

C TARBUCKS' revenue fell 1% in the April-June pe-Oriod as customer traffic weakened in the U.S. and

But the Seattle coffee giant expressed optimism that successful new products and improvements in efficiency — including faster drive-thru service and better equipment — will help turn things around in its next fiscal year, which begins later this fall.

"We are focused on what we can control in a consumer environment that can best be described as 'complex,'" Starbucks CEO Laxman Narasimhan said during a conference call with investors.

Narasimhan said consumers in many markets have gotten more cautious with their spending and are staying home. Starbucks' comments mirrored those at McDonald's, which said earlier this week that its same-store sales fell 1% in the April-June period.

Starbucks' same-store sales — or sales at locations open at least a year — fell 3%. That was slightly higher than the 2.7% drop Wall Street had expected, according to analysts polled by FactSet.

In China, where Starbucks is feeling pressure from lower-priced rivals, same-store sales plunged 14%. Chinese customers visited less often and spent less per visit, Starbucks said.

Narasimhan said Starbucks believes it still has immense opportunity in China, which is its second-largest market with 6,500 stores. But he said the company is in the early stages of exploring a strategic partnership or joint venture in China that could help it accelerate its growth. Such a partnership could also lessen Starbucks' exposure to the market's volatility.

"What we want to be sure of is that we are further strengthening our advantage in this market because the long-term opportunity for us is significant," he

In the U.S., same-store sales fell 2%. Starbucks said higher spending per visit helped offset a 6% slowdown in traffic.

Narasimhan said there were some bright spots in the U.S. The company's new Summer-Berry Refresher, which has boba-like raspberry pearls, saw the highest first-week sales for a new product in the company's history. Starbucks also noted a 7% increase in U.S. loyalty members during the quarter.

But Narasimhan said the company has work to do to increase afternoon sales and improve its supply chain. The Summer-Berry Refresher was so popular the company ran out of ingredients and had to pull back on marketing, he said. Starbucks has also trouble keeping its food items in stock.

Narasimhan said Starbucks also still faces boycotts of its stores in the Middle East, Southeast Asia and parts of Europe for its perceived support of Israel in the war in Gaza.

Starbucks reported revenue of \$9.1 billion for its fiscal third quarter. That was lower than the \$9.2 billion Wall Street anticipated, according to analysts polled by FactSet. Net income fell 7.6% to \$1.05 billion, or 93 cents per share. That was in line with analysts' forecasts.

Narasimhan confirmed recent reports that activist investor Elliott Investment Management has taken a stake in the company.

"Our conversations to date have been constructive," he said.

Starbucks shares rose 3% in after-hours trading Tuesday. The stock has fallen 25% in the last 12 months. MDT/AP

China accuses Japan of 'smear attacks' in talks with the US, India and Australia

HINA has expressed strong dissa- 품 tisfaction to Japan about what it called "smear attacks" against China at recent high-level meetings with the United States, India and Australia, the Foreign Ministry said yesterday.

A ministry statement said that Liu Jinsong, the director general of the Asian affairs department, conveyed solemn representations and serious concern at a meeting the previous day with Akira Yokochi, the deputy chief of mission at the Japanese Embassy.

"Liu pointed out that Japan's smear attacks on China are self-contradictory to its statement of promoting the strategic and reciprocal relationship between the two countries," the statement said.

Meeting in Tokyo on Sunday, Japan's foreign and defense ministers agreed to bolster military cooperation with the U.S. at what are known as "2+2" talks with their American counterparts.

A joint statement said China's foreign policy "seeks to reshape the international order for its own benefit at the expense of others" and that such behavior represents "the greatest strategic challenge" in the Indo-Pacific region and beyond.

The U.S.-Japan talks were followed by a meeting on Monday of the foreign ministers from the Quad countries — the U.S. Japan, India and Australia. The joint statement did not mention China by name but expressed opposition to "the militarization of disputed features and coercive and intimidating maneuvers in the South China Sea."

The Chinese government has complained repeatedly about the U.S. deepening ties with other countries in the face of China's rise, which President Joe Biden has made a priority during his four years in office.

Hamas leader Haniyeh killed in Iran by an alleged Israeli strike

'AMAS leader Ismail Haniyeh was killed by a predawn airstrike in the Iranian capital yesterday, Iran and the militant group said, blaming Israel for a shock assassination that risks escalating the conflict even as the U.S. and other nations were scrambling to prevent an all-out regional war. Iran's supreme leader vowed revenge against Israel.

There was no immediate comment from Israel, which has pledged to kill Haniyeh and other Hamas leaders over the group's Oct. 7 attack on southern Israel in which the Palestinian militant group killed 1,200 people and took some 250 others hostage. The strike came just after Haniyeh had attended the inauguration of Iran's new president in Tehran — and only hours after Israel targeted a top commander in Iran's ally Hezbollah in the Lebanese capital Beirut.

The dramatic assassination of Hamas's top political leader threatened to reverberate throughout the region's intertwined conflicts. Most explosively, the strike in Tehran could push Iran and Israel into direct conflict if Iran retaliates.

"We consider his revenge as our duty," Iranian supreme leader Ayatollah Ali Khamenei said in a statement on his official website. He said Israel had "prepared a harsh punishment for itself" by killing "a dear guest in our home."

Bitter regional rivals, Israel and Iran risked plunging into war earlier this year when Israel hit Iran's embassy in Damascus in April. Iran retaliated and Israel countered in an unprecedented exchange of strikes on each other's soil, but international efforts succeeded in containing that cycle before it spun out of control.

Haniyeh's killing could also prompt Hamas to pull out of negotiations for a cease-fire and hostage release deal in the 10-month-old war in Gaza, which U.S. mediators had said were making progress.

And it could enflame already heightening tensions between Israel and Hezbollah - which international diplomats were trying to contain after a weekend rocket attack that killed 12 young people in the Israeli-controlled Golan Heights.

Tuesday evening, Israel carried out a rare strike in the Lebanese capital that it said killed a top Hezbollah commander allegedly behind the rocket strike. Hezbollah, which denied any role in the Golan strike, said yesterday that it was still searching for the body of Fouad Shukur in the rubble of the building that was hit in a Beirut suburb, killing two women and two children, according to the Lebanese Health Ministry.

There was no immediate reaction from the White House to the killing of Haniyeh.

Asked by reporters in Manila about the Tehran strike, U.S. Secretary of Defense Lloyd Austin said he had no "additional information to provide." But he expressed hope for a diplomatic solution on the Israeli-Lebanon border.

"I don't think that war is inevitable," he said. "I maintain that. I think there's always room and opportunity for diplomacy, and I'd like to see parties pursue those opportunities."

But international diplomats trying to defuse tensions were alarmed. One Western diplomat, whose country has worked to prevent an Israeli--Hezbollah escalation, said the double strikes in Beirut and Tehran have "almost killed" hopes for a Gaza cease-fire and could push the Middle East into a "devastating regional war." The diplomat spoke on condition of anonymity to discuss the sensitive situation.

An Israeli military spokesman declined to comment. Israel often doesn't comment on assassinations carried out by its Mossad intelligence agency or strikes on other countries.

Iranian media showed videos of Haniyeh and Iranian President Masoud Pezeshkian hugging after Pezeshkian's inauguration ceremony Tuesday. Hours later, the strike hit a residence Haniyeh uses in Tehran, killing him, Hamas said in a statement.

It also quoted a past speech by Haniyeh in which he said the Palestinian cause has "costs" and "we are ready for these costs: martyrdom for the sake of Palestine, and for the sake of God Almighty, and for the sake of the dignity of this nation."

Pezeshkian vowed his country would "defend its territory" and make the attackers "regret their cowardly action." An influential Iranian parliamentary committee on national security and foreign policy was to hold an emergency meeting on the strike later yesterday.

Hamas' military wing said in a statement that Haniyeh's assassination "takes the battle to new dimensions and will have major repercussions on the entire region." It said Israel "made a miscalculation by expanding the circle of aggression."

Speaking to the AP, a Hamas spokesman Sami Abu Zuhri said the loss of Haniyeh won't impact the group, saying it had emerged stronger after past crises and assassinations of its

Haniyeh left the Gaza Strip in 2019 and had lived in exile in Qatar. The top Hamas leader in Gaza is Yehya Sinwar, who masterminded the Oct. 7 attack.

In the West Bank, the internationally backed Palestinian President Mahmoud Abbas condemned Haniyeh's killing, calling it a "cowardly act and dangerous development." Political factions in the occupied territory called for strikes in protest at the killing.

In April, an Israeli airstrike in Gaza killed three of Haniyeh's sons and four of his grandchil-

Meanwhile, Iraq's Popular Mobilization Forces, a coalition of Iranian-backed militias, said that a strike Tuesday night on a base southwest of Baghdad killed four members of the Kataib Hezbollah militia.

The group accused the United States of being behind the strike. MDT/AP

1976 Lauda FIGHTS FOR LIFE AFTER GRAND PRIX **CRASH**



Formula One racing driver Niki Lauda is in a critical condition in hospital after an horrific accident at the Nurburgring Grand Prix

The Austrian-born driver became trapped inside his Ferrari after it swerved off the track before bouncing back into the path of the oncoming cars and catching fire.

Fellow driver Guy Edwards managed to avoid the blazing wreckage but Harald Ertl and Brett Lunger both hit it.

All three drivers raced to the burning Ferrari and, with the help of the Italian driver Arturo Merzario, who also stopped, eventually managed to pull 27-year-old Lauda from his vehicle.

Lauda, who has led this drivers' championship since the beginning of the season, began the race second on the grid behind James Hunt in pole position.

Guy Edwards said they had had problems getting the trapped driver out.

"Lauda was basically sitting in the middle of a fire and I would guess it would be about a minute before we managed to get the belts undone

"In the meantime Ertl had got a fire extinguisher from somewhere and was aiming it towards the central cockpit area so he was able to keep the fire under some sort of

"Lauda was conscious most of the time and was saying 'get me out'."

Mr Lauda was taken to nearby Adenau hospital with serious burns. From there he was flown to the University Hospital in Mannheim where his condition is described as critical.

IN CONTEXT

Within six weeks of the Nurburgring accident Niki Lauda was back behind the wheel

He fought for his life for several days following the accident and suffered horrendous burns to his head and face

Part of one of his ears was burnt off and his tear duct mechanism was severely damaged which affected his vision in subsequent races

Lauda won the World Championship a total of three times - in 1975, 1977 and 1984. He retired from F1 in 1985

Before the 1976 accident he had been well on course to win it again - but eventually lost by just one point to James Hunt.

At the end of the 1970s he launched his own airline Lauda Air, which was later sold to Austrian Airlines. He managed the Jaguar F1 racing team from 2001-2. In late 2003 he launched another airline, Niki. Guy Edwards was awarded a Queen's Gallantry Medal for his bravery.



A CENTURIES-OLD SECRET SCRIPT CALLED NÜSHU IS EMPOWERING YOUNG CHINESE WOMEN

CHEN Yulu never thought her home province of Hunan had any culture that she would be proud of, much less become an ambassador of.

But these days, the 23-year-old is a self-proclaimed ambassador of nüshu, a script once known only to a small number of women in the south China.

It started as a writing practiced in secrecy by women who were barred from formal education in Chinese. Now, young people like Chen are spreading nüshu beyond the women's quarters of houses in Hunan's rural Jiangyong, the county whose distinct dialect serves as the script's verbal component.

Today, nüshu can be found in independent bookstores across the country, subway ads, craft fair booths, tattoos, art and even everyday items like hair clips.

Nüshu was created by women from a small village in Jiangyong, in the southern province where Mao Zedong was born, but there's little consensus on when it originated. Scholars estimate the script is at least several centuries old, from when reading and writing were deemed male-only activities. So the women developed their own script to communicate with

each other.

The script is slight with gently curving characters, written with a diagonal slant that takes up much less space than boxy modern Chinese with its harsh angles.

"You won't allow me to go to school. Okay, I get it. So what's my way out? I'll find ways to educate myself," said Xu Yan, 55, the author of a textbook on nijshu

Women lived under the control of either their parents or their husband, using nüshu, sometimes called "script of tears," in secret to record their sorrows: unhappy marriages, family conflicts, and longing for sisters and daughters who married and could not return in the restricti-

ve society.

Xu is also the founder of Third Day Letter, a nüshu studio in Beijing named after a centuries-old practice by the script's practitioners. The third-day letter is a hand-sewn book presented in farewell to a woman in Jiangyong on the third day after her marriage, when she's allowed to visit the childhood home she left.

The script became a unique vehicle for composing stories about women's lives, typically in the form of seven-character line poems that are sung. A secret world sprung form the script that gave Jiangyong women a voice through which they found friends and solace.

That secret world still resona-

tes today as a source of strength for young women dissatisfied with patriarchal constraints.

Chen, who studied photography at an art school in Shanghai, said her male professors often doubted that she could keep up with the male photographers because of her slight physique. That attitude, she said, is "in every aspect of life, there's nowhere it doesn't touch."

She was frustrated but didn't see much room to push back — until she learned about nüshu.

"I felt that I had received a very strong power, and I think a lot of women need this power," she said.

Chen wanted to make a documentary about feminism and came across nüshu in her online search. When she realized the script originated from Jiangyong, just a few hours from her hometown, she immediately knew that she had found her graduation project's topic.

The more she learned about this script, the more she learned about its duality: that it was as much a painful thing as it was a source of strength.

In her documentary, she follows He Yanxin, a formally designated inheritor for nüshu who is now in her 80s. She asks Chen, "Do you think nüshu has any use?" Chen says yes. In res-

ponse, He says, "Nüshu is useless."

He comes from Jiangyong and says she was forced to marry a man she didn't want to be with, who physically abused her and tore up photos from nüshu meetups and workshops she attended. She did not feel that the script had made her life materially better, according to Chen's first-person account, published on social media.

Yet, He is the one who urged her to learn the script.

Formal inheritors of the script have to be from Jiangyong, Chen said, and have to master the nüshu, but there was nothing stopping her from sharing her love of the script with others.

Beginning in 2022, Chen began spreading the practice. She started an online nüshu group, taught writing workshops and set up nüshu art exhibitions in cities across China. Most participants at her writing workshops are women, she said, and some people even bring their mothers. Chen also runs a social media account to promote nüshu and its culture beyond Hunan.

Lu Sirui, a 24-year-old working as a marketer, learned about nüshu from online feminist groups and joined Chen's nüshu-focused WeChat group.

"At first I just knew that it was a women's inheritance, belonged only among women," Lu said. "Then, as I got to know it better, I realized that it was a kind of resistance to traditional patriarchal power."

For Lu, nüshu means "a very powerful rebellion" and a bond of sisterhood. She said it was important for women to stick together.

Lu once encountered a rental agent in Beijing who, drunk in the middle of the night, knocked on her door and tried to enter her home. Lu said that she picked up a stick at the doorway and ran out to confront him. Afterwards, she confided in a small feminist community online, where she received comfort and advice on how to handle the situation. She says communities like that have supported her in the face of gender-based violence, inequality and mother-daughter relationship problems, among other challenges.

Seeing nüshu as another representation of sisterhood, Lu bought a textbook and practices the script in her spare time. Even though she is not a formal nüshu ambassador, she began hosting nüshu workshops at bookstores and bars in Beijing. When organizing these events, Lu discovered that very few people had heard of nüshu, but the feedback was always positive.

"It's a manifestation of female strength that transcends time and space," Lu said. MDT/AP

Italy wins gold in women's team epee fencing to disappoint a passionate French crowd again

HE fans at fencing are among the loudest and most passionate at the Paris Olympics, especially when France is challenging for a gold medal. They usually leave disappointed.

Italy overcame a passionate "Marseillaise"-singing crowd at the Grand Palais to hand France its fourth fencing silver medal of the Games in the women's team epee yesterday [Macau time].

Alberta Santuccio got the winning touch for Italy in overtime against France's Auriane Mallo-Breton to complete a hard-fought 30-29 win for gold. It was the second time that Mallo-Breton lost a Paris Olympic final by a single point after a 13-12 loss to Hong Kong's Vivian Kong Man Wai in the indi-

vidual epee Saturday.

French fencers are 0-3 in finals against non-French opponents at the 2024 Olympics,

with those losses coming in epee events. The host nation's only gold came when Manon Apithy-Brunet beat her teammate Sara Balzer in the


women's saber final on Monday. "If you look at the (epee) finals, of course we seem to be losing, but we're in the finals all the same," Mallo-Breton said through an interpreter. "I think that in the teams, there are possibilities to go and get some wonderful medals, and we hope that the other (French) teams will be able to go and do that, so we're going to be supporting them."

Team fencing involves squad members fencing one-on-one in a rotating sequence that means everyone gets to face each opponent once. Despite the overtime loss, Mallo-Breton was still France's standout in the final with a combined record of 14-10 against all opponents.


Italy has one gold, one silver and one bronze medal so far in fencing. Five more team events remain.

Polish fencer Aleksandra Jarecka was shaking on the floor with emotion after winning her team bronze. Jarecka tied the score with less than three seconds to go and then won the tiebreaker point for a 32-31 overtime win against China.

Just before that was an unexpected twist when an apparent glitch with the scoring system seemed to give Poland an extra point in the last minute, only to take it away. It prompted the referee to study video of recent points in a bid to clear up exactly what the state of play was for the final seconds. MDT/AP

USA, CHINA, DECOUPLING, AND THE 'LITTLE GUY'

As the years go by, we realize that decoupling does not (and will not) occur in all areas simultaneously; it tends to occur in a fragmented and sector-specific manner. It began with the tariff war initiated by the USA in 2018. It progressed to restrictions in access to high technology, in capital flows, and also in critical metals.

However, China's rise is inevitable. Even with the current adjustment difficulties (particularly in the real estate sector), the Chinese economy is growing at 5% per year. Its industrial capacity has been diminished with the relocation of numerous companies abroad (due to rising domestic costs and as a preventive reaction to the approaching demographic winter), but it remains formidable, with an export sector that has become the locomotive of Chinese development. Despite the progressive interference of the CCP in the private business sector (80% of the total), companies continue to be competitive and innovative, within a regulatory framework that mixes a still quite liberal capitalism with submission to public policies defined by the State-Party. Nonetheless, from the record creation of intellectual property rights to the production of relevant capital goods (cars, airplanes, advanced industrial equipment), including the production of military equipment, China has never been stronger.

On the other hand, Chinese influence on a global scale continues to increase, especially in developing countries. And foreign trade between the USA and China keeps growing, despite repeated political acts by American authorities aiming to implement decoupling. Furthermore, on a global scale, world flows of goods and capital have stabilized since the global financial crisis, confirming that globalization and multilateralism have created enormous interdependence between the economies of the main blocs.

But what would be the economic effects of a significant decoupling between the USA and China? The IMF has already warned of the dangers of wealth destruction that such a move would generate, estimating that enormous restrictions on international trade could reduce about 7% of global GDP in the long term, a loss equivalent to \$7.4 trillion. And who will suffere the most if a significant decoupling occurs?

The IMF predicts that developing economies will be the most affected if Washington and Beijing cut economic ties. Not all (some are even benefiting from the effects of decoupling), but the majority of developing countries – the most fragile component of the international economic system – are destined to be the proverbial little guy who gets hurt when the big guys fight.

ABOUT 8 IN 10 DEMOCRATS ARE SATISFIED WITH HARRIS IN STARK POST BIDEN SHIFT: AP-NORC POLL

Vice President Kamala Harris appears to have energized Democrats in the early days of her candidacy, with the surge in warm feelings extending across multiple groups, including some key Democratic constituencies that had been especially tepid about President Joe Biden, a new poll shows.

About 8 in 10 Democrats say they would be somewhat or very satisfied if Harris became the Democratic nominee for president, according to the survey from The Associated Press-NORC Center for Public Affairs Research, which was conducted after Biden withdrew from the race.

In a separate AP-NORC poll, taken before Biden dropped out but after his debate against Republican former President Donald Trump, only about 4 in 10 Democrats said they were somewhat or very satisfied that he was the Democratic Party's likely nominee for president.

The rapidly changing views among Democrats in such a short time span underscore how swiftly the party — from rank-and-file voters to elected officials — has coalesced behind Harris as its standard-bearer, motivated by the fresh face at the top of the ticket and newfound confidence in the party's prospects against Trump in November.

FORMER LEAD BBC NEWS PRESENTER PLEADS GUILTY TO THREE COUNTS OF MAKING INDECENT IMAGES OF CHILDREN

Huw Edwards, the BBC's former top news presenter, pleaded guilty yesterday to three counts of making indecent images of children.

The offenses he pleaded guilty to at Westminster Magistrates' Court in central London during a 26-minute hearing involved images shared on WhatsApp between December 2020 and August 2021 by a man who had initially contacted Edwards via social media.

Edwards, who was the lead anchor on the BBC's nighttime news for two decades and led the public broadcaster's coverage of the funeral of Queen Elizabeth II in 2022, has been remanded on bail until a pre-sentencing hearing on Sept. 16. He could face up to 10 years in prison, though the prosecution conceded that a suspended sentence may be appropriate.

The court heard that Edwards, 62, was involved in an online chat with an adult man on the messaging service who sent him 377 sexual images, of which 41 were indecent images of children.

The images that were sent

included seven of what are known as "category A," which are the most indecent. Of those, the estimated age of most of the children was between 13 and 15, but one was aged between 7 and 9.

The court also heard that the unnamed male asked Edwards on Feb. 2, 2021 whether what he was sending was too young. Edwards told him not to send any underage images. Five more, though, were sent, and the exchange of pornographic images continued until April 2022.

"Accessing indecent images of underage people perpetuates the sexual exploitation of children, which has deep, long-lasting trauma on these victims," said Claire Brinton of the Crown Prosecution Service.

Speaking in Edwards' defense, his lawyer Philip Evans said there is "no suggestion" that his client had "in the traditional sense of the word, created any image of any sort."

Edwards, he added, "did not keep any images, did not send any to anyone else and did not and has not sought similar images from anywhere else." He added that Edwards had "both mental and physical" health issues and that he is "not just of good character, but of exceptional character."

Prosecutor Ian Hope told the court that Edwards' "genuine remorse" was one reason why a suspended sentence might be considered. Setting out the potential penalties under the law, he said that where there is the prospect of rehabilitation, a community order and sexual offender treatment program could be considered as alternatives to prison.

A spokesperson for the National Society for the Prevention of Cruelty to Children said there should be "no doubt" about the seriousness of Edwards' crimes.

"It can be extremely traumatic for young people to know sexual images of themselves have been shared online," the spokesperson said. "We also need to see online platforms do much more to identify and disrupt child abuse in private messaging services in order to safeguard young people."

Edwards, who was one of the BBC's top earners, was suspended in July 2023 for separate claims made last year. He later resigned for health reasons. MDT/AP
