CITY SEES DECLINE IN MORTGAGE LOAN APPROVALS

New approvals for residential mortgage loans (RMLs) and commercial real estate loans (CRELs) both saw declines in October 2024, according to the Monetary Authority of Macao. New RMLs dropped by 57.4% month-onmonth to MOP1.30 billion, with loans to residents decreasing by 58.5%. In contrast, non-resident loans rose by 8.7%. New CRELs fell by 37.9% to MOP642.21 million, primarily due to a significant decrease in loans to non-residents.

'NEW PERSPECTIVES' **EXHIBITION OPENS**

The Macao Museum of Art (MAM) will host the exhibition "New Perspectives: Modern and Contemporary Works from the Macao Museum of Art" from today to May 25, 2025. This exhibition features nearly 100 pieces across three sections: "Scenery and Images," "Ink Expressions and Concepts," and "Objects, Colors, and New Perspectives." It showcases modern and contemporary artworks in various creative forms, including watercolors, oil paintings, ink art, printmaking, photography, installation and mixed media.

UTM STRENGTHENS TIES WITH JINAN UNIVERSITY

The Macao University of Tourism (UTM) has signed a cooperation agreement with the Jinan Municipal Education Bureau and Jinan University to enhance educational collaboration between Macau and Shandong Province. This initiative aims to foster the development of talent, allowing for student exchanges and faculty collaborations. During the signing ceremony yesterday, key figures, including Fanny Vong, UTM president, and Liu Chunhua, Secretary of the Party Committee of Jinan University, outlined specific cooperation plans, emphasizing their commitment to improving educational opportunities for students in both regions.

GOV'T TO INJECT AIR MACAU WITH NEARLY MOP345 MILLION

THE government is preparing L to make a capital injection of MOP344.13 million into Air Macau next year. This allocation is already included in the government's 2025 budget under projects that exceed MOP50 million.

According to the project, the MOP344,126,400 will be directed into the company's operating fund to address its "challenging operating situation, which has resulted in significant losses," as noted in the opinion of the Legislative Assembly's Second Standing Committee, which analyzed the bill in detail.

This capital injection from the Macau Special Administrative Region (MSAR) will directly result in an increase in the com-



pany's shares, a move that was reportedly requested by Air Macau's major shareholder, Air Chi-

Following the capital injection, MSAR will hold a total investment of MOP1.6 billion in Air Macau, reflecting its proportional shareholding in the company.

The opinion from the Second Standing Committee, which approved the bill for voting at the plenary, also mentioned dis-

cussions with government representatives on the issue. It stated that "the company is very likely in a situation where the value of its net assets is less than half the value of its share capital," a situation that is believed to have prompted Air China to seek additional financial support from the MSAR government.

In addition to Air Macau, the same budget bill also includes a planned increase in the share capital of the Macau International Airport Company, amounting to approximately MOP896 million next year.

The largest investment project outlined for 2025 is the construction of the East Line of the Light Rapid Transit system, which is budgeted at nearly MOP4 billion.

SJM Holdings to develop budget hotel in Hengqin

CJM Holdings Limited has Orecently announced plans to expand its footprint into the budget accommodation sector with the acquisition of nine floors of office space in Hengqin. The company will invest RMB546 million to convert this space into a three-star hotel, strategically located just a five-minute walk from the Hengqin Port.

In a statement, SJM Holdings revealed that the property spans 14,845 square meters, covering the 21st to 29th floors of the Xin De Kou An Shang Wu Zhong Xin commercial development. This initiative aligns with a recent policy initiative by the Hengqin government aimed at repurposing underutilized buildings into hotels, a plan that has gained traction since its introduction in April and subsequent expansion in July.

Daisy Ho, chair of SJM Holdings, emphasized the strategic advantages of the location in the statement. "The pro-



posed acquisition is situated next to the 24-hour Hengqin Port and is in close proximity to our existing hotel portfolio in Macau," she stated. The area is just a five-minute walk from the 24-hour Hengqin Port and a short drive from major hotels like the Grand Lisboa Palace Resort and the Grand Lisboa Hotel.

The new three-star hotel is expected to cater to budget-conscious travelers, particularly mainland Chinese tourists who have often found Macau's accommodation costs to be prohibitive.

The anticipated Jan. 1, 2025 opening of the Hengqin-Macau multiple-entry visa policy is expected to stimulate tourism. This policy will allow eligible visitors to travel back and forth between Macau and Hengqin multiple times within a week. Additionally, the newly inaugurated Hengqin Light Rapid Transit line is expected to enhance accessibility between these locations.

Ho added that the new Hengqin hotel would expand the types of customers that the gaming concessionaire

New archives building to serve as centralized storage for gov't records

HE Cultural Affairs Bureau (IC) is preparing to open a new 50,000 square meter archives building that will serve as a centralized storage facility for government records and files, director Leong Wai Man said yesterday.

The construction of the massive facility, Edifício dos Arquivos Históricos do Governo, will commence in the second quarter of next year, and is slated to open in 2026.

The building will dedicate over 34,000 square meters to housing files transferred from various public departments across Macau, Leong said in an interview yesterday.

Edifício dos Arquivos Históricos do Governo is located in Pac On, Taipa.

"Its biggest function is to store files," Leong explained. "We actually have other ancillary functions, including receiving, disinfecting, dusting, and repairing the files, as well as digitizing them and providing office space for colleagues working on the archives."

While the ground floor will feature some public exhibition and promotional spaces, Leong emphasized that the archives building's primary purpose will be professional and specialized, unlike the archives facility at Tap Seac Square, which may be better suited for educational and outreach efforts.

"We initially thought that after Tap Seac Square is no longer used to store archives, it could be used as a space for



educational promotion and external exhibitions," Leong

"Tap Seac Square has a rich historical background and the entire area is actually a series of cultural facilities. So, if we want to promote exhibitions to the public, citizens, or even schools in the future, we think it is more appropriate to use the archives building in Tap Seac Square."

The new archives building

is still undergoing renovations to adjust the temperature and humidity for proper file storage.

Leong said the transfer of files from other departments is expected to take place in 2026, after the renovations are complete.

While the archives will primarily serve government needs, Leong did not rule out the possibility of allowing professional researchers and scholars access to the facilities in the future.

"Sometimes, they will donate some of their precious archives to our SAR government, and they will become archives permanently preserved in our SAR government," Leong said. "I think we can continue to promote and cooperate in this direction in the future."

The bureau also plans to continue digitizing its archives to make them more accessible to the public through its online platform.

"Now everyone can see all the archives in the Macau Archives through the online platform," Leong said. "This will also enable more people to study or conduct research."

ARCHIVES UNVEILS NEW LOCAL RECORDS CHAPTER

CHIEF Executive Ho

Iat Seng presided
over the ceremonious
unveiling of the Edificio
dos Arquivos Históricos
do Governo yesterday,
a landmark project that
elevates Macau's archival work, as well as that
of the whole region.

The event, held at the intersection of Avenida Son On and Rua Heng Long in Pac On, Taipa, was attended by a host

of government officials, including the Secretary for Social Affairs and Culture, Ao Ieong U, and the director of the Cultural Affairs Bureau, Leong Wai Man.

Leong Wai Man highlighted the significance of this event, noting, "This year marks a milestone in the development of Macau's archival sector. With the entry into force of

Law No. 3/2023 (Archives Law) on March 14 this year and the official inauguration of the Government Historical Archives Building today, the development of the Macau SAR's archival sector will move to a new level."

The 13-story building, with an additional floor below ground, will have a gross floor area of over 50,000

square meters and a total usable floor area of over 40,000 square meters.

Leong emphasized the importance of this cultural infrastructure project, stating, "The building will provide sufficient and appropriate space for the preservation and management of Macau's archival resources."

Leong concluded her

remarks by expressing gratitude to the Chief Executive and guests, and expressing her hope that the Macau SAR archival sector would prosper as a result of the project.

The Chief Executive, accompanied by other dignitaries, also visited an exhibition showcasing the new government archives building.

Lei Wai Nong reflects on team successes in farewell address

GUANGDONG-HONG KONG-MACAU AIR QUALITY IMPROVES, BUT OZONE REMAINS A CHALLENGE

THE governments of Guang-**▲** dong, Hong Kong, and Macau have jointly released the 2023 Air Quality Report of the Guangdong-Hong Kong-Macau Pearl River Delta Regional Air Monitoring Network.

The report shows a continuous downward trend in various air pollutants, reflecting the effectiveness of emission reduction measures implemented in the region.

According to the report, the average annual concentration values of pollutants such as sulfur dioxide, nitrogen dioxide, carbon monoxide, and particulate matter PM10 and PM2.5 have dropped by 17%, to 86% from their peak levels. This progress is attributed to the various air pollution control measures undertaken by the three governments in recent years.

However, the report notes that the average annual concentration of ozone has remained similar in



recent years, indicating that regional photochemical pollution needs to be further addressed. A study on ozone pollution and regional transmission characteristics in the Greater Bay Area was completed earlier this year, pro-

viding scientific data to help the three places better understand and tackle the ozone issue.

The Macau government has announced the "Macau Long--term Carbon Reduction Strategy" and the "Macau Electric Vehicle Promotion Plan" to reduce air pollutants and greenhouse gas emissions.

The Hong Kong government continues to promote initiatives such as the "Hong Kong Electric Vehicle Popularization Roadmap," "Hong Kong Clean Air Blueprint 2035," and "Hong Kong Climate Action Blueprint 2050," which focus on controlling emissions from land and sea transportation, power plants, and non-road mobile machinery.


Additionally, the government is working on phasing out older diesel commercial vehicles and promoting the use of electric vehicles, with the number of electric vehicles in Hong Kong increasing significantly from around 14,000 in 2019 to more than 102,000 as of September 2024, a sevenfold increase over

Guangdong province has also undertaken various measures, including implementing stricter regulations on volatile organic compound emissions, strengthening the control of nitrogen oxide emissions from stationary and mobile sources, and enhancing environmental supervision of diesel trucks.

The regional air monitoring network, consisting of 23 air monitoring stations in Guangdong, Hong Kong, and Macau, continues to play a crucial role in tracking and reporting the air quality in the Pearl River Delta region.

The coordinated efforts of the three governments have vielded tangible results, and they remain committed to further improving air quality in the region.





Sam Hou Fai emphasizes necessity for reform in social security system

TNCOMING Chief Execu-Ltive Sam Hou Fai has acknowledged the persistent economic divide between the affluent and the disadvantaged in the region.

In an interview with state media outlets, Sam highlighted that despite some improvements in the overall economic landscape, vulnerable groups—particularly the elderly—are facing significant challenges due to escalating living costs and the ongoing repercussions of the pandemic.

He emphasized the necessity for reform in Macau's social security system to better support these popu-

The incoming top official pointed out that while Macau is often perceived as a wealthy enclave, many residents struggle to make ends

Meanwhile, he expressed



confidence that his political agenda would come to fruition, particularly concerning the pillars he outlined during his candidacy: building a Macau grounded in the rule of law and characterized by dynamism, culture, and happiness.

Recognizing the need for economic diversification, he aims to address concerns regarding small and medium-sized enterprises while enhancing social welfare for vulnerable populations.

"We must improve the happiness and well-being of Macau residents," he stated. Sam is slated to take office on December 20.

In the interview, Sam envisions Macau as a vital trade link between China and Portuguese-speaking nations, supporting local industries in expanding their international presence.

He said his government aims to utilize Macau's connections with Portuguese-speaking countries to enhance cooperation in technology, finance, trade, and culture.

He also pledged that his administration will explore establishing a cultural hub that merges Eastern and Western influences, alongside tourism initiatives designed to draw more visitors.



Ho lat Seng: Macau targets 60% non-gaming value by 2028

HIEF Executive Ho Iat Seng highlighted a significant shift in the region's economic landscape, noting that while gambling remains important, it now accounts for only 37.2% of Macau's gross domestic product (GDP).

Macau's outgoing Chief Executive is preparing to hand over leadership of the city to Sam Hou Fai on Dec. 20.

In recent interviews with mainland media, Ho emphasized the need for economic diversification, stating, "Macau's goal is to increase the share of non-gaming value-added to about 60% by 2028." This transition is particularly crucial in light of challenges posed by the Covid-19 pandemic. "In the face of uncertainties, our economy found it difficult to withstand risks," he said.

Since taking office in December 2019, Ho's administration has focused on reducing reliance on the gaming industry to build a more resilient and capa-



ble economy.

The gaming sector has shown signs of recovery, rebounding to approximately 75% of its pre-pandemic levels in 2023. However, Ho warned that the city's heavy dependence on casinos is no longer sustainable. Following revisions to gaming laws in 2022, Macau's casino operators committed to investing MOP118.8

billion (about USD \$14.8 billion) over the next decade, with plans for non-gaming projects significantly outpacing those for gaming.

In November 2023, a formal economic diversification plan was released, outlining objectives for 2024 to 2028. This plan aims for the non-gaming sector to contribute about 60% of GDP

by 2028 while allowing the gaming industry to stabilize postpandemic. Key areas of focus include tourism and leisure, traditional Chinese medicine and healthcare, modern finance, high technology, and conventions and exhibitions.

Ho also noted efforts to promote performing arts as part of this strategy. "We are committed

to showcasing the city's unique charm," he said, referencing Macau's rich cultural blend of Chinese and Western influences.

The tourism sector has also adapted to changing traveler preferences. In 2023, over 28 million tourists visited Macau, a significant increase compared to previous years. Ho attributed this growth to the government's ability to anticipate shifts in travel patterns post-pandemic and adapt accordingly. He pointed out that while the number of tour groups has sharply decreased from over 500 daily arrivals in 2018 to around 30, independent travelers are increasingly drawn to Macau's cultural offerings.

Despite these advancements, Macau remains heavily reliant on casino taxes, which constituted approximately 80.6% of government revenue from January to November this year.

Ho expressed confidence to Chinese media that with continued support from the central government and strategic investments in infrastructure—such as the new Macau Medical Center—Macau can navigate its post-pandemic recovery while fostering sustainable economic growth. In addition, he noted that the 'Onecountry, two systems' policy has granted Macau a degree of autonomy that has been crucial during these transformative years.

Black Bears lose pace, Kings win Macau CLASSIC REMATCH

THE Macau Black Bears were **▲** defeated 95-114 by the New Taipei Kings in the final game of a doubleheader on Wednesday evening at Studio City. This marked the Kings' second game of the year in the East Asia Super League (EASL) and their first victory of the season.

The Kings took control early, building a significant lead that they maintained throughout the game, ultimately winning by 19 points. The Kings surged to a 33-17 lead after the first quarter and continued their dominance by outscoring the Bears 35-17 in the third quarter, securing a comprehensive victory.

A standout performance came from former NBA star Jeremy Lin, who led the Kings in scoring with 27 points. Lin was also named Player of the Game, earning his first such honor of the season.

At halftime, Kings head coach Ryan Marchand emphasized the importance of securing

a win, stating, "We're trying to win. In EASL, you probably need to get four wins to move on, so we know we're in trouble if we lose this game." The message was clearly heard, as the Kings came out focused, shooting an impressive 69% from the field in the first quarter. Meanwhile, the Bears struggled offensively, shooting just 23% in the opening period.

The Bears introduced new players to their lineup, including Adonis Thomas, Johnny Wang, and Lei Cheong, all making their EASL debuts. Head coach Garrett Kelly experimented with different rotations following the departures of key players Jeantal Cylla and Will Artino. Unlike their victory in October, when only eight players saw action, all 12 active players participated in this game.

"We brought in some talent, and they're just trying to get used to each other," Kelly said in a halftime interview. "We tried our best during practice, but really, you've got to do it in front of a



great crowd like this and against a really good team. They're learning on the fly right now."

Unfortunately for the Bears, the new players struggled to gel with the team. Wang and Lei failed to score, while Thomas managed only 13 points on 33% shooting.

The Kings, reigning champions of the P. LEAGUE+ (Taiwan's professional men's basketball league), were in peak form, hitting 48% of their three--point attempts. In contrast, the Bears struggled from beyond the arc, converting just 24% of their attempts—a significant 27% difference compared to their previous encounter, which the Bears had won.

At the end of the game, Lin shared his thoughts: "It's going to be hard. I feel that EASL has gotten better. They also added a fifth team to each group, so we see the competition is getting better and better. And for us, it comes down to execution and attention to detail. This is high-

-quality basketball, with the best teams from other leagues. It just comes down to doing what the coach wants us to do." Lin also expressed gratitude to the fans, stating, "We're here in Macau today as the away team, but I honestly felt like the home team tonight. Thank you to all the fans who came out. I see all the different jerseys you're wearing. I'm very grateful from the bottom of my heart."

Looking ahead, the Kings will face the Ryukyu Golden Kings of Japan Dec. 25, while the Bears will have a month-long break before returning to action Jan. 15 against the Busan KCC Egis from Korea.

In the other game of the evening, the Taoyuan Pauian Pilots defeated the Suwon KT Sonicboom from Korea 100-64, maintaining a perfect record of three wins in three games. The Pilots currently lead Group A, followed by the Hiroshima Dragonflies, while the Ryukyu Golden Kings lead Group B, ahead of the Meralco Bolts.

Gov't unveils digital pataca prototype

THE Monetary Au-**1** thority of Macau (AMCM) unveiled the prototype system for the "Digital Macau Pataca" (e-MOP) yesterday.

Chan Sau San, chairman of the Board of Directors of the AMCM, emphasized that both digital and physical patacas would hold legal tender status, ensuring they cannot be refused in transactions.

The digital currency initiative includes two types of wallets: hard wallets, which will be card-based and compatible with self-service exchange machines for converting cash; and soft wallets, which will offer various functionalities such as adding value, transferring money, and making payments via QR codes.

AMCM plans to initially focus on retail applications while exploring wholesale scenarios as technology advances.

Additionally, there are plans to integrate the digital pataca with digital currencies from mainland China and Hong Kong to facilitate cross--border transactions.

AMCM will implement the process in three stages comprising infrastructure and core system development, an internal closed trial operation, and comprehensive public testing. The digital Macau patacas will only be officially launched once the infrastructure is established and thoroughly tested to ensure that risks are manageable.

Yesterday, the bureau

China policies aim to nurture fresh growth engines

HINA is planning a fresh set of policies to propel growth in the equipment manufacturing sector, focusing on nurturing new growth engines such as new energy vehicles and low-altitude aircraft, amid the country's concerted efforts to promote industrial upgrading and enhance global supply chain resilience, said officials and experts.

The move mirrors the directive to nurture technological innovation to boost the development of new quality productive forces and the establishment of a modern industrial system, which was mapped out at a meeting of the Political Bureau of the Communist Party of China Central Committee on Monday.

The meeting, which was presided over by Xi Jinping, general secretary of the CPC Central Committee, anchored China's key focal points for next year's economic development, as the nation is in a pivotal process of changing its development paradigm from quantity-driven to quality-driven.

The vision is backed by China's ever-stronger equipment manufacturing capability, as reflected in the fact that annual production of new energy vehicles passed the milestone of 10 million units on Nov 14, according to the Ministry of Industry and Information Technology, making China the only nation to realize such an achievement.

It took only six years for this figure to grow from 1 million to 10 million, showcasing the nation's unwavering commitment to innovation-driven development.

"Innovation stands as a pivotal force propelling the high-quality advancement of the manufacturing sector, and companies are increasingly assuming central roles in driving innovation," said Li Jinghong, an academician of the Chinese Academy of Sciences and a professor at Tsinghua University.

To date, China has built nearly 10,000 digital workshops and smart factories, of which over 400 have developed into national-level intelligent manufacturing demonstration factories. Artificial intelligence, digital twins and other cutting-edge technologies have been applied in more than 90% of these demonstration factories, according to a report released at the 2024 World Internet Conference.

Businesses are also stepping up efforts to promote green transformation. NBS data showed that the proportion of nonfossil energy consumption increased 2.6 percentage points in the first three quarters, compared with the same period last year, while coal consumption decreased 1.9 percentage points and petroleum use fell 0.9 percentage point.

"Despite China's rapid advancement in the manufacturing sector, challenges persist, notably in balancing innovation investments with operational demands," said Li, the CAS academician.

Xin Guobin, vice-minister of industry and information technology, said at a recent conference that the Ministry of Industry and Information Technology's upcoming policies to further boost manufacturing are expected to strengthen the implementation of large-scale equipment upgrades and trade-in programs for consumer goods to stimulate consumption of major commodities like automobiles. OPENING UP - CHINA, THE ENVIRONMENTAL LEADER VIA THE GBA NDERLINING Jinping's 2021 statement to the UN General Assembly, in and policy announcements risk ment of more environmental

late October of this year Beijing reiterated China's goal of carbon neutrality by 2060. Key targets have been set under a new development philosophy which sees carbon dioxide emissions peaking by 2030 followed by a decline to net zero 30 years later. The recent pledge is for a vision of a low-carbon, green, circular economy.

Although this is an incredible undertaking for an economy of this size and structure, China already holds a position of pride as the supplier of 80 percent of global solar equipment and installation technology and 50 percent of the global wind power equipment and technology as highlighted by Zhang Chuanwei, founder of the Mingyang Group in Zhongshan. Speaking at the 2024 Understanding China Conference last week, Zhang introduced the successes of his company which include the production of clean energy sufficient to supply 25 million people for 20 years to come. Beyond the GBA, Mingyang's reach extends throughout Asia, Africa, Oceania, Europe and the Americas. The company's activities exemplify the innovation and opening up that are the intended consequences of the GBA's integrated support systems for local, regional and international investors

Due to the unique investment infrastructure, incentives and ongoing economic development, the multinational company Itochu is seeking investment opportunities in the GBA. Itochu's particular focus is to invest in businesses in en-

vironmental sustainability and to leverage from China into the global marketplace. The general manager of the Guangzhou subsidiary, Katae Tomoaki, is another executive that sees the GBA as offering favourable circumstances for business in the decarbonization and low-carbon sectors.

The range of foundational development incentives and (infra) structures makes the GBA an international marketoriented business environment, especially conducive for multinationals keen to enhance their sustainability credentials. Such credibility relies on a deep level of trust in the supply and value chains, and a holistic systems approach from all levels of government and industry leadership in terms of policy, philosophical and ethical positioning, infrastructure, financial and bureaucratic support, including creativity, cultural buy-in and long-term

At the 2024 Global Investment Promotion Conference for the GBA in Guangzhou in early November - another of the many facilitation and promotion conferences – BASF chairman, Markus Kameith praised local governmental bodies in Guangdong for understanding and meeting the needs of multinationals in environmental-conscious market. The fact that the corporation will be able to manage operations entirely on renewable energy from 2025 is indicative of the type of GBA support required by these enterprises. Such environmental incentives and supporting systems and the messaging of a strong global environmental protection brand will continue to encourage global business investment in the GBA and on Chinese soil.

Given the levels of emissions from China's economic activity historically, much of the rhetoric being perceived as propaganda. However, a number of sections in the 2019 Outline Development Plan for the Guangdong--Hong Kong Macao Greater Bay Area acknowledge ecological and environmental concerns and resource limitations in robust terms. Ecological and environmental protection are areas of strengthened cooperation between the three geographical regions. Under a listing of opportunities and challenges, "growing constraints on resources and energy supplies, escalating pressure on ecology and the environment" recognizes the material limits to growth. Further, the section on Basic Principles lays out the systemic perspectives - the interconnectedness of places, peoples, policies and resources in a holistic and highly coordinated fashion: "To pursue green development and ecological conservation. To vigorously take forward ecological conservation, establish the approach of green development, uphold state policies on saving resources and protecting the environment, implement the most rigorous ecological protection system".

Indeed, it was a half-decade prior to this when in 2014 ClientEarth, an environmental law organization based in the UK but active across Europe and the US, was approached by the Ministry of Ecology and Environment and the Supreme People's Court to consult on environmental laws, and to train environment court judges and prosecutors. The aim was to encourage the establishgroups in China and to enable NGOs to pursue polluting companies and even governmental bodies in the fight against environmental harms. According to James Thornton of ClientEarth, this legislation was the first to allow Chinese federal prosecutors to sue the government. The recommendations were put in place to make it easier for citizens to enable enforcement of environmental protection laws. In 2020, 80,000 environmental cases were brought before the courts. By March 2022, 1,500 environmental judges and 1,200 prosecutors had been trained; all in efforts to raise environmental standards across China. On the financial front, more recently, banks have been lobbied and advised on appropriate investment targets and which investments to avoid that will be of little value in the long run due to environmental and sustainability risks, such as coal-fired power

Systemic change and development rely on integrated legal, financial, economic and cultural elements coming together. It takes time and concerted efforts for policies to be realized, and to be embodied by institutional systems, then to infiltrate through markets and for the message to be trusted. At some point, the momentum gathers, and positive developmental outcomes start to be visible, first to those with interest to test the waters and then invest, and finally to the average citizen. We appear to be on that trajectory, seeing those elements come together.

GBA affords global firms ease of doing business, space for growth

HINA'S Guangdong-**⊿**-Hong Kong-Macao Greater Bay Area (GBA) is becoming a world-class business hub where global firms can thrive, members of the global business community said at a conference held in Hong Kong this week.

China transitions As towards an economy driven by innovation, sustainability and inclusiveness, the GBA is poised to lead the way as it serves as a model of integrated development, balancing the dynamism

of the private sector with the guidance of strategic planning, said Michael Hart, president of the American Chamber of Commerce (AmCham) in China, at the second Business Conference on Guangdong-Hong Kong-Macao Greater Bay Area Development.

According to AmCham China's 2024 China Business Climate Survey, the GBA is one of the most attractive locations for investment in China in the eyes of respondents across all industry sectors.

Hart said that members of AmCham China value market access, proximity



to existing operations and good business environment when making investment decisions, acknowledging the GBA's "good work" to ensure equal treatment for foreign-invested enterprises.

Local authorities in the region have sweetened invitations to foreign businesses. Guangdong Province, for instance, has rolled out a raft of policies to en-

sure national treatment for foreign-funded enterprises in terms of access to factors of production, license application, standards setting, and government procurement.

The Hong Kong Special Administrative Region government had vowed in October to make it easier for companies from the Chinese mainland and overseas to set up headquarters or corporate divisions in Hong Kong.

The foundation provided by the GBA offers tremendous potential as a strategic destination for investment, particularly for U.S. companies, said Noah Fraser, senior vice president of China operations with the US-China Business

Its world-class infrastructure, ports, airports, logistics networks, and advanced digital ecosystems enhance the ease of doing business, he said.

The GBA's growth is rooted in creativity, speed to market, technological innovation and economic diversification, said Fraser.

"It is these principles, coupled with sustainability, that will ensure the region's growth benefits all stakeholders and position the GBA as a model of high-quality development on the global stage," he said. MDT/XINHUA

US hikes tariffs on imports of Chinese solar wafers, polysilicon and tungsten products

HE Biden administration plans to raise tariffs on solar wafers, polysilicon and some tungsten products from China to protect U.S. clean energy businesses.

The notice from the U.S. Trade Representative's office said tariffs on Chinese-made solar wafers and polysilicon will rise to 50% from 25% and duties on certain tungsten products will increase from zero to 25%, effective on Jan. 1, following a review of Chinese trade practices under Section 301 of the 1974 Trade Act.

The decision followed a public comment period after the USTR said in September that it was considering such actions.

"The tariff increases announced today will further blunt the harmful policies and practices by the People's Republic of China," USTR Katharine Tai said in a statement. "These actions will complement the domestic investments made under the Biden-Harris Administration to promote a clean energy economy, while increasing the resilience of critical supply chains."

Reports yesterday said U.S. and Chinese officials were meeting this week and next for trade talks ahead of the year's end.

Last week, Washington tightened restrictions on Chinese ac-



cess to advanced semiconductor technology. Beijing responded by banning exports to the U.S. of certain critical minerals needed to make computer chips, such as gallium, germanium and antimony. It also stepped up its controls on graphite exports to the U.S.

China provides a very large share of most of those materials and the United States has been working to secure alternative sources in Africa and other parts of the world.

Tungsten is another strategi-

cally vital metal whose production is dominated by China. The U.S. does not produce it, but South Korea is a potential big supplier. It's used to make armaments and is also used in x-ray tubes and light bulb filaments, among other industrial applications. U.S. imports of the metal from China fell to \$10.9 million in 2023 from \$19.5 million the year before.

After Beijing announced its ban on exporting gallium and the other materials to the United States, analysts said tungsten was another likely area where China might strike back.

Trade frictions have been escalating ahead of the inauguration of President-elect Donald Trump, who has vowed to impose 60% tariffs on Chinese goods, among other threats. President Joe Biden has said Trump's promise of broad tariffs on foreign imports would be a mistake.

His administration has kept in place tariffs that Trump imposed during his first term in office, but says it has a more targeted approach. China has sharply ramped up production of cheap electric vehicles, solar panels, and batteries at a time when the Biden administration has championed moves to support those industries in the U.S.

The U.S. and other trading partners allege China improperly subsidizes exports, giving exporters of solar panels and other products an unfair advantage in overseas markets, where its manufacturers charge lower prices thanks to government support. Washington also says China improperly pressures foreign companies to hand over technology.

China accounts for more than 80% of the market for solar panels at all stages of production, according to the International Energy Agency, more than double domestic demand for those products. Its huge economies of scale have made solar power more affordable, but also concentrated the supply chain inside China. The IEA has urged other countries to assess their solar panel supply chains and develop strategies to address any risks.

In early 2018, the Trump administration imposed 30% tariffs on imports of Chinese solar panels. Beijing filed a complaint with the World Trade Organization charging that the U.S. was unfairly supporting electric vehicle purchases.

The investigation that led the USTR to raise the tariffs on solar panels concluded with a report in May that has prompted increases in tariffs on a range of products including electric vehicles, syringes and needles, medical gloves and facemasks, semiconductors and steel and aluminum products, among others.

It has pushed tariffs on Chinese-made electric vehicles up to 100% from 25%, raised tariffs on Chinese-made lithium batteries to 25% from 7.5%. MDT/AP


China expands private pension program nationwide: reports

CHINA is scaling its private pension fund pilot program to a nationwide level in an effort to address mounting strains on its retirement system, Bloomberg has reported. However, the initiative, first launched in 36 cities in 2022, has already revealed significant hurdles, including lackluster fund performance and tepid investor interest.

Modeled after U.S.-style Individual Retirement Accounts, the program allows workers to contribute up to 12,000 yuan (\$1,650) annually to taxadvantaged accounts.

This initiative is part of China's broader pension reform, aiming to tackle challenges posed by a rapidly aging population—expected to exceed 400 million individuals aged 60 and older by 2035.

According to Bloomberg, the program's initial rollout garnered attention from global financial players like BlackRock Inc., with some estima-



tes, including Citic Securities Co., projecting potential asset growth to 12 trillion yuan by

2035. On December 15, the program will extend across the nation, as announced by the Ministry of Human Resources and Social Security.

Additionally, investment options will expand to include sovereign bonds and certain index funds, such as those tracking the CSI 300 stock index, potentially attracting long-term investors.

Despite its potential, the program has faced difficulties. Bloomberg highlights that over 60 million people have signed up, yet only 22% of them have made contributions, according to a March report by local media outlet The Paper. By the end of 2023, the funds had collected a combined 28 billion yuan, and Ping An Securities Co. estimated that figure had doub-

led to 58 billion yuan this year.

Participation growth remains a concern. While over 700 million Chinese citizens are eligible for the program, not all stand to benefit. Only 67 million individuals paid personal income tax last year, with more than 60% taxed at the 3% rate—the same as the pension plan's tax advantage—providing minimal incentive to participate, according to Ping An Securities.

China's decision to delay its retirement age starting next year has also sparked public backlash, further complicating efforts to reform its retirement system.

Papua New Guinea gains a team in Aussie RUGBY LEAGUE IN DIPLOMATIC PUSH

Papua New Guinea will a gain its own to a tralia's rugby league in a soft diplomacy deal announced yesterday linked to limiting Chinese influence in the South Pacific.

The Australian government will spend 600 million Australian dollars (\$380 million) over a decade to add a team from its nearest neighbor to the National Rugby League from

Prime Minister Anthony Albanese and his Papua New Guinea counterpart James Marape announced the deal at a Sydney news conference. They also announced that a bilateral security deal struck a year ago had officially come into force.

China has pursued its own bilateral security pact on policing with Papua New Guinea and with other South Pacific island nations which U.S. allies, including Australia, fear could undermine regional security.

Rugby league is the most popular sport in Papua New Guinea, which has an impoverished population of 12 million mostly subsistence farmers, wracked by tribal warfare, worsening violent crime and civil unrest.

Marape said the security deal with Australia "fits in neatly" with ensuring the safety of players and officials who would be based in the capital, Port Moresby.

"The player is safe when we have good rapport between our two police" forces, Marape told reporters.

Albanese did not directly answer when asked by a reporter if the agreement would prevent Papua New Guinea from striking a security deal with China.

"Security in Pacific is primarily the responsibility of the Pacific family is a principle that we share," Albanese said.

Marape said the security pact with Australia was in his country's interests.

"Australia is a security partner of choice in the first instance," Marape said.

"That doesn't stop us from relating with any nation, especially our Asian neighbors. We relate with China, for instance, a great trading partner, a great bilateral partner, but on security, closer to home we have this synergy and our shared territory needs to be protected, defended, policed," Marape added.

But Peter V'landys, chair of the Australian Rugby League Commission, said the Papua New Guinea government would never jeopardize Australian taxpayer support for the team by striking a security deal with Beijing.

"Rugby league is such a religion in Papua New Guinea that they will never take the risk of losing a rugby league team to do a deal with another country," V'landys told reporters.

Marape described the deal to create a Port Moresby-based football team as "pivotal in ... anchoring" the Papua New Guinea-Australia relationship.

The security pact signed by Albanese and Marape a year ago strengthened Australia's place as the preferred security partner. It was signed six months later than initially planned.

The original June 2023, date was abandoned after a security deal struck between the United States and Marape's government sparked protests in the South Pacific nation a month earlier over concerns that it undermined Papua New Guinea's sovereignty.

Australia agreed to support Papua New Guinea's internal security in areas of policing, courts and prisons.

Australia has also helped Papua New Guinea build a new police training center in the Port Moresby that will be open to recruits from other Pacific nations. MDT/AP

Yoon defends martial law as an act of governance and vows to 'fight to the end'

OUTH Korean President Yoon Suk Yeol defended his martial law decree as an act of governance and denied rebellion charges, vowing yesterday to "fight to the end" in response to attempts to impeach him and intensifying investigations into last week's dramatic move.

The main opposition Democratic Party quickly slammed Yoon's speech as "an expression of extreme delusion" and "false propaganda." Later Thursday, it and other opposition parties submitted a new impeachment motion against Yoon for a floor vote this weekend.

The opposition-controlled parliament also passed motions yesterday to impeach and suspend Yoon's police chief and justice minister over the imposition of martial law, escalating the pressure on Yoon's embattled government.

Yoon's short-lived Dec. 3 martial law declaration has generated political chaos and large protests calling for his ouster. The decree brought hundreds of armed troops who attempted to encircle parliament and raid the election commission, though no major violence or injuries occurred. Martial law lasted only six hours as Yoon was forced to lift it after the National Assembly unanimously voted it down.

In a televised speech yesterday, Yoon, a conservative, said he enacted martial law as a warning to the liberal Democratic Party. He called the party "a monster" and "anti-state forces" that he said tried to use its legislative muscle to impeach top officials, undermined the government's budget bill for next year and sympathized with North Korea.

"I will fight to the end to prevent the forces and criminal groups that have been responsible for paralyzing the country's government and disrupting the nation's constitutional order from threatening the future of the Republic of Korea," Yoon said. "The opposition is now doing a sword dance of chaos, claiming that the declaration of martial law constitutes to an act of rebellion. But was it really?"

Yoon said martial law was an act of governance that cannot be the subject of investigations and doesn't amount to rebellion. He said the deployment of nearly 300 soldiers to the National Assembly was designed to maintain order, not

dissolve or paralyze it.

Kim Min-seok, head of a Democratic Party task force, dismissed Yoon's statement as "an expression of extreme delusion" and "a declaration of war against the people."

It's unclear how Yoon's comments will affect his fate. Opposition parties hold 192 seats combined, eight votes short of a two-thirds majority of the 300 members of the National Assembly. The earlier attempt to impeach Yoon failed with most lawmakers from Yoon's governing People Power

Party boycotting the vote.

Yoon's speech was expected to deepen a divide inside the PPP. When party chair Han Dong-hun, a critic of Yoon, called Yoon's statement "a confession of rebellion" during a party meeting, Yoon loyalists angrily jeered and called on Han to stop speaking. Han has urged party members to vote in favor of Yoon's impeachment.

Opposition parties and even some PPP members say the martial law decree was unconstitutional. South Korean law allows the president to declare martial law during wartime or similar emergencies, and they said such a situation did not exist. They argue that deploying troops to seal the National Assembly to suspend its political activities amounted to rebellion because the constitution doesn't give a president such rights in any situation.

The country's law enforcement authorities are investigating whether Yoon and others involved in imposing martial law committed rebellion, abuse of power and other crimes. A conviction for rebellion carries a maximum penalty of death

The National Assembly on Thursday passed a bill that could introduce an independent counsel to investigate Yoon on rebellion charges without his approval. MDT/AP

Nissan reshuffles management to fix its money-losing business

EMBATTLED Japanese automaker Nissan has tapped Jeremie Papin, who was overseeing its U.S. operations, as its chief financial officer in a major management reshuffle billed as key to a turnaround.

The move as announced in the United States yesterday. It means Papin, chairman of Nissan's Americas Management Committee, replaces Stephen Ma, who will oversee Nissan Motor Corp.'s China operations.

Ma's replacement had been speculated about

for some time, given Nissan's problems in the key U.S. market, lately dominated by Tesla, Toyota and Ford.

Last month, Nissan said it was slashing 9,000 jobs, or about 6% of its global work force, and reducing global production capacity by 20% after reporting a quarterly loss of 9.3 billion yen (\$61 million).

That was a reversal from the 190.7 billion yen profit recorded the same quarter a year ago. Sales for the quarter through September fell

to 2.9 trillion yen (\$19 billion) from 3.1 trillion yen.

Chief Executive Mako-

to Uchida took a 50% pay cut to take responsibility for the results and acknowledged Nissan needed to become more efficient and respond better to market tastes, rising costs and other global changes.

"These executive changes reflect the experience and urgency needed to get the company back on track," Uchida said in a statement. "Nissan will continue to focus on future growth and steadily execute these turnaround efforts to ensure sustainable profitability."

Papin will steer a recovery, given his experience in strategy, business development and investment banking, according to Nissan, which makes the Leaf electric car, Rogue SUV and Infiniti luxury models.

A citizen of both the U.S. and France, Papin was initially with the French automaker Renault SA, with which Nissan formed an alliance since 1999. In 2023, he was named to Nissan's executive committee, helping shape its growth plans. Previously, Papin worked for more than a decade as a financial analyst at Deutsche Bank, Lehman Brothers and Nomura.

As part of the moves, effective Jan. 1, Christian Meunier, the former chief executive of Jeep, returns to Nissan as chairman of the Americas Management Committee.

Asako Hoshino will continue to oversee the customer experience, while Shohei Yamazaki, China Management Committee chairman, takes over a part of her role and will oversee the Japan-ASEAN region. MDT/AP

In lithium boom, many mines are illegal and children do much of the work

ROWING demand for the lithium used in batteries for electric vehicles and energy storage has created a new frontier for mining in Nigeria.

But it's led to exploitation of children who are often poor and take work in small, illegal mines to support themselves and their families.

The Associated Press recently traveled to the deep bush of Pasali, near the federal capital of Abuja in Nasarawa state, to follow and interview miners operating illegal mines, including some where children work. AP also witnessed negotiations and an agreement to purchase lithium by a company with no questions about the source of the lithium or how it was obtained.

The International Labour Organization estimates more than one million children work in mines and quarries worldwide, a problem particularly acute in Africa, where poverty, limited access to education and weak regulations add to the problem. Children, working mostly in small-scale mines, work long hours at unsafe sites, crushing or sorting rocks, carrying heavy loads of ore, and exposing themselves to toxic dust that can cause respiratory problems and asthma.

Lithium mining began in Pasali a decade ago, transforming a remote and slumbering community into a bustling site for

small-scale illegal mining, said Shedrack Bala, a 25-year-old who began working in the mines at age 15 and now owns his own pit. Dozens of mines now dot the area, all unlicensed.

The mining methods are primitive and dangerous. Miners use chisels and heavy hammers to break through rocks, descending several feet into dark pits. In some old but still viable mines, they crawl through narrow passages snaking between unstable mud walls before starting to dig. For new mines, the ground is blasted open with dynamite.

Bashir Rabiu, now 19, started in the pits as an underage worker. AP journalists watched as he wriggled around at the bottom of a pit, where miners can be at risk if dynamite explodes prematurely. They also face danger of suffocating in narrow tunnels that connect pits, or burial from wall collapse.

Rabiu hauled up raw lithium ore and passed it to six children, all younger than 10. Wearing rubber slippers and dust--stained shorts and shirts, the children hunched over rubble and chipped away with crude stone tools to extract valuable fragments.

A team of six children can sort and bag up to 10 25-kilogram bags of lithium-rich rock a day. For working from early morning to late evening, the children typically share 4,000 naira (about \$2.42), according to Bala and others who use

None of the children in the

group AP saw was attending school. Only two ever had. One, a 5-year-old boy, stopped when he was orphaned. The other was a 6-year-old girl who was pulled out of school by her family, who felt they couldn't afford to send two children to school and prioritized her 11-year-old brother.

The illegal mining thrives on informal networks of buyers and sellers who operate without much fear of the government. Aliyu Ibrahim, a lithium merchant in Nasarawa, owns unlicensed mines and also buys lithium ore from other illegal sites. At his warehouse, he told AP that his business flourishes by paying officials to look the other way. Ibrahim said he then sells his lithium in bulk to Chinese companies.

Ibrahim said he knows that children are working at his mines and others he buys from, but he said many of the children are orphans or poor. He said the work helps them sur-

AP accompanied miners from Pasali illegal mines to Chinese-owned RSIN Nigeria Limited, where a sales agreement was reached without questions about the source of the minerals or the conditions under which they were extracted. Sellers were asked to leave samples to test for lithium content. A price list from the buyers offered 200,000 naira (about \$119) for a metric ton of minerals containing up to 3%

RSIN Nigeria Limited did

not respond to repeated requests for comment. But in a statement to AP, the Chinese embassy in Abuja said Chinese mining companies in Nigeria "operate in line with local laws and regulations."

Philip Jakpor, a Nigerian activist, said his nonprofit Renevlyn Development Initiative has documented widespread child labor practices across Na-

"Revenue generation seems to have trumped the need to protect human rights," Jakpor said. "We expect those operating in the upper spheres of the supply chain to adopt responsible models that prevent abusive conditions in mineral extraction."

Juliane Kippenberg, associate director of children's rights at Human Rights Watch, said global demand for lithium is expected to grow rapidly in coming years and it's imperative for governments to protect human rights and press corporations to do the same.

Segun Tomori, a spokesperson for the Ministry of Mining and Solid Minerals Development, said ongoing reforms such as amending the Minerals and Mining Act are aimed at minimizing the use of child labor. Tomori also said social safety programs such as school feeding initiatives are being revamped to keep children in school and combat child labor. He also cited a program to add mining marshals announced this year to clamp down on illegal mining. MDT/AP

1995 RIOTS BREAK OUT IN BRIXTON



Hundreds of black and white youths have taken to the streets of Brixton, in south London attacking police, ransacking shops and burning cars after the death of a black man in police custody.

About 50 police officers in riot gear have formed a line across Brixton's main road to stifle pockets of trouble and prevent anyone entering the area - the scene of massive rioting in 1981 caused by racial tensions.

One report said two shots were fired as the centre of the demonstration moved into the area of the Ritzy cinema.

A police motor cyclist is reported to have been pulled from his machine by a crowd of at least 10

Officers have sealed off a two-mile area around the centre of Brixton and both Brixton and neighbouring Stockwell tube stations have been

A police helicopter has been despatched over

Riots broke out after a peaceful picket of the police station - triggered by the death last week of Wayne Douglas, 26.

Police said Mr Douglas, who was being questioned about a burglary, collapsed at the local police

A post-mortem later revealed he had suffered from heart disease.

The protest about his death developed into a march down Brixton's main street.

A standoff ensued between the police and about 100 demonstrators triggering a backlash

Witnesses have reported hearing groups of black youths shouting "Killers, killers" at the po-

A spokeswoman for the police said seven civilian casualties had been reported so far, and police were also dealing with sporadic pockets of trouble in the area around Brixton town centre

She said there had been unconfirmed reports of petrol bombs being ignited.

"Officers were wearing protective clothing because we had reports of missiles being thrown,

"We gave them every opportunity to move off peacefully but they hadn't done so."

In context

The violence continued for five hours and 22 people were arrested and charged with public order offences, theft and criminal damage and three police officers were hurt. Riots in Brixton hit the headlines again in July 2001 after an estimated 100 youths went on the rampage, looting and breaking shop windows.

It was triggered by the fatal shooting by police of a man they mistakenly believed had been brandishing a gun.

Twenty-seven people were arrested after

Alex Owolade, chairman of the anti-racist group Movement for Justice, said the violence was a rebellion against years of "racist injustice" by police in an impoverished area plagued by racial tension.

A WORDLESS LATVIAN CAT PARABLE ABOUT CLIMATE CHANGE IS THE YEAR'S BEST ANIMATED MOVIE

F all the post-apocalyptic Clandscapes we've been treated to over the years, none is as beautiful nor peaceful as that of "Flow."

In Gints Zilbalodis' wondrously shimmering animated fable, a solitary black cat, after escaping a cataclysmic flood, navigates a water world. What brought things to this point is never explained. We're left to look upon this strange, verdant and overgrown landscape through the amber eyes of our unnamed feline protagonist. Humans are completely absent, and it's part of this beguilingly meditative film to wonder not just about what role we played in the flood, but to ponder the grace of the animal life left to inherit the Earth.

As much as I didn't have a wordless Latvian animated movie on my 2024 bingo card, "Flow" — an expected Oscar contender cur-

rently in theaters — is quite easily the best animated movie of the year and one of the most poetic ecological parables in recent memory. It's an all-audiences movies, and by that, I'm tempted to include not just young and old, but cats and dogs, too.

When the waters rise, the cat encounters a friendly Labrador, a long-legged secretary bird, a dozing capybara and a bauble-

-hoarding ring-tailed lemur. Cute as they are, they aren't quite your typical animated animals. Part of the allure of "Flow" is seeing animal characters that would normally be anthropomorphized and voiced by celebrity actors — the lemur, in particularly, has until now been ruled by Sacha Baron Cohen's King Julian of "Madagascar" — move and sound authentically.

Well, mostly. Circumstances bring these five together aboard a small sailboat, an ark sans Noah.

That "Flow" is made with computer generated animation adds to its dreamy, curiously real surrealism. Zilbalodis created "Flow" with Blender, the free, open-source graphics software tool. His camera moves less with the prescribed, storyboarded form of traditional animation than as a nimble,

roving perspective within a virtual world. That such a natural and sensory movie is made possible by cutting-edge technology is one reason why the dystopic world of "Flow" always feels more hopeful than it ought to.

Another reason is the animals. Though they come from different species and have little means of communication, they together form an odd partnership. The cat is initially wary of each, but they slowly form an evident bond. Their survival hinges on their cooperation, which is occasionally threatened by the self-interest of others (there's a pack of less community-minded dogs) or the cat's own timid reluctance. Staying to face a problem or trust another animal, rather than scampering away, goes against its nature.

In that way, these two- and four-legged creatures, digitally rendered in a human-less future, are both worthy heirs to the planet and furry figures of inspiration for today. Reflections run through "Flow" — in a mirror clutched by the lemur, in the water the cat peers into — but none more so than the image of ourselves gazing back at it.

uses a warbled beat to a hypnotic effect, as Mayberry takes on an enemy.

Those moments — the ones where Mayberry brawls, heard in her lyrics and the wolf howling back at the boy crying wolf in "Crocodile Tears" — are some of the album's best.

But there are dialed back moments as well quieter songs, the furthest from her work with CH-VRCHES — and they come with their own revelations. ELISE RYAN, MDT/AP

HOW TO PROTECT YOUR COMMUNICATIONS THROUGH ENCRYPTION

After a sprawling hacking campaign exposed the communications of an unknown number of Americans, U.S. cybersecurity officials are advising people to use encryption in their communications.

To safeguard against the risks highlighted by the campaign, which originated in China, federal cybersecurity authorities released an extensive list of security recommendations for U.S. telecom companies - such as Verizon and AT&T — that were targeted. The advice includes one tip we can all put into practice with our phones: "Ensure that traffic is end-to-end encrypted to the maximum extent possible."

End-to-end encryption, also known as E2EE, means that messages are scrambled so that only the sender and recipient can see them. If anyone else intercepts the message, all they will see is a garble that can't be unscrambled without the key.

Officials said the hackers targeted the metadata of a large number of customers, including information on the dates, times and recipients of calls and texts. They also managed to see the content from texts from a much smaller number of victims.

If you're an iPhone user, information in text messages that you send to someone else who also has an iPhone will be encrypted end-to-end. Just look for the blue text bubbles, which indicate that they are encrypted iMessages.

The same goes for Android users sending texts through Google Messages. There will be a lock next to the timestamp on each message to indicate the encryption is on.

But there's a weakness. When iPhone and Android users text each other, the messages are encrypted only using Rich Communication Services, an industry standard for instant messaging that replaces the older SMS and MMS standards.

To avoid getting caught out when trading texts, experts recommend using encrypted messaging apps.

Privacy advocates are big fans of Signal, which applies end-to-end encryption on all messages and voice calls. The independent nonprofit group behind the app promises never to sell, rent, or lease customer data and has made its source code publicly available so that it can be audited by anyone to examine it "for security and correctness."

Signal's encryption protocol is so reputable that it has been integrated into rival WhatsApp, so users will enjoy the same level of security protection as Signal, which has a much smaller user base. End-to-end encryption is also the default mode for Facebook Messenger, which like WhatsApp is owned by Meta Plat-

Telegram is an app that can be used for one-on-one conversations, group chats and broadcast "channels" but contrary to popular perception, it doesn't turn on end-to-end encryption by default. Users have to switch on the option. And it doesn't work with group chats.

Instead of using your phone to make calls through a wireless cellular network, you can make voice calls with Signal and WhatsApp. Both apps encrypt calls with the same technology that they use to encrypt messages.

There are other options. If you have an iPhone you can use Facetime for calls, while Android owners can use the Google Fi service, which are both end-to-end encrypted.

The only catch with all these options is that, as with using the chat services to send messages, the person on the other end will also have to have the app installed.

WhatsApp and Signal users can customize their privacy preferences in the settings, including hiding IP address during calls to prevent your general location from being guessed. [Abridged]

UK SPY AGENCY RELEASES ANNUAL CHRISTMAS CARD PUZZLE TO UNCOVER FUTURE CODEBREAKERS

What does a spy agency give for Christmas? How about a riddle wrapped in an enigma inside a mystery.

GCHQ, Britain's electronic and cyber-intelligence agency, this week published its annual Christmas Challenge - a seasonal greeting card that doubles as a set of fiendishly difficult puzzles designed to excite young minds about solving cyphers and unearthing clues.

The challenge is aimed at young people aged 11 to 18, who are encouraged to work in teams and use "lateral thinking, ingenuity and perseverance" to crack the seven brainteasers set by GCHQ's "in-house puzzlers."

The card is sent by the head of GCHQ — short for Government Com-

munications Headquarters — to other national security chiefs around the world. Puzzles were first included in 2015 and have become an an-

The agency admits the festive fun has an ulterior motive.

GCHQ Director Anne Keast-Butler said she hoped the card would inspire young people to explore STEM subjects - science, technology, engineering and mathematics - "and to consider what a career in cybersecurity and intelligence might have to offer."

It also aims to dispel some myths about intelligence work, fueled by super-agent James Bond and other fictional spies.

Australia plans to tax DIGITAL PLATFORMS THAT DON'T PAY FOR NEWS

THE Australian govern-**I** ment said yesterday it will tax large digital platforms and search engines unless they agree to share revenue with Australian news media organizations.

The tax would apply from Jan. 1 to tech companies that earn more than 250 million Australian dollars (\$160 million) a year in revenue from Australia, Assistant Treasurer Stephen Jones and Communications Minister Michelle Rowland said.

They include Meta, Google-owner Alphabet and ByteDance, the Chinese owner of TikTok.

The tax would be offset through money paid to Australian media organizations. The size of the tax is not clear. But the government aims to make sharing revenue with media organizations the cheaper option.

"The real objective ... is not to raise revenue -- we hope not to raise any revenue. The real objective is to incentivize agreement--making between platforms and news media businesses in Australia," Jones told reporters.

The move comes after Meta, which owns Facebook, Instagram and WhatsApp, announced that it would not renew three--year deals to pay Australian news publishers for their content.

A previous government introduced in 2021 laws called the News Media Bargaining Code that forced tech giants to strike revenue-sharing deals with Australian media companies or face fines of 10% of their Australian revenue.

Meta said in a statement the current law was flawed and the U.S. company continued to have "concerns about charging one industry to subsidise another."

"The proposal fails to account for the realities of how our platforms work, specifically that most people don't come to our platforms for news content and that news publishers voluntarily choose to post content on our platforms because they receive value from doing so," the statement said.

Google has struck revenue-sharing agreements with more than 80 Australian news companies in the past three years and has committed to renewing those deals.

But Google has raised doubts about the government's new approach.

"The government's introduction of a targeted tax risks the ongoing viability of commercial deals with news publishers in Australia," a Google statement said.

"We are reviewing to-

day's announcement and will have more to say once we've assessed the full impact," Google added.

TikTok noted that its users didn't seek news.

"As an entertainment platform, TikTok has never been the go to place for news. We will actively engage in the consultation process and look forward to hearing more details," a TikTok statement said.

Jones said Australian officials had explained the government's intentions to their counterparts in the United States, where most of the digital giants are headquartered. President-elect Donald Trump's administration is planning to increase tariffs against some countries, which has the potential to trigger trade wars.

"We want to ensure that they understand the reasoning, also understand that this is not a tax in the normal sense of the word," Jones said.

"This is an incentive to bolster up a law that has existed in Australia since 2021," he added.

Rowland said the revenue-sharing was needed to safeguard Australian democracy.

"The rapid growth of digital platforms in recent years has disrupted Australia's media landscape and it is threatening the viability of public interest journalism," Rowland said. MDT/AP
